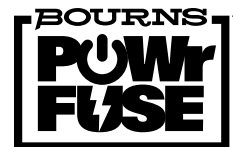

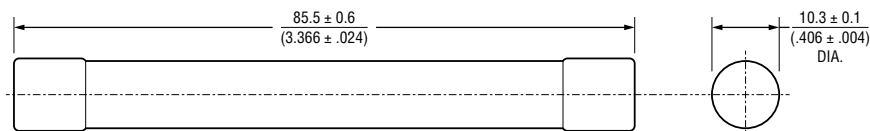

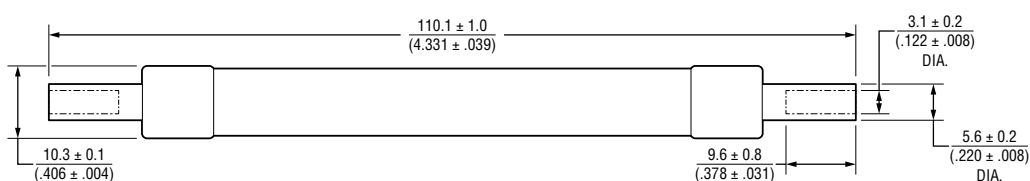

Ferrule / C1 Type

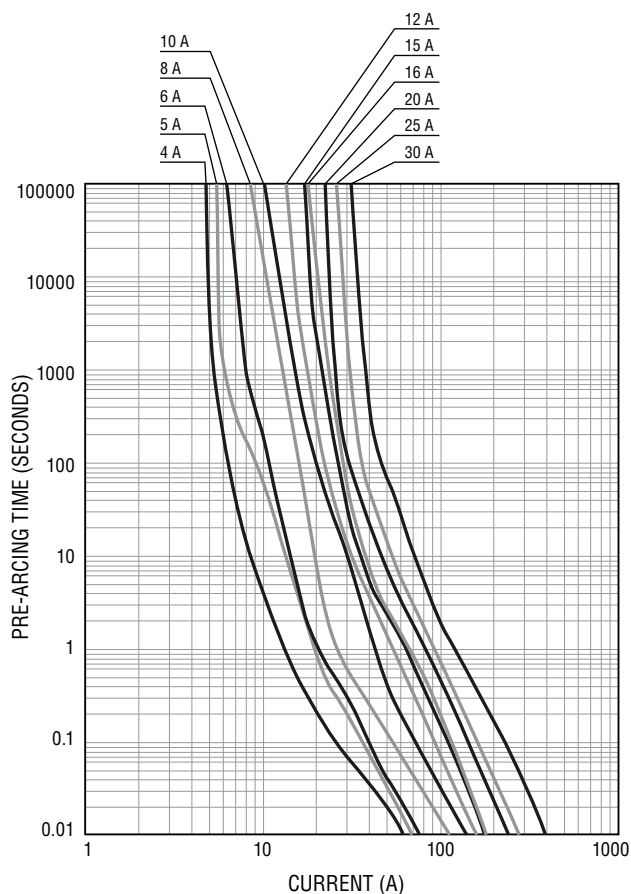


Crimp Cap / C2 Type

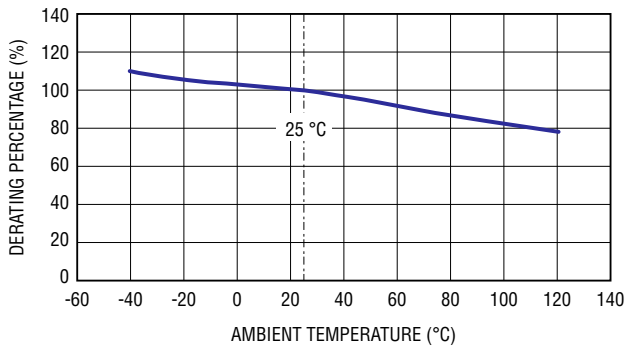
