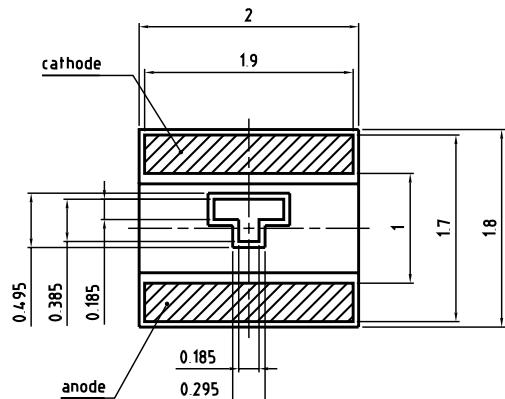
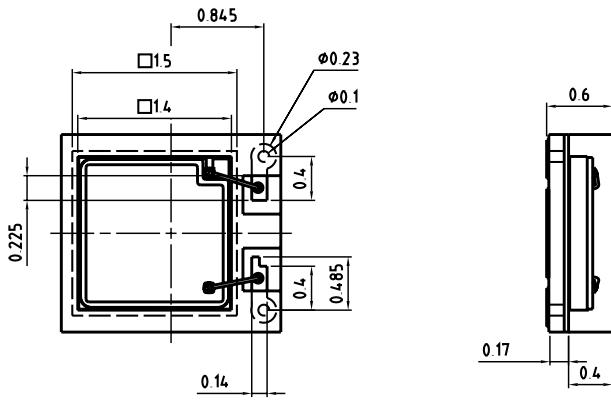


Dark Current ¹⁾

Dimensional Drawing ³⁾



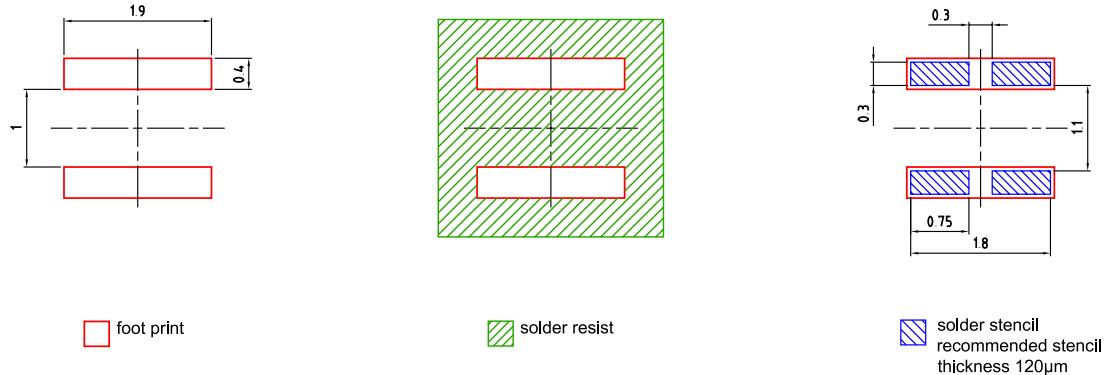

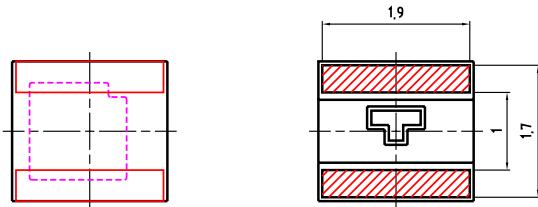

Recommended Solder Pad ³⁾



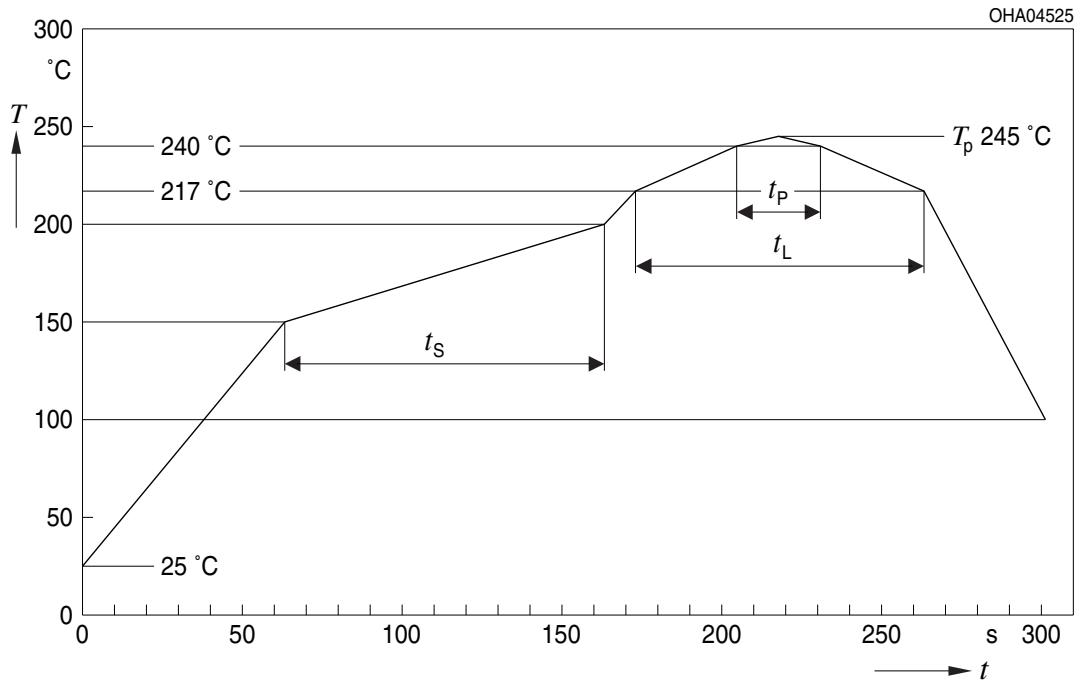
Component Location on Pad

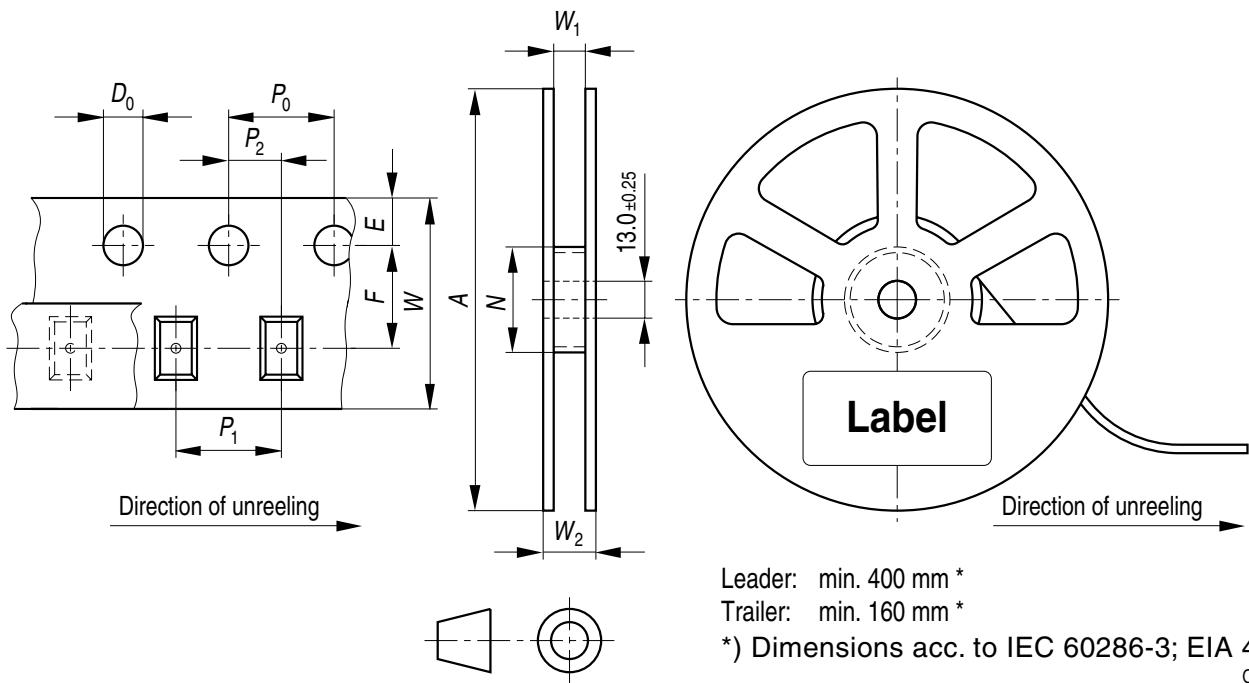

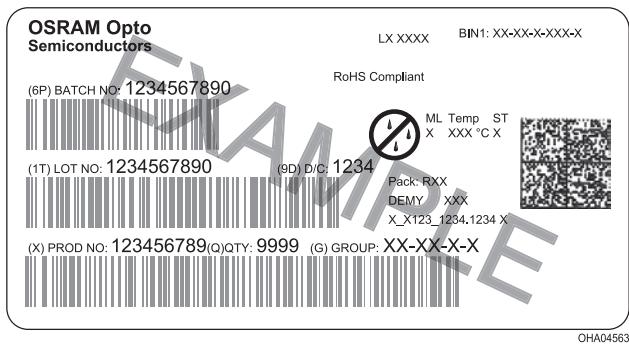

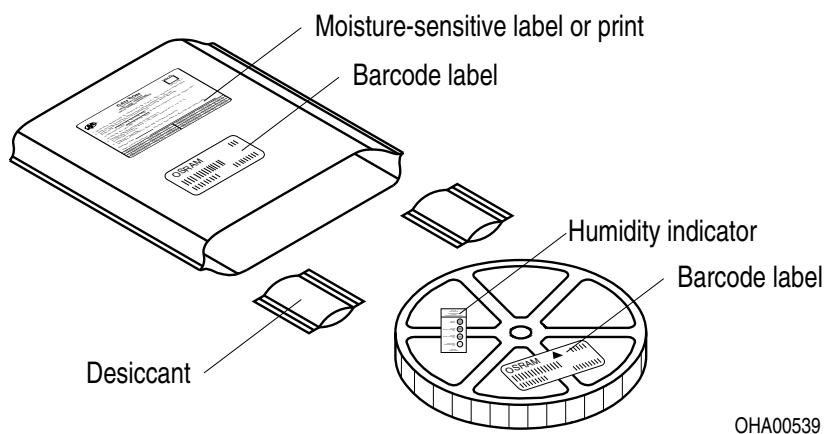

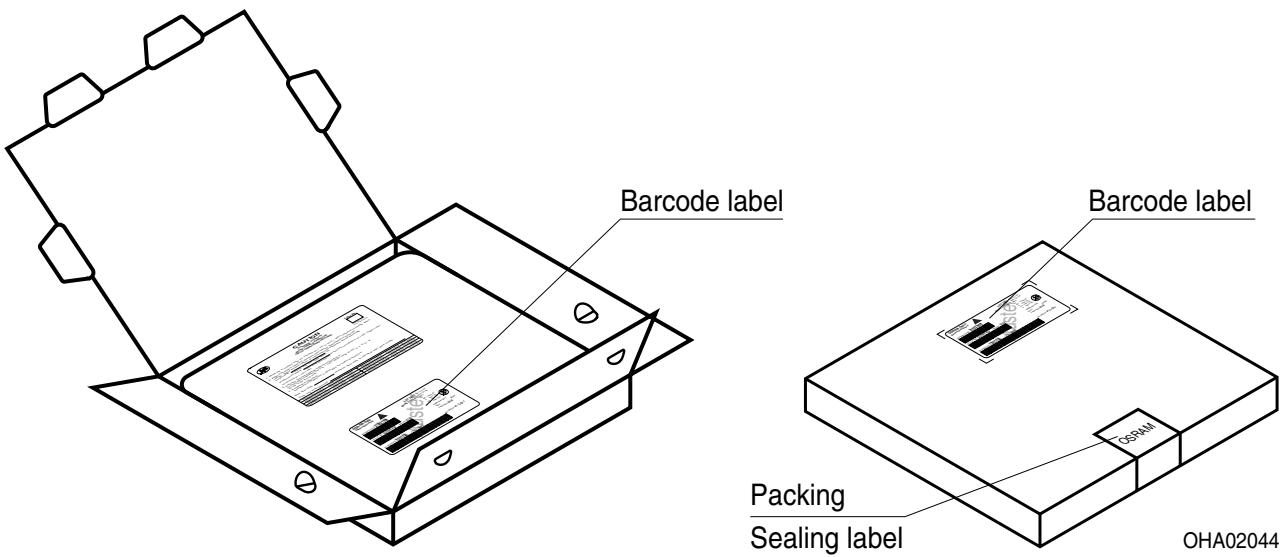


Dry Packing Process and Materials ³⁾

Notes
