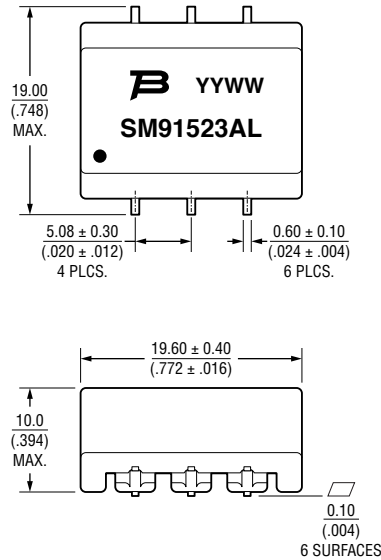

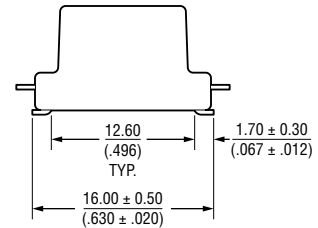

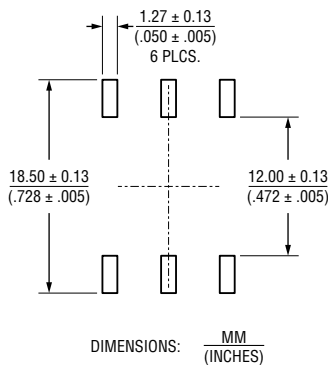
Product Dimensions

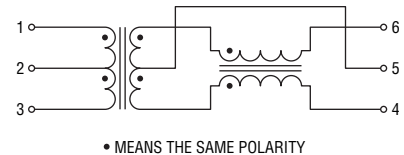


Recommended Layout

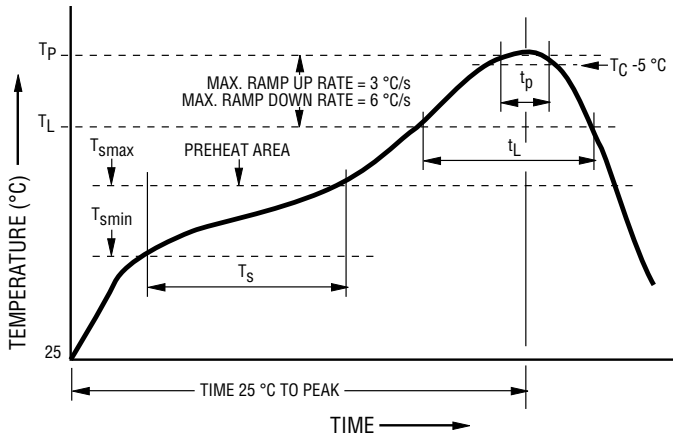

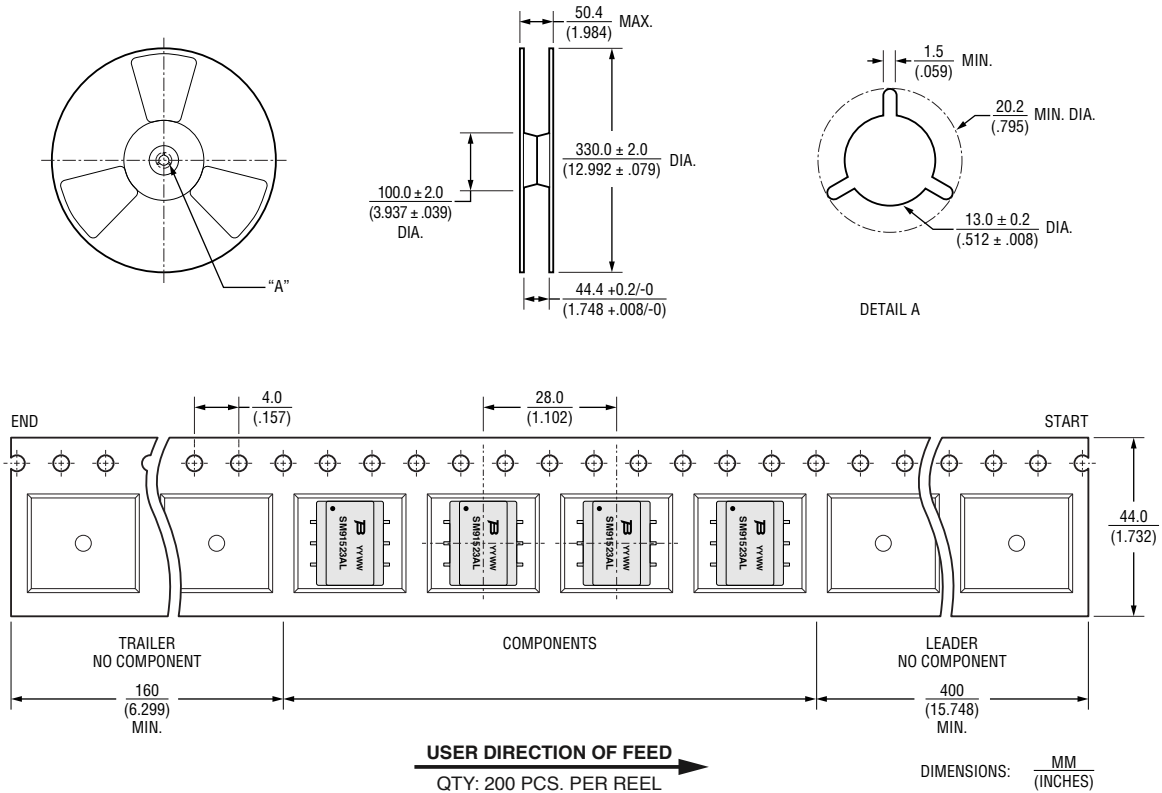
