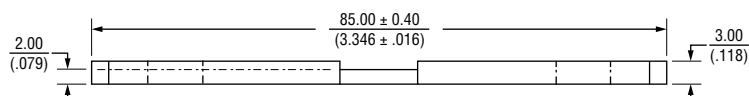

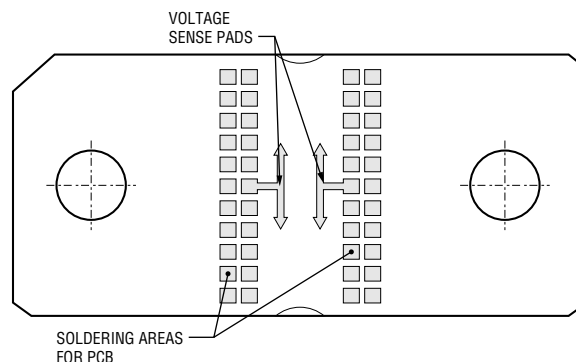
## Power Derating Curve

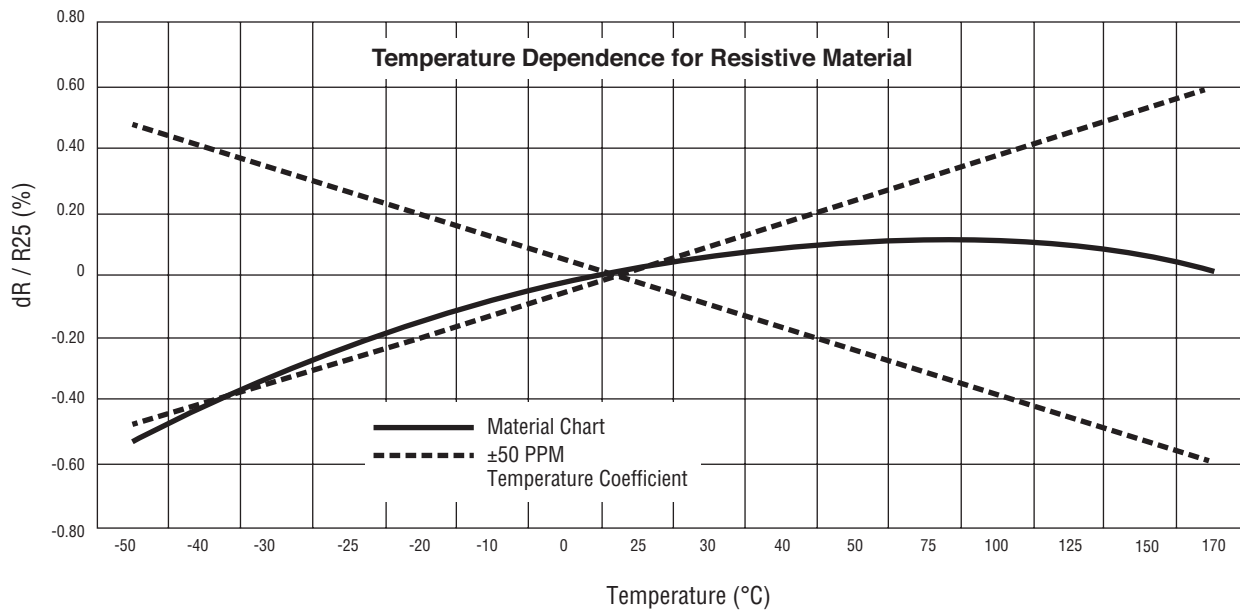
