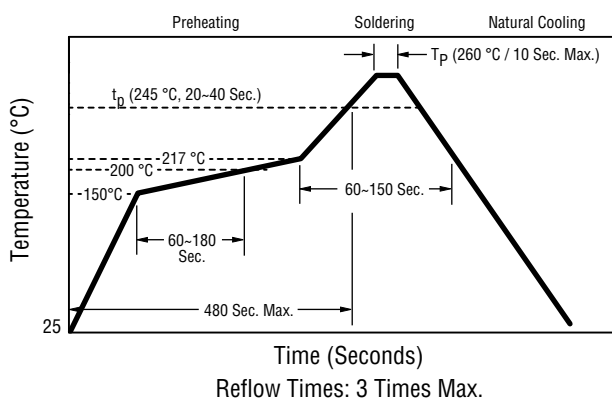

Soldering Profile

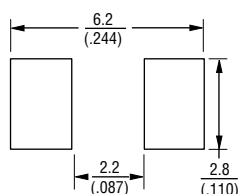

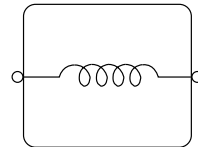
