The SiC Schottky diode encapsulated in a Real-2-Pin TO247 R2P (TO-247-2) through-hole power plastic package offers temperature independent capacitive turn-off, zero recovery switching behavior combined with an outstanding figure-of-merit ($Q_c \times V_F$). The Merged PiN Schottky (MPS) diode improves the robustness expressed in a high I_{FSM} .







Fig. 1. Transient thermal impedance as a function of pulse duration; maximum values




Fig. 2. Power dissipation; maximum values





Fig. 3. Forward current as a function of case temperature; maximum values



Fig. 4. Forward current as a function of forward voltage; typical values



Fig. 5. Forward characteristics in surge current as a function of forward voltage; typical values



Fig. 7. Diode capacitance as a function of reverse voltage; typical values




Fig. 8. Capacitance stored energy as a function of reverse voltage; typical values




Fig. 9. Simplified forward characteristics mode




Fig. 10. Duty cycle definition




Fig. 11. Package outline TO-247-2 (SOT8022)
