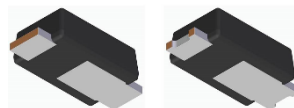

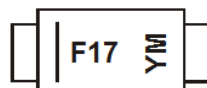

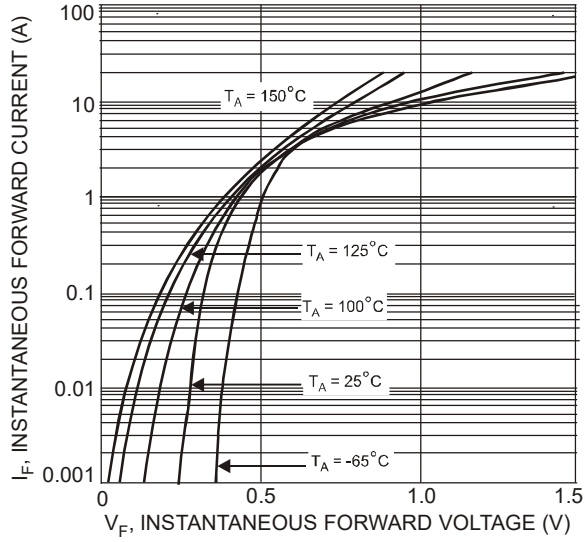


Fig. 1 Typical Forward Characteristics

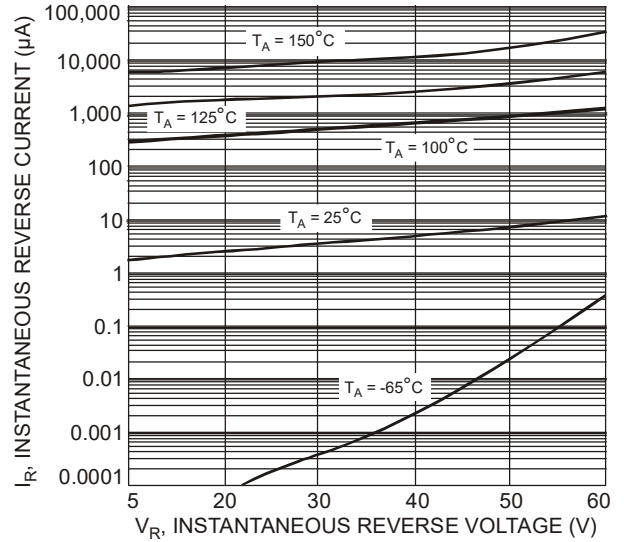


Fig. 2 Typical Reverse Characteristics

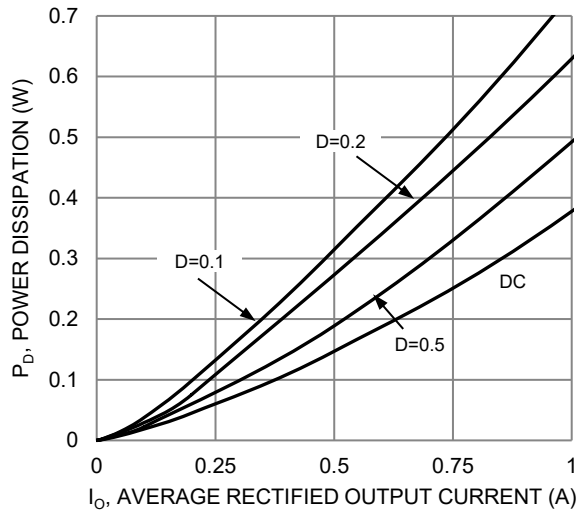


Fig. 3 Forward Power Dissipation $T_J=125^\circ\text{C}$

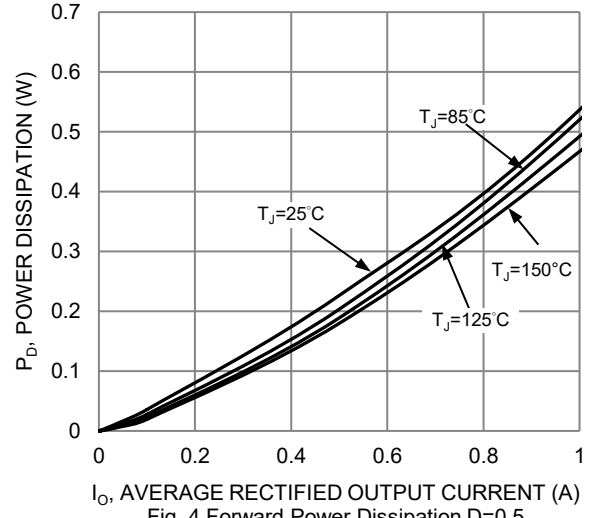


Fig. 4 Forward Power Dissipation $D=0.5$

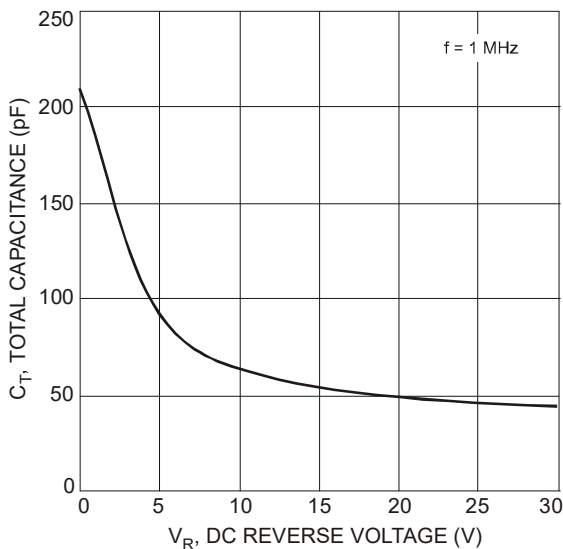


Fig. 5 Total Capacitance vs. Reverse Voltage

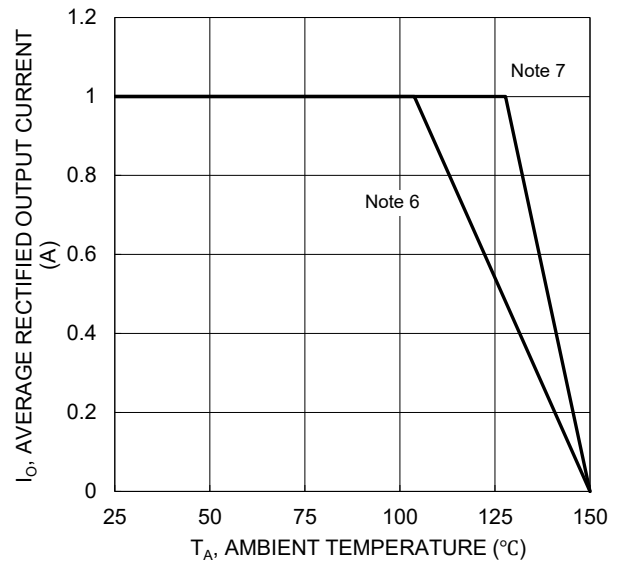
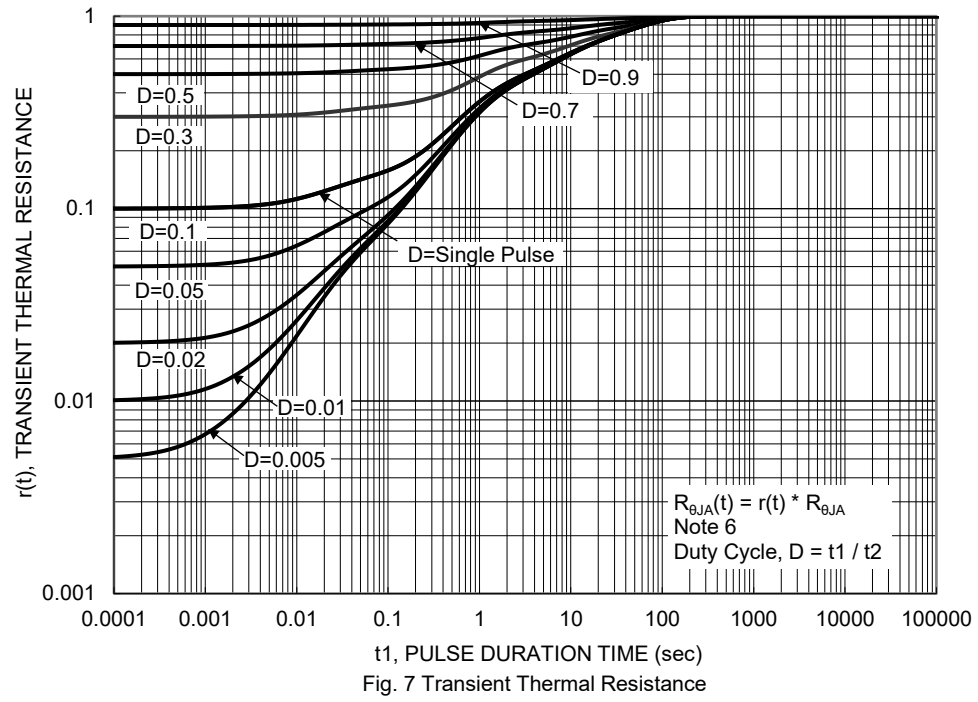


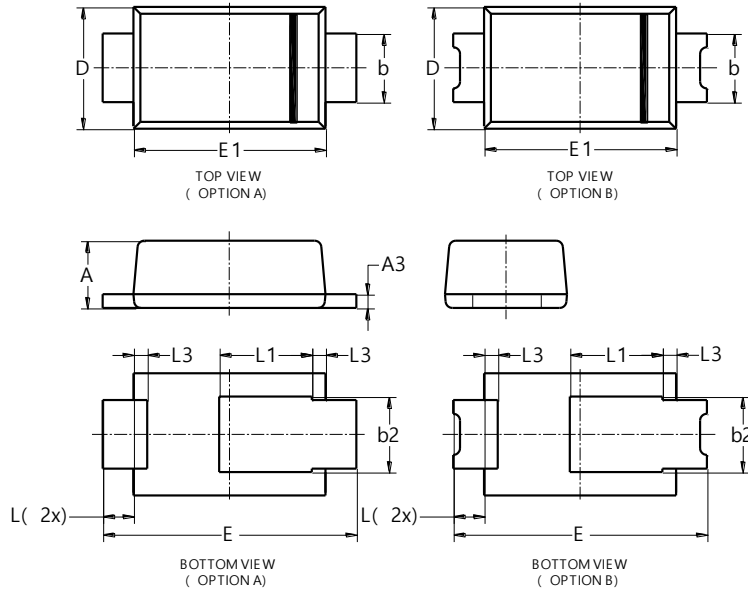
Fig. 6 DC Forward Current Derating

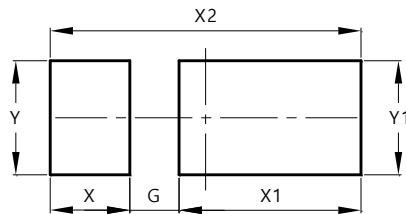
