





## RELATIVE INTENSITY vs. WAVELENGTH




## SPATIAL DISTRIBUTION






## REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS



## TAPE SPECIFICATIONS (units : mm)





## REEL DIMENSION (units : mm)
