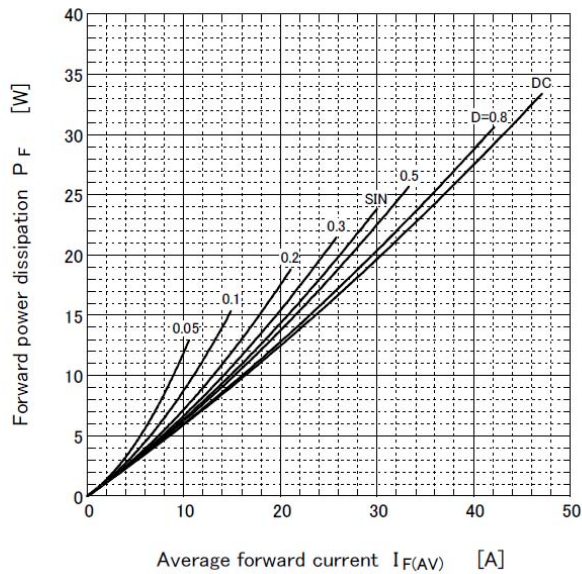
Forward voltage



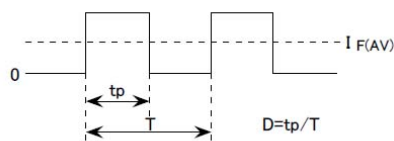
Reverse current



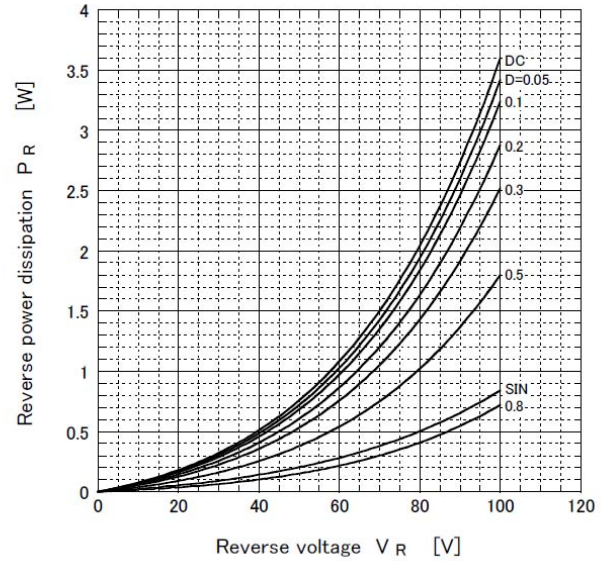
Forward power dissipation



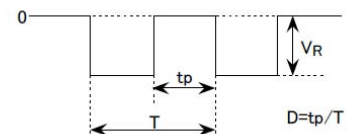

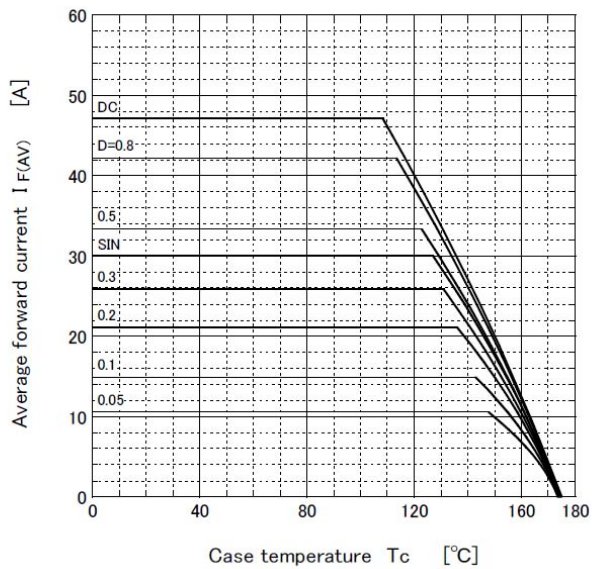
Reverse power dissipation



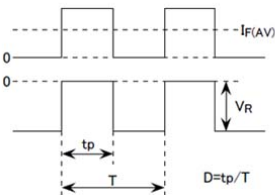

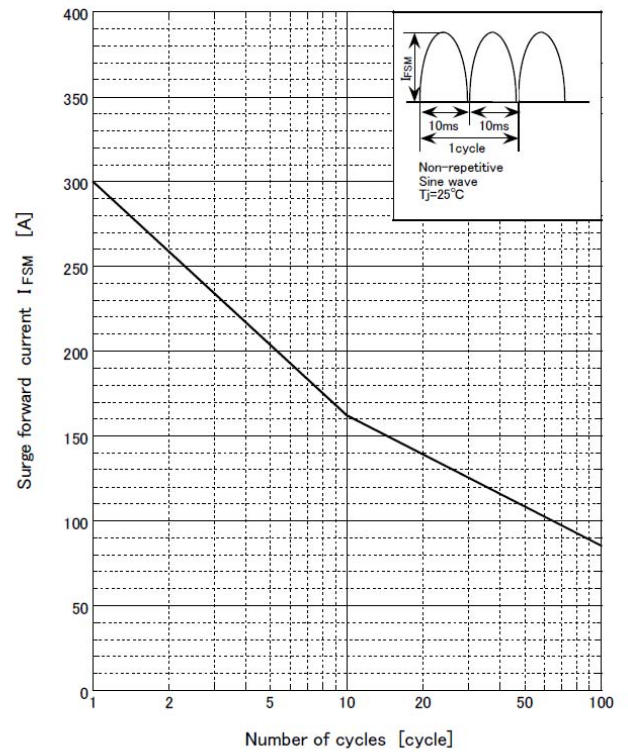
Derating curve



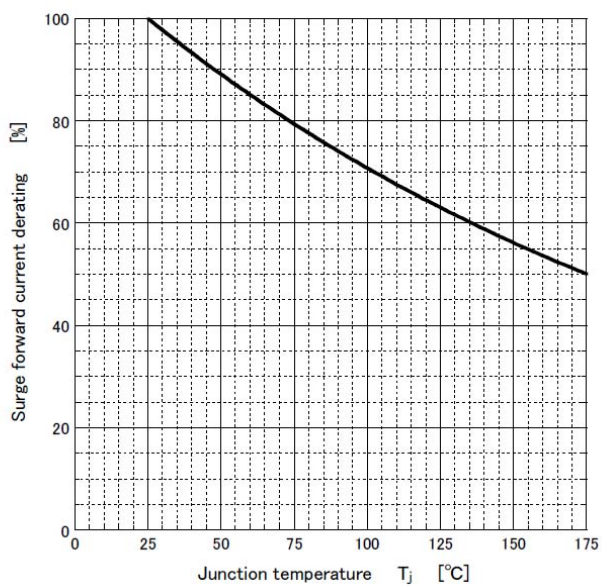

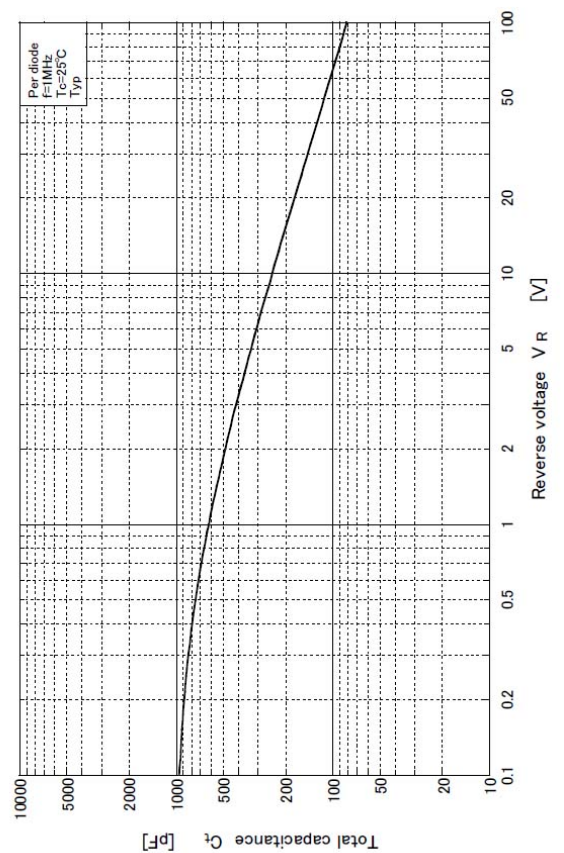
Surge forward current capability



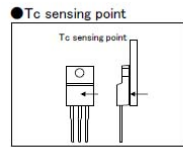
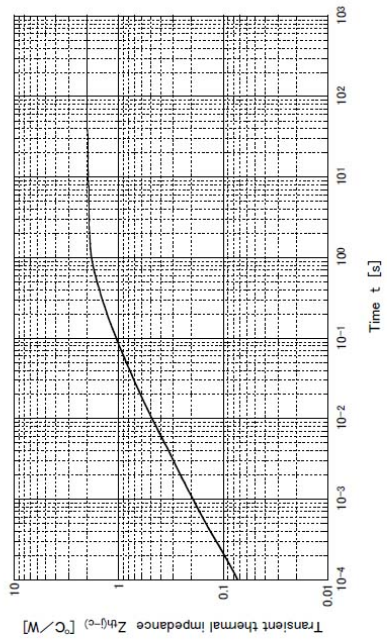
Surge forward current derating vs Junction temperature



Total capacitance

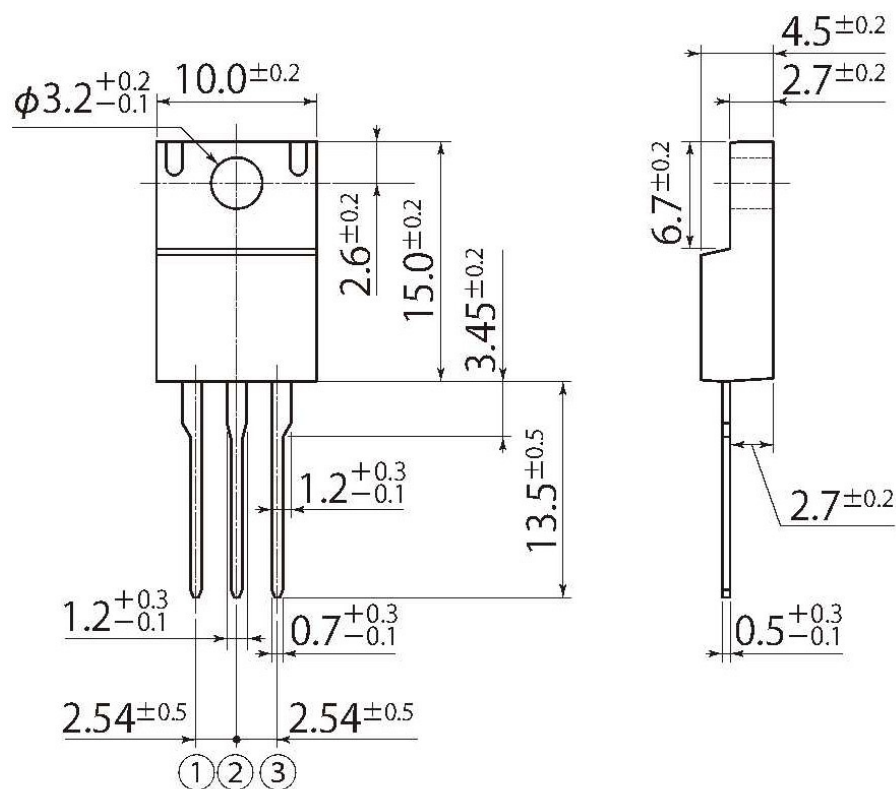


Transient thermal impedance
