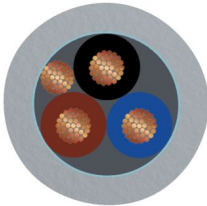

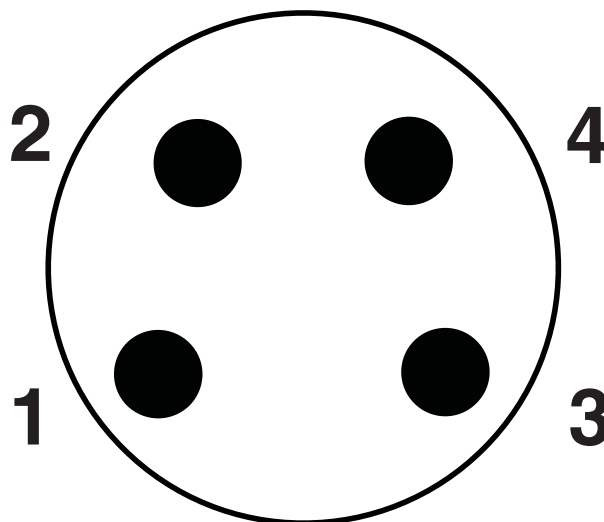

Pin assignment M8 plug, 4-pos., view male side

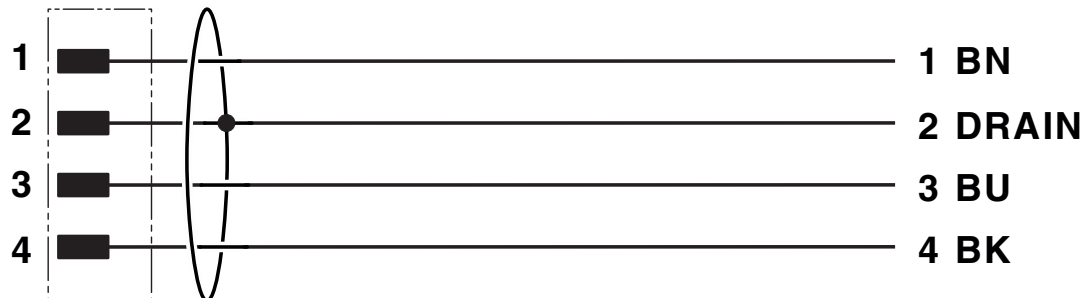
