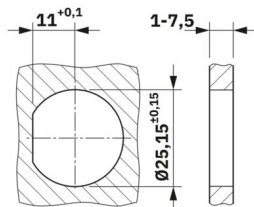

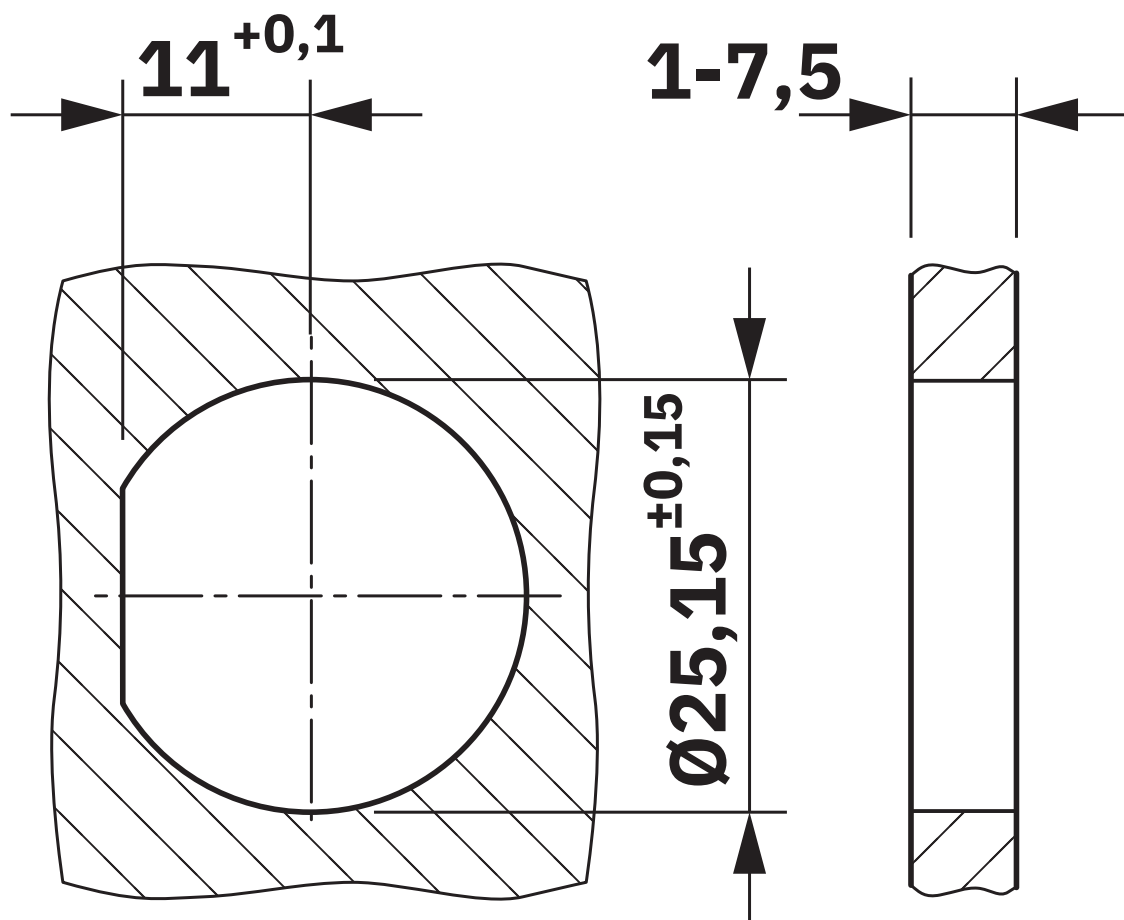

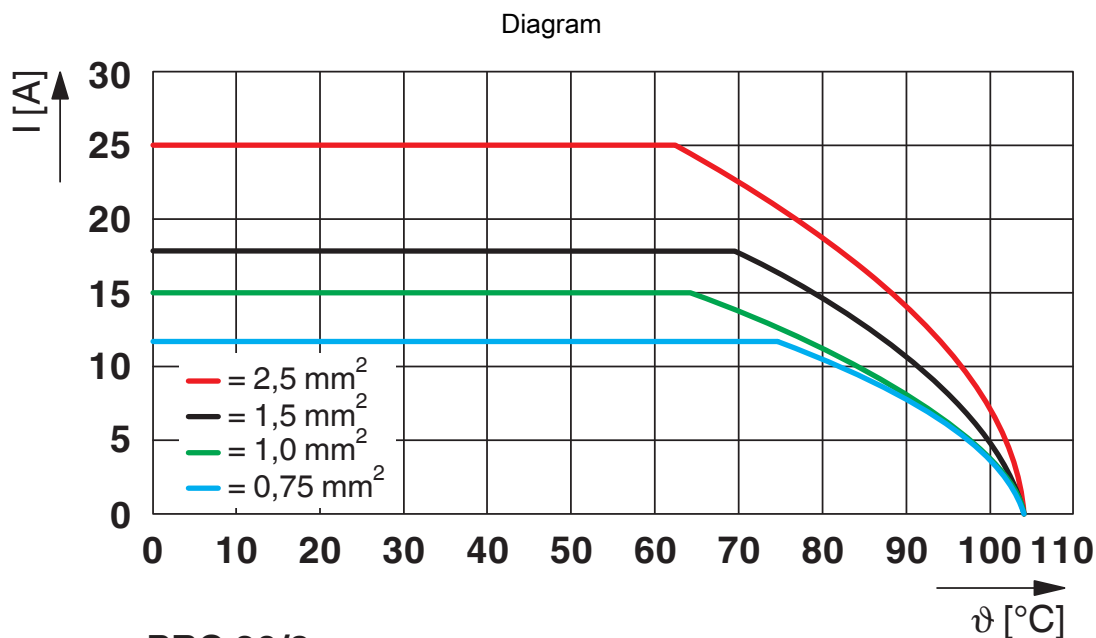
Drilling diagram

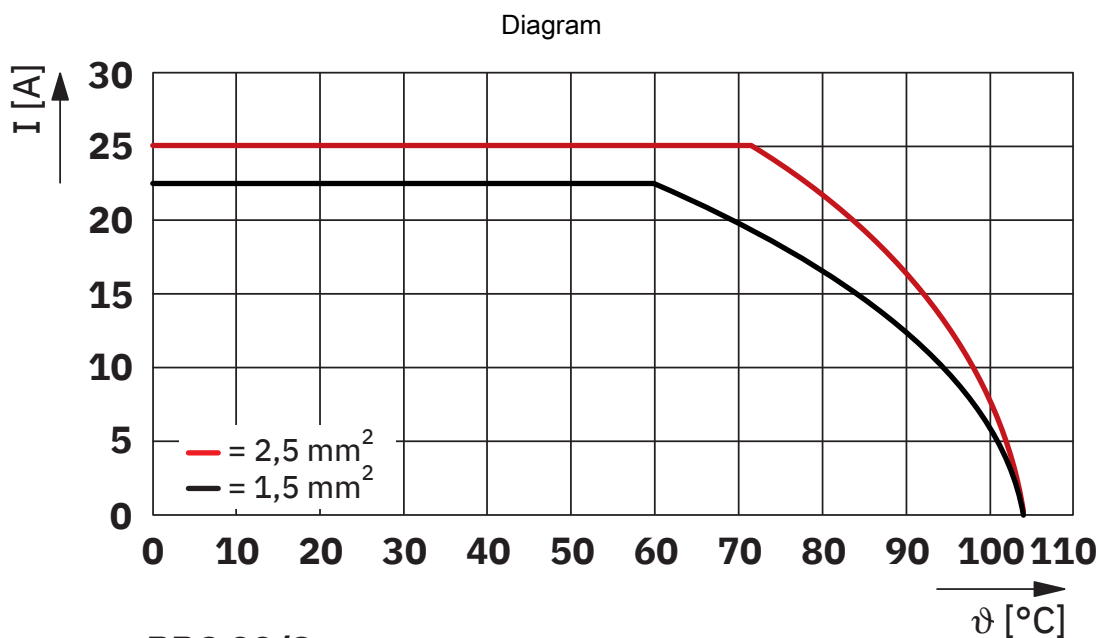
