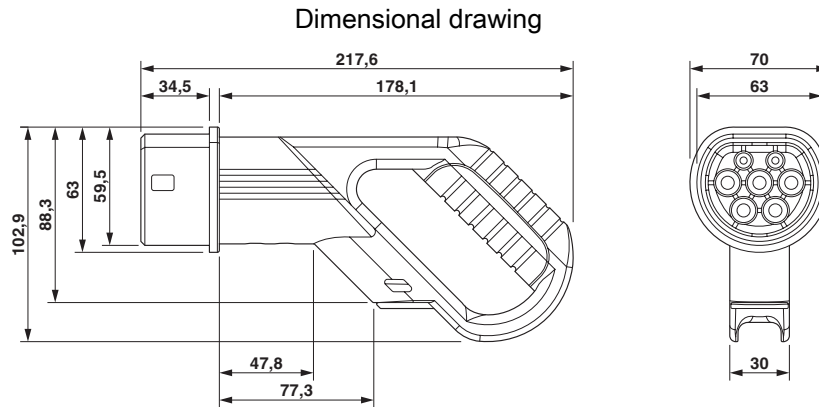

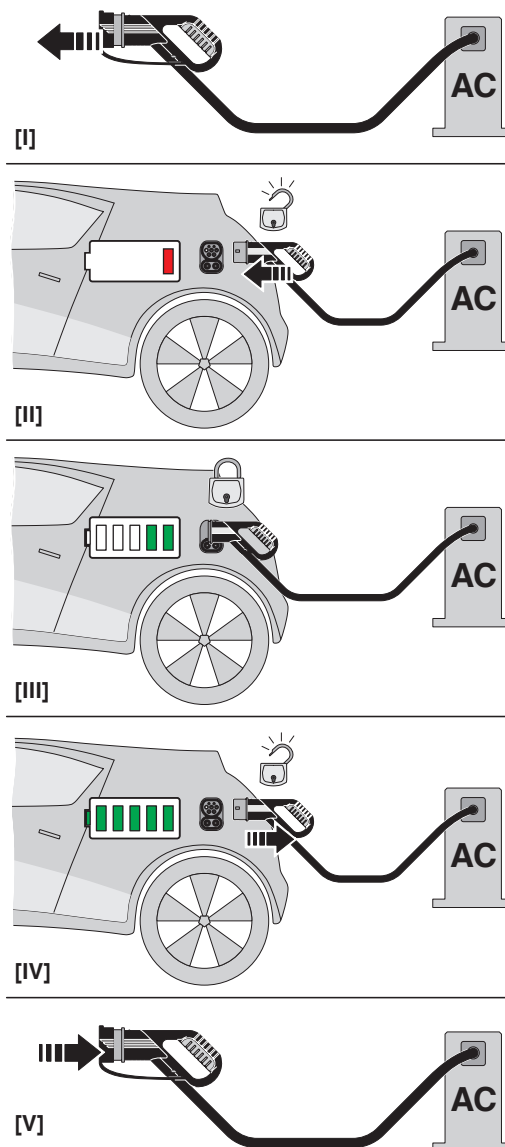

Schematic diagram



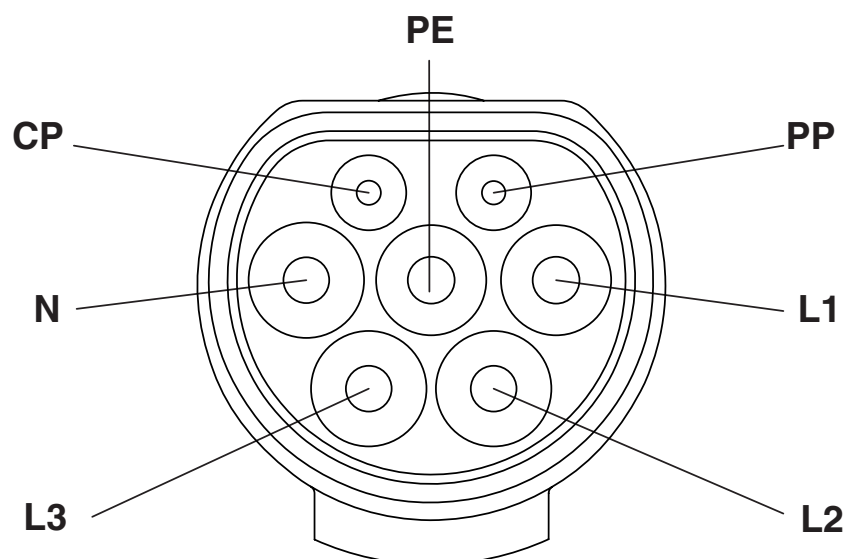
