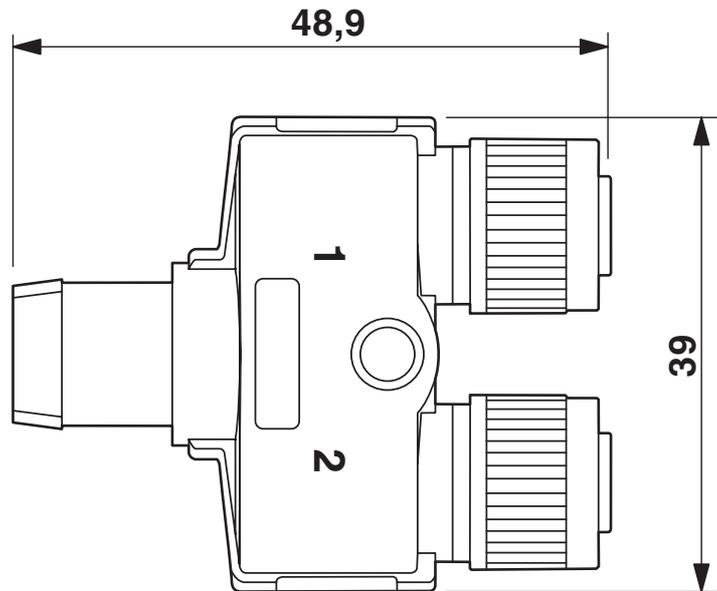




Y distributor, 2 x socket M12 x 1


Plug, M12 x 1, straight, shielded

Schematic diagram




Pin assignment M12 plug, 4-pos., A-coded, view plug side
