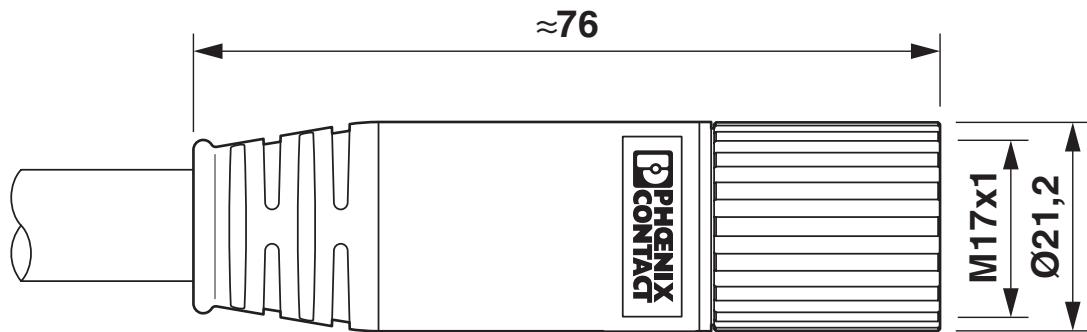

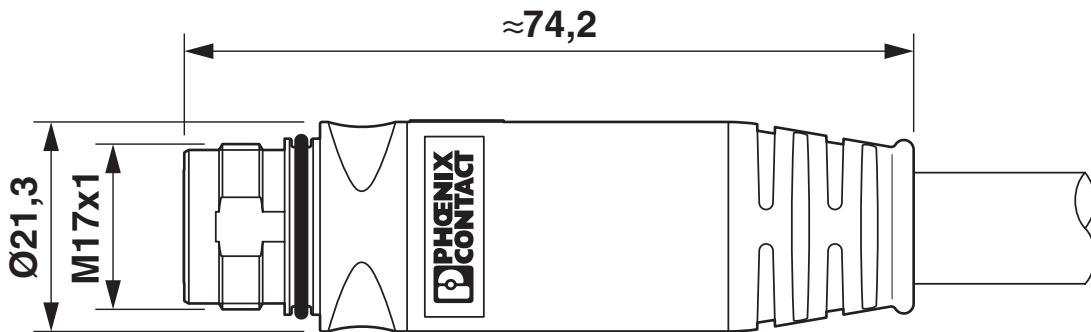

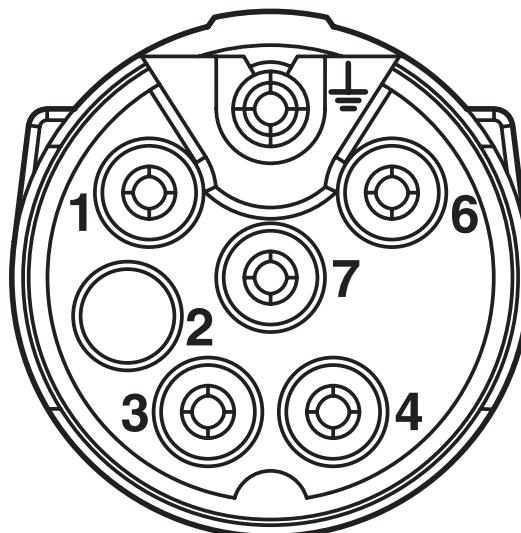

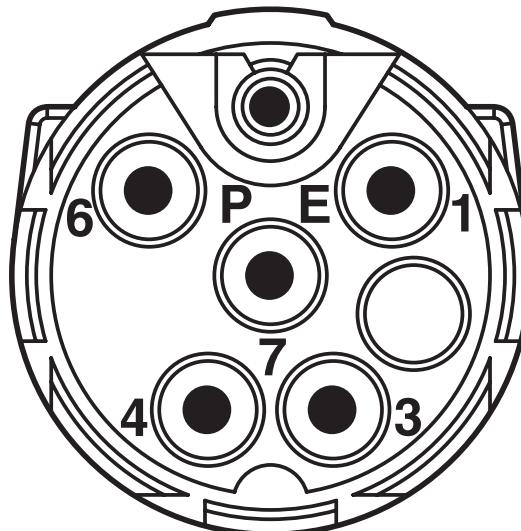

Pin assignment of pin

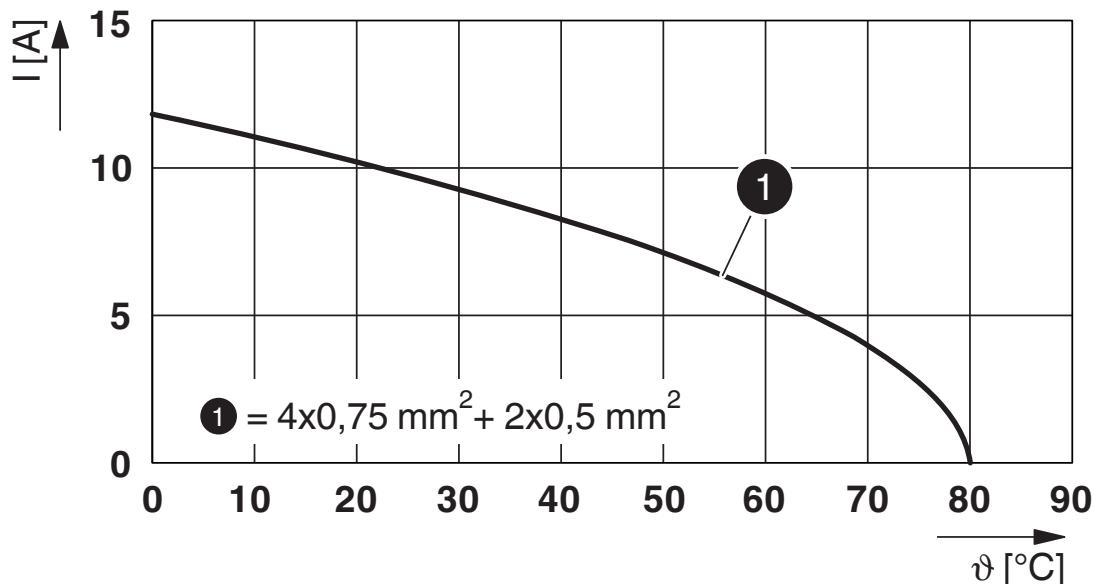

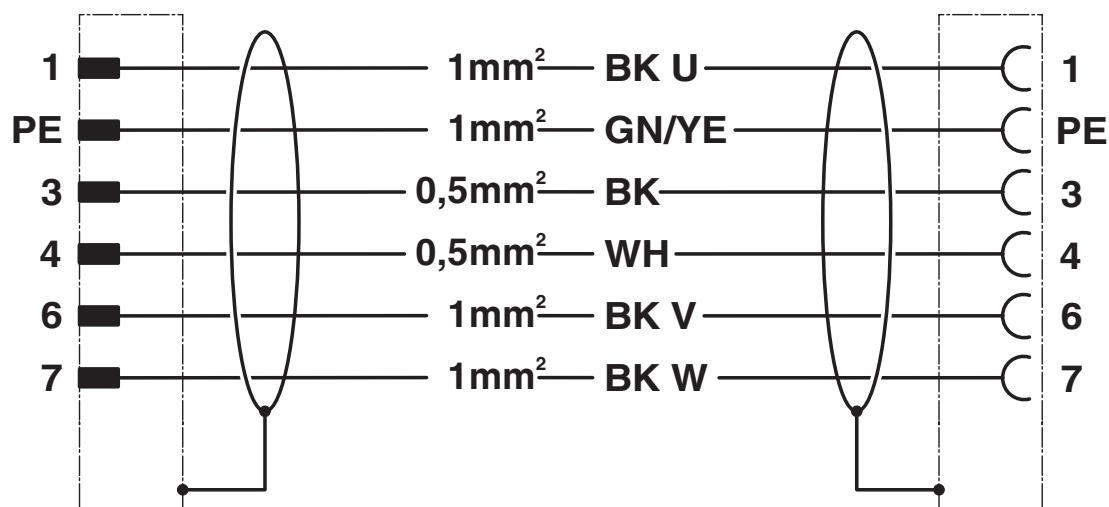
