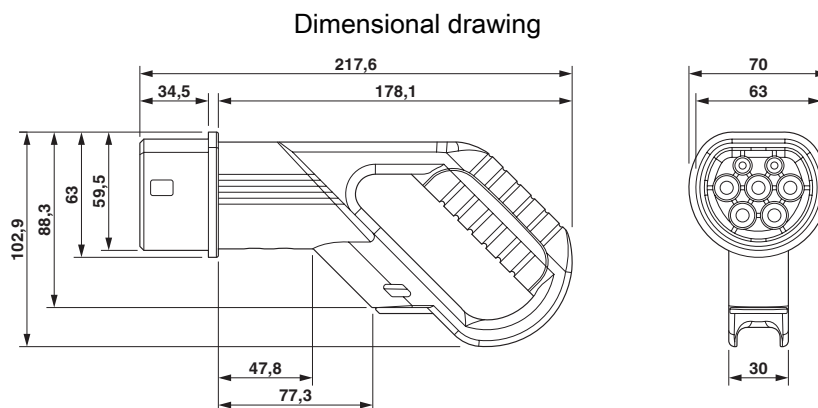

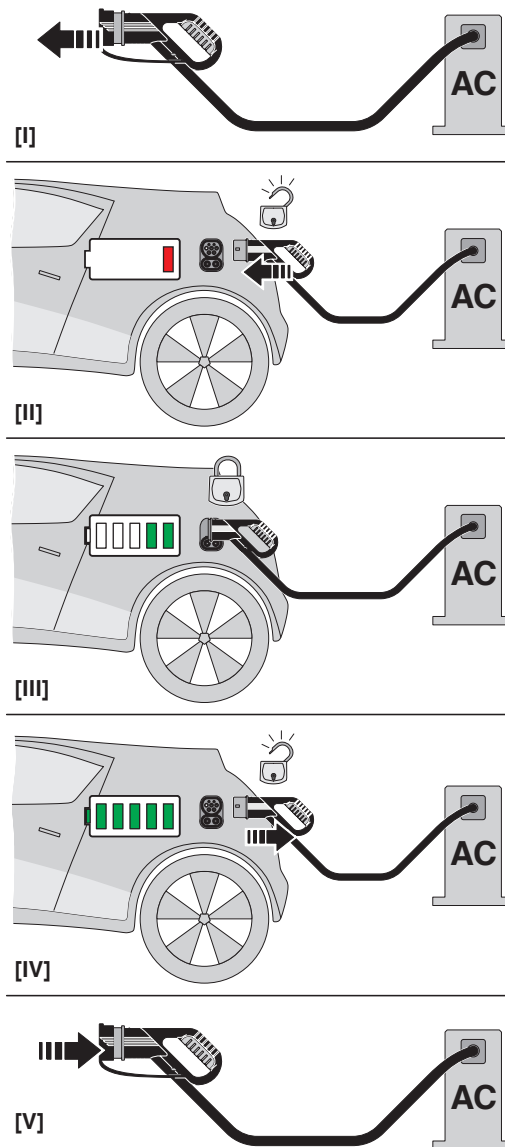

Schematic diagram



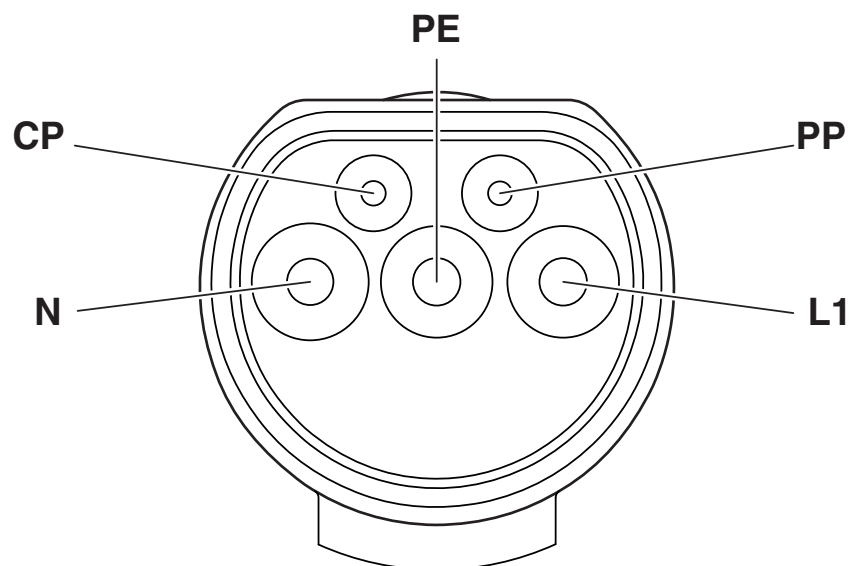
