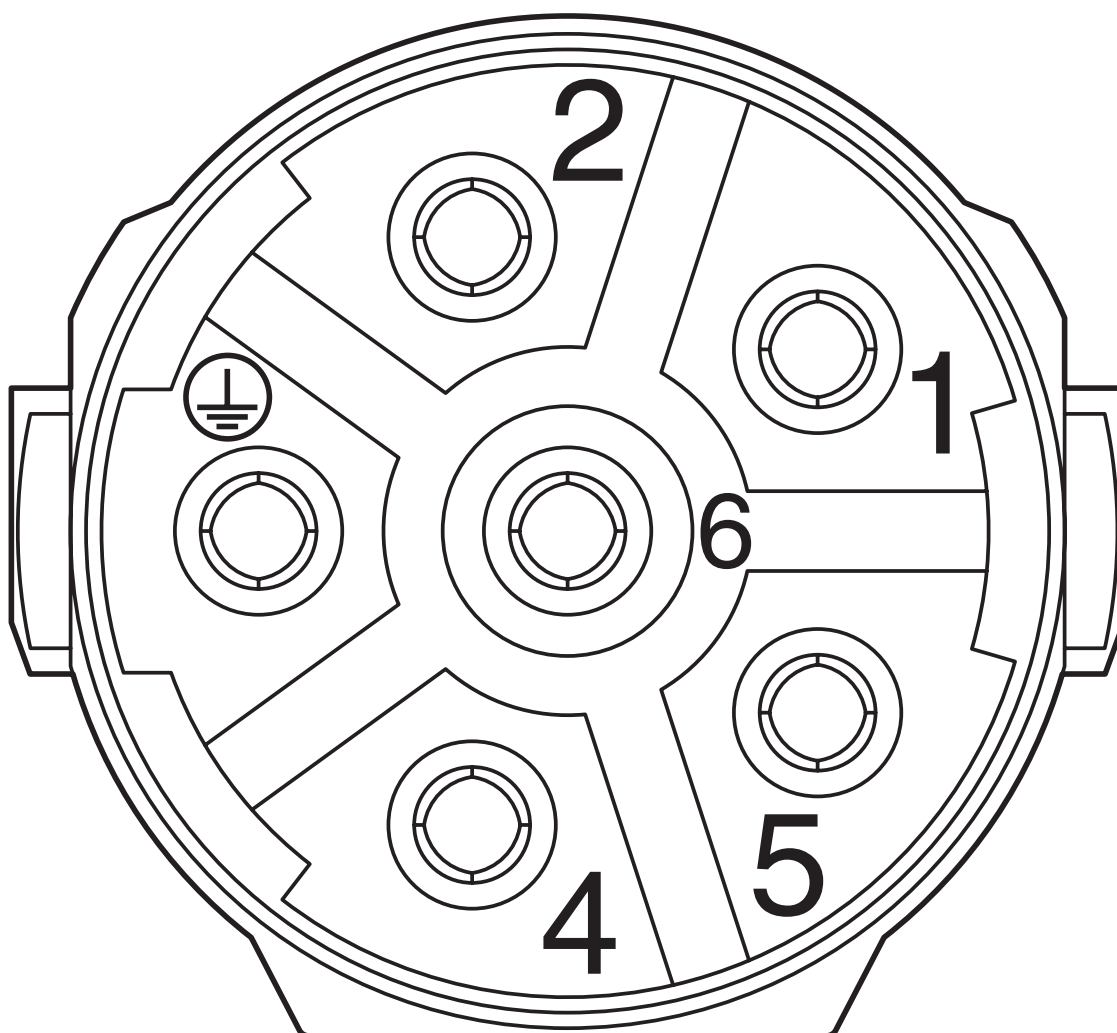

Connector pin assignment

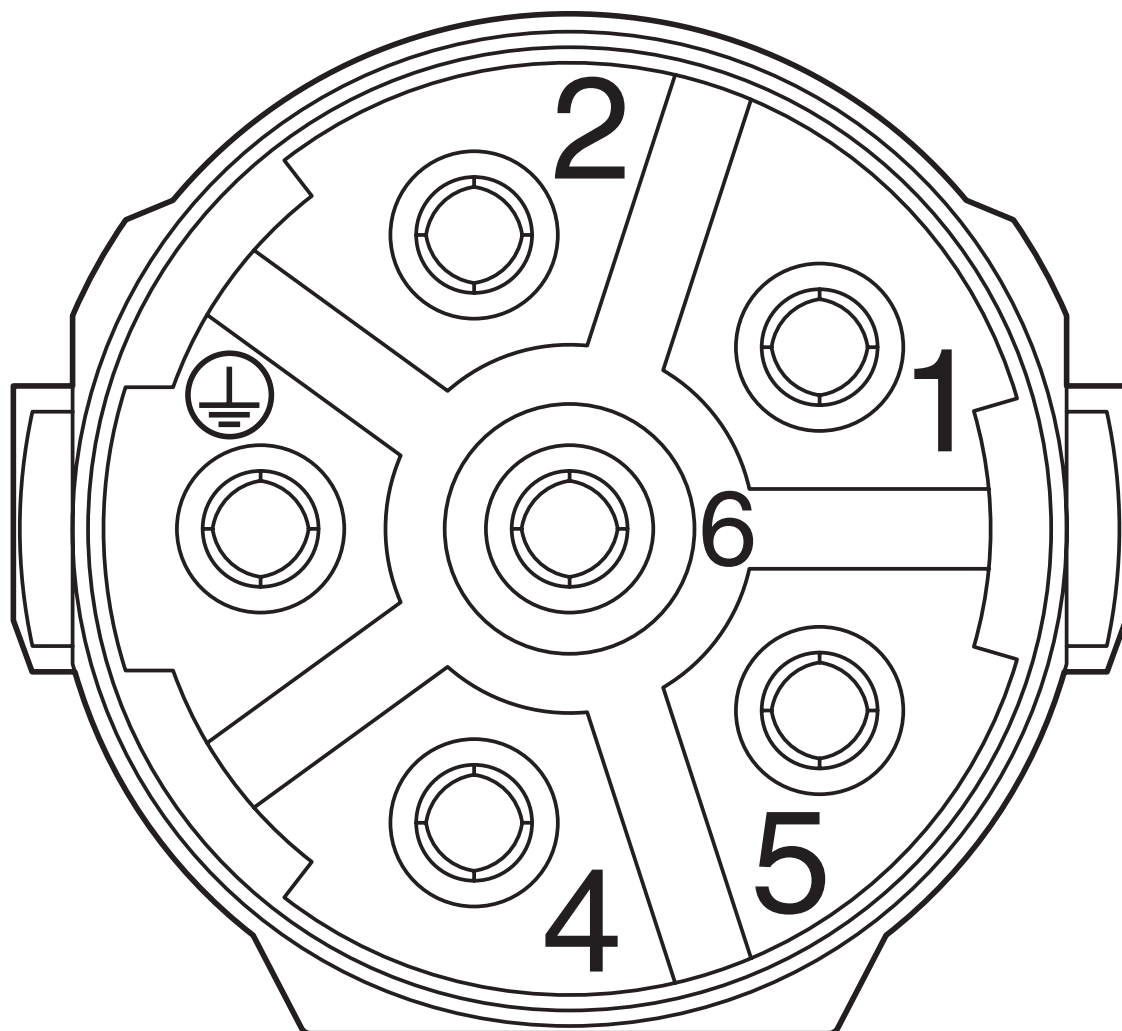

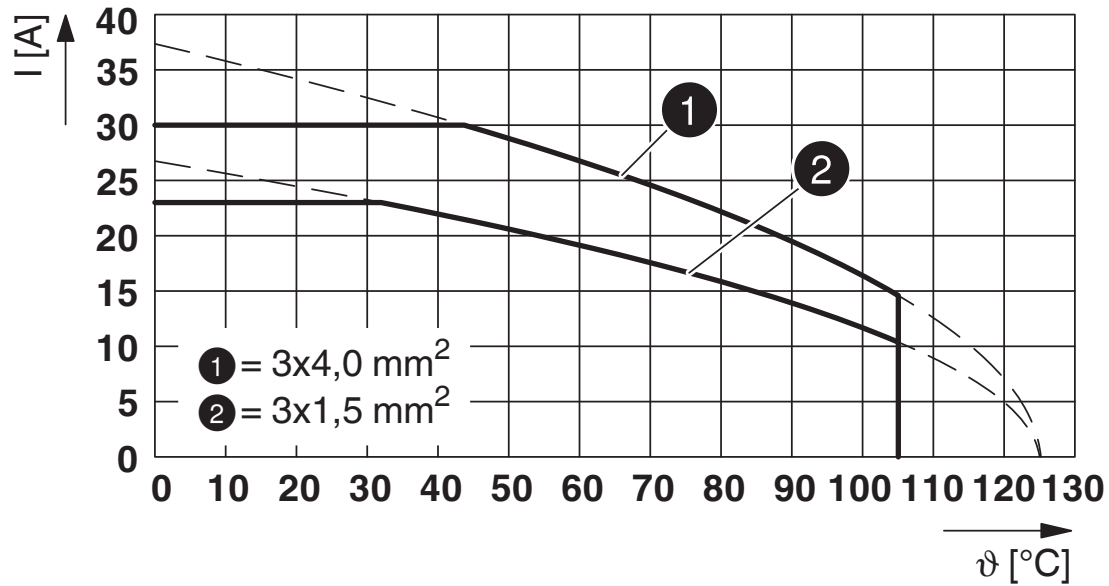
