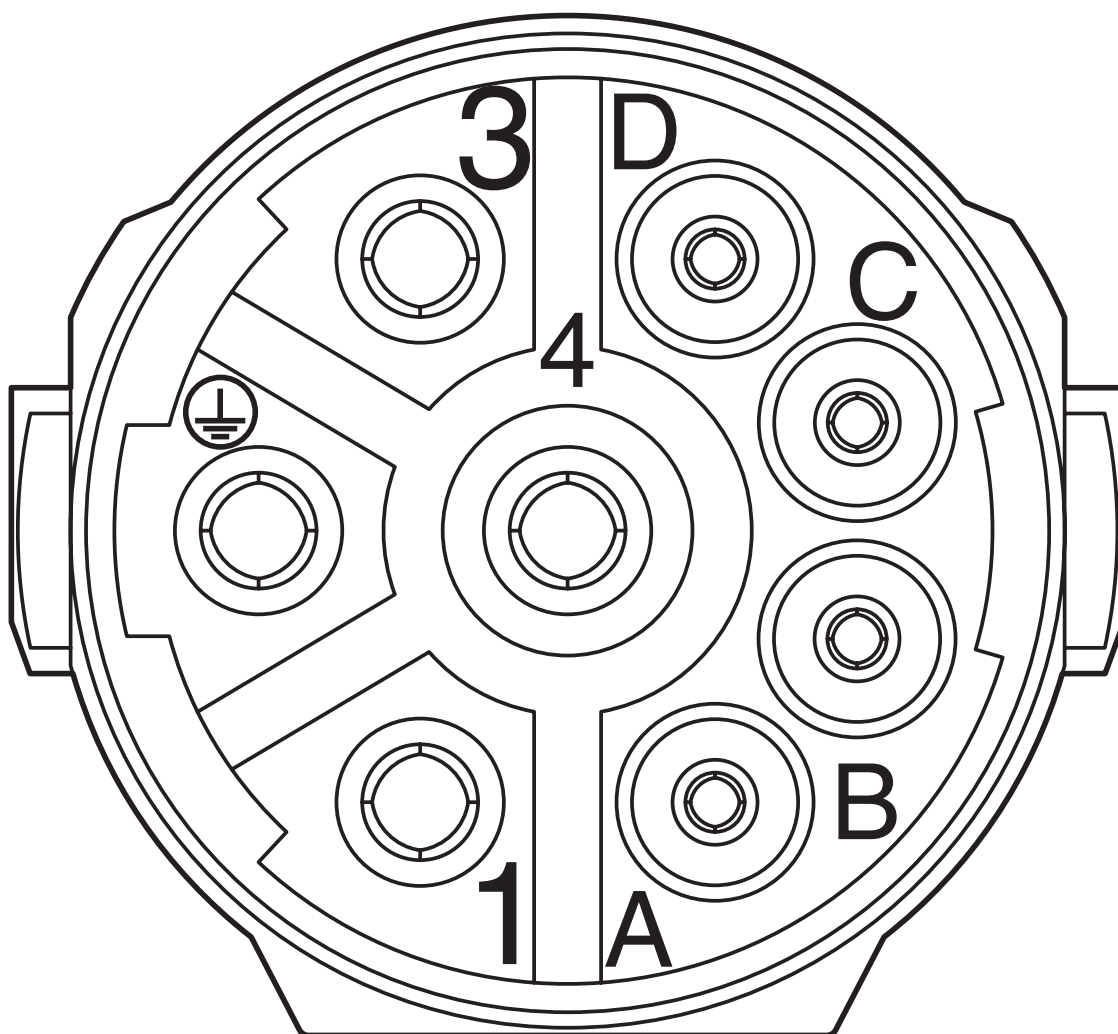

Schematic diagram



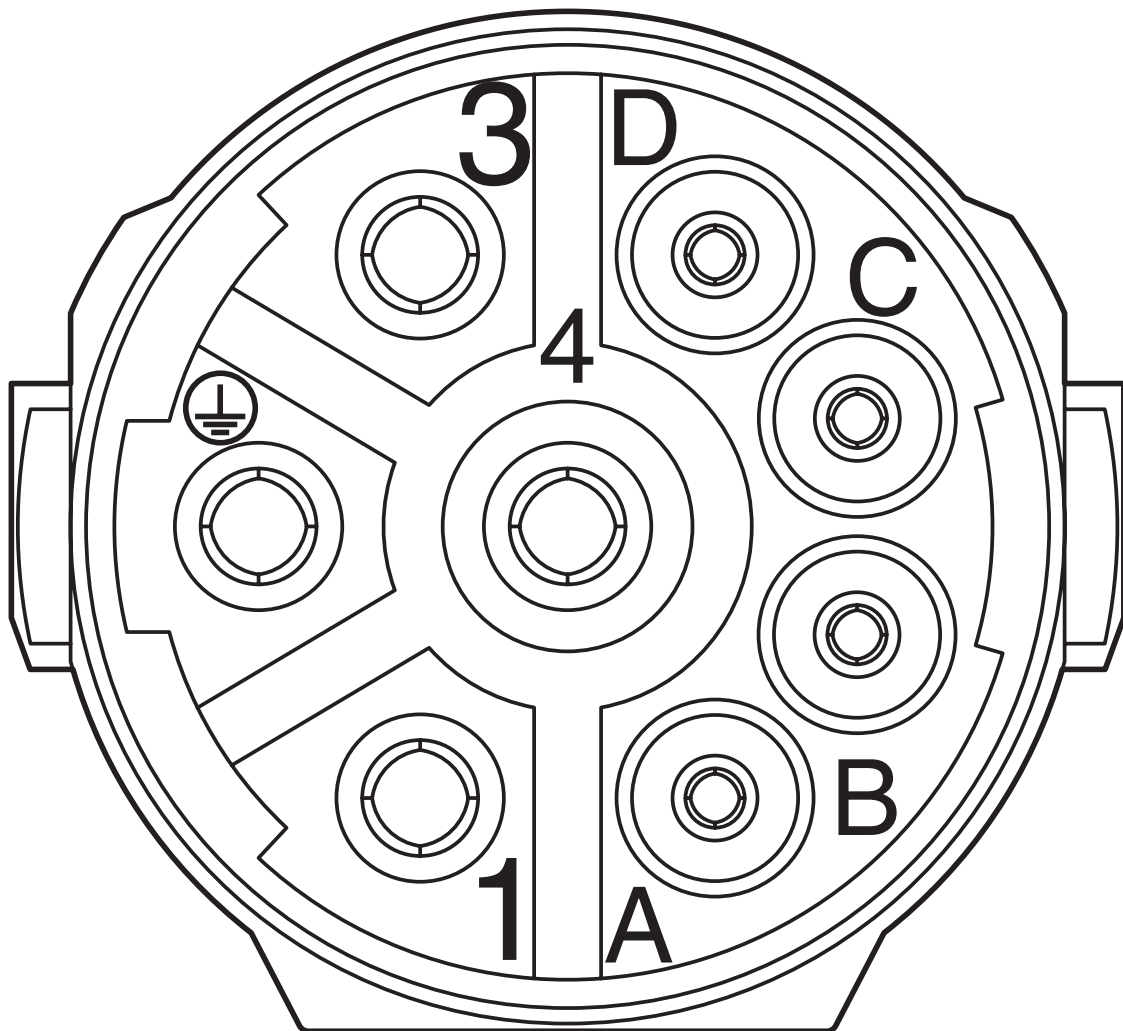

Schematic diagram



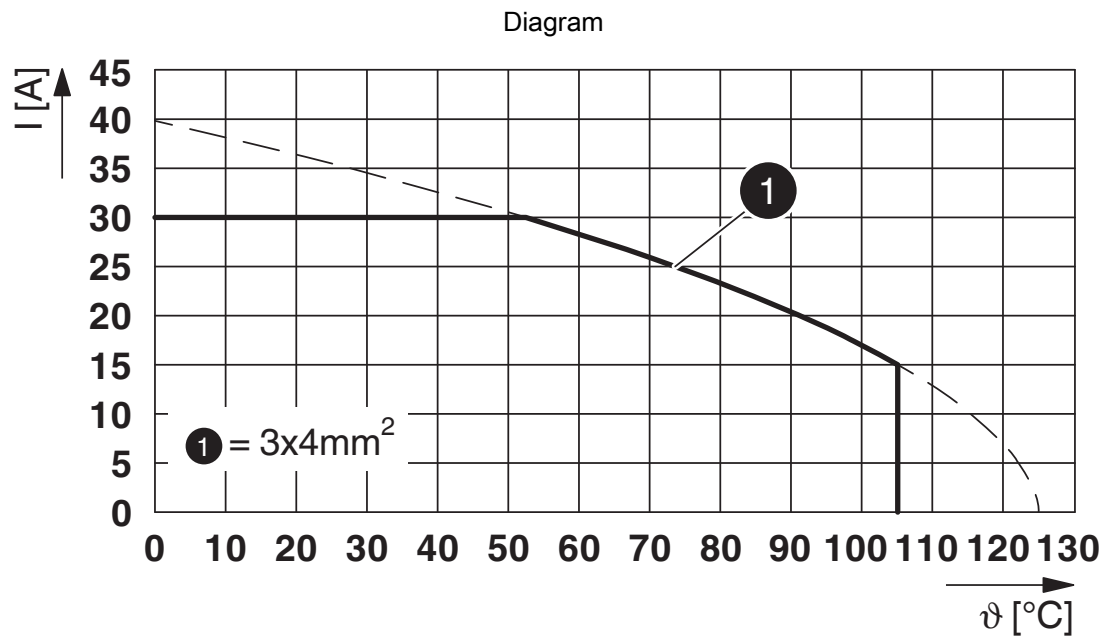
