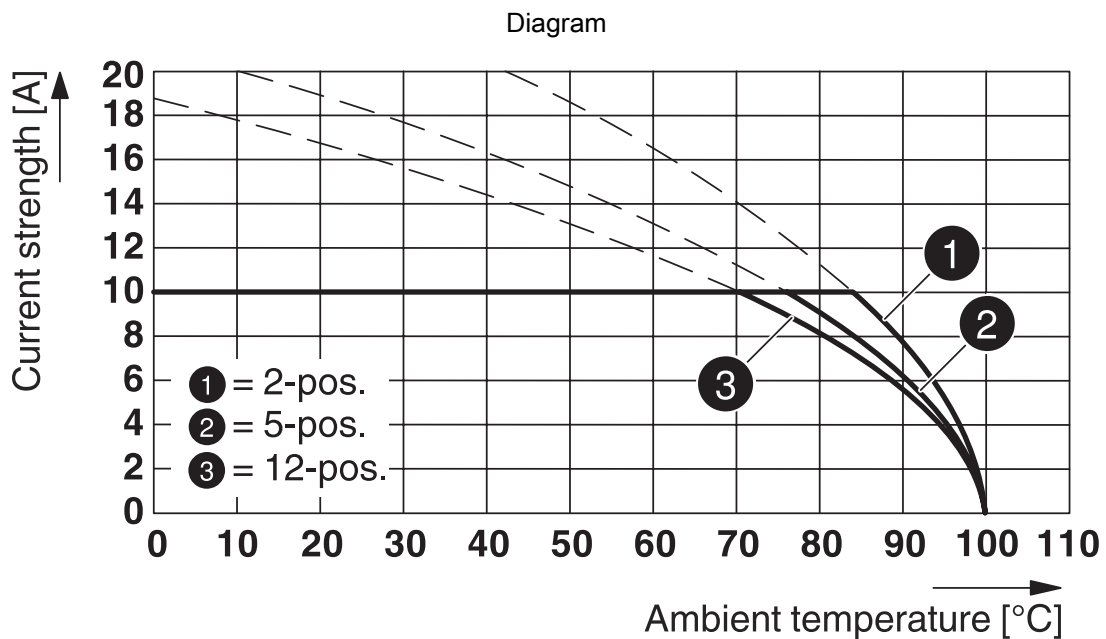

Type: FKC 2,5/...-ST-5,08 with CCVA 2,5/...-G-5,08 P26THR

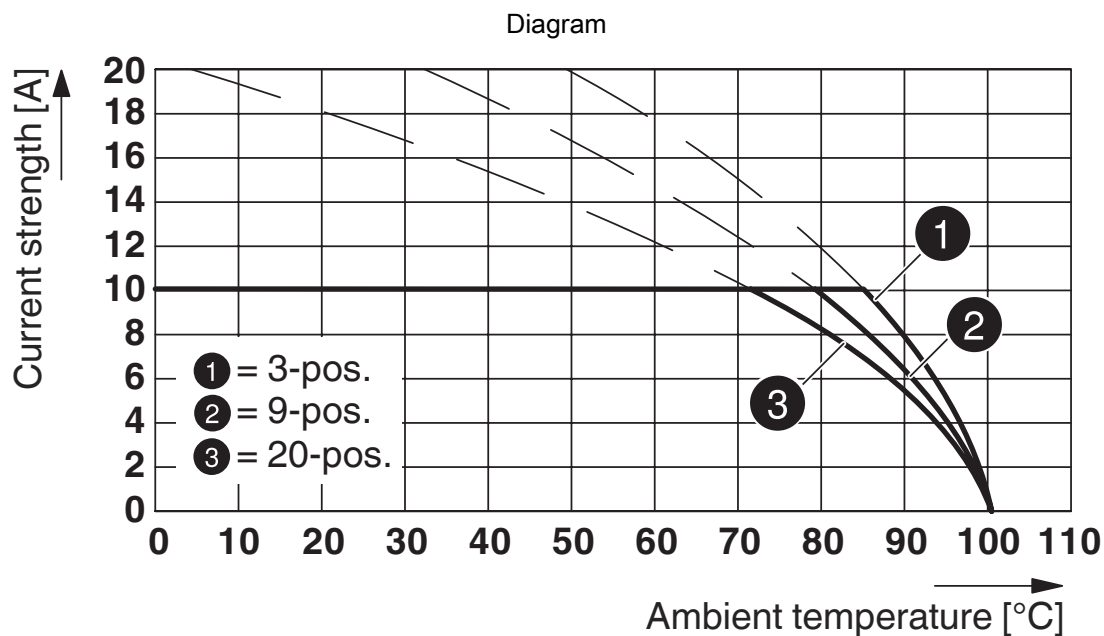


Type: FKC 2,5/...-ST-5,08 with MDSTBVA 2,5/...-G-5,08

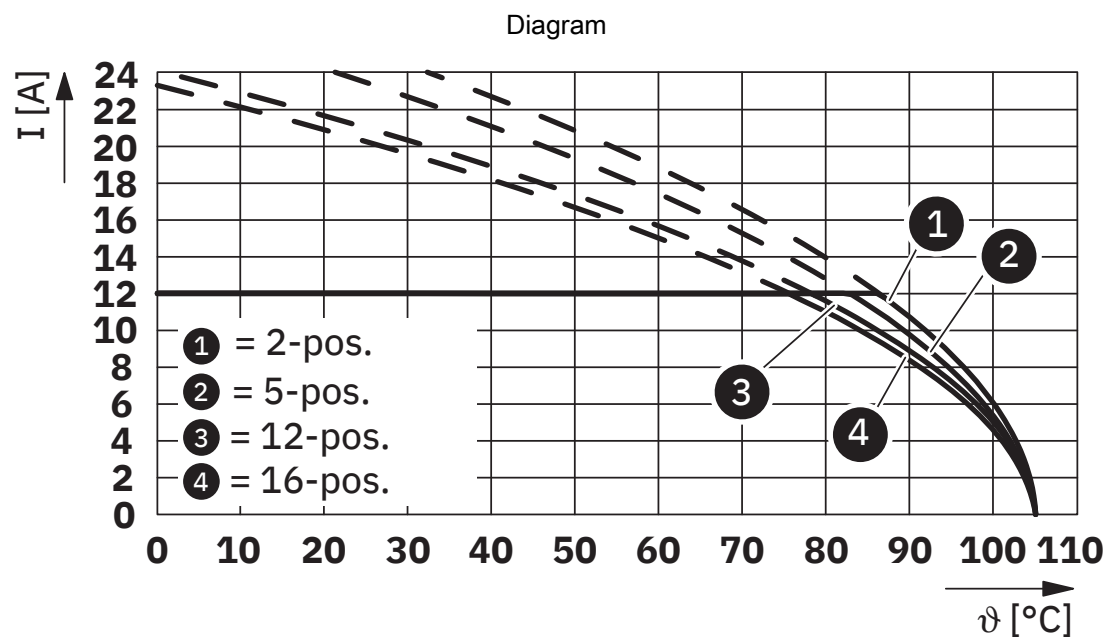


Type: FKC 2,5/...-ST-5,08 with MDSTB 2,5/...-G-5,08

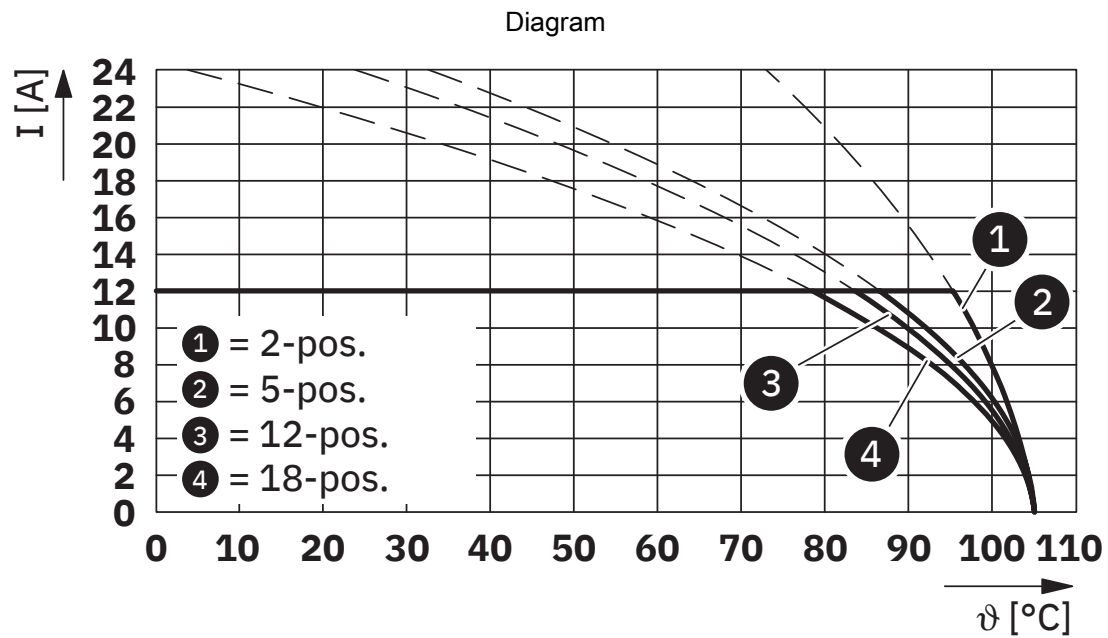
