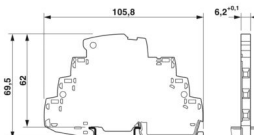

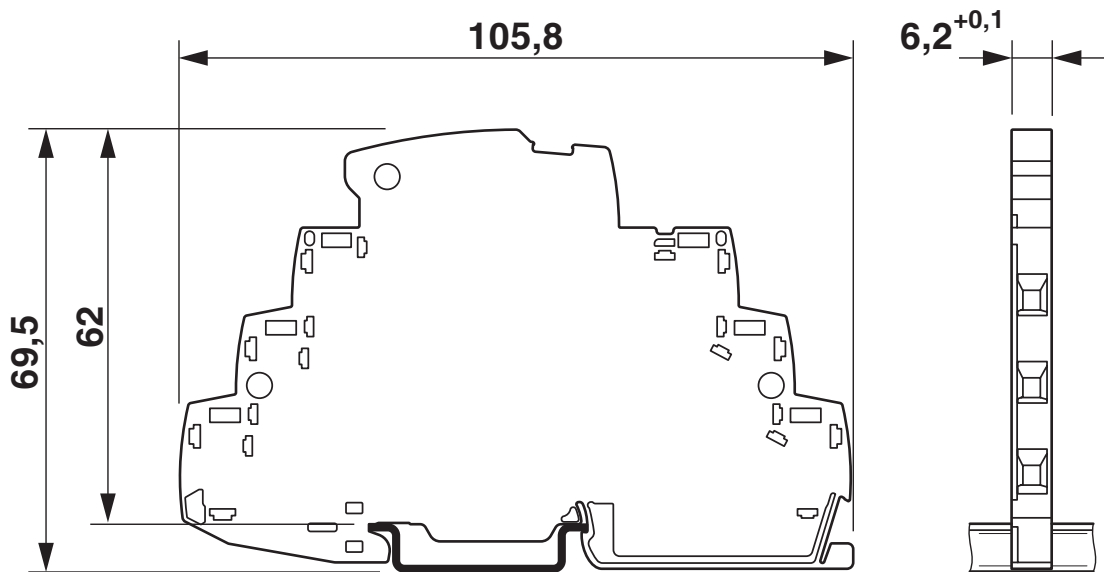

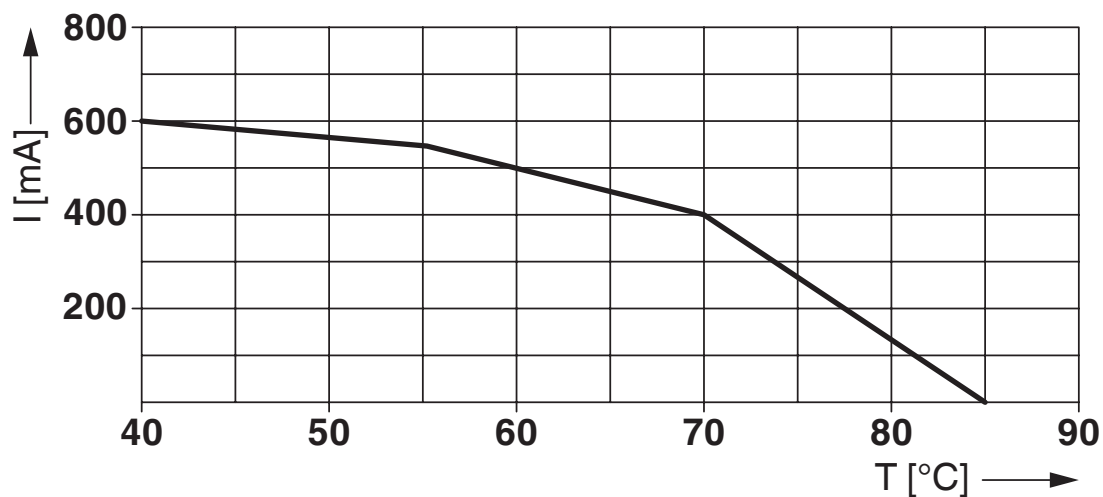


Schematic diagram

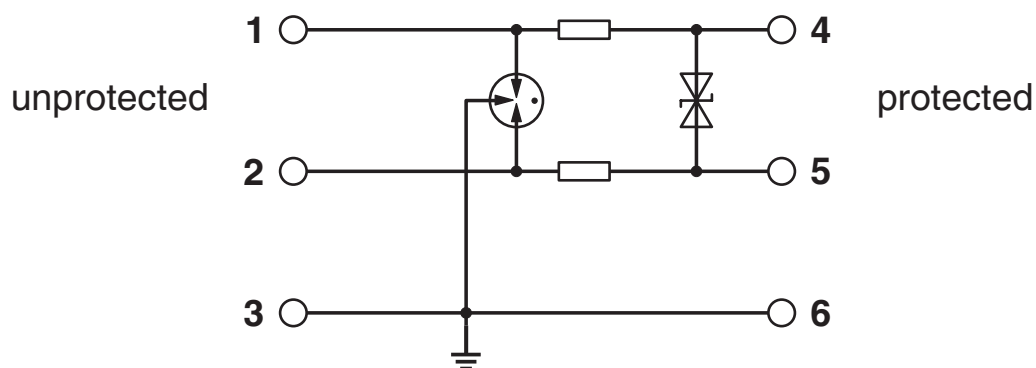
