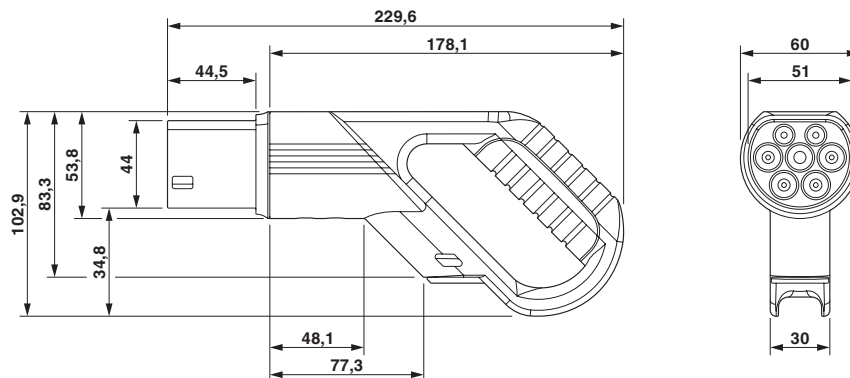

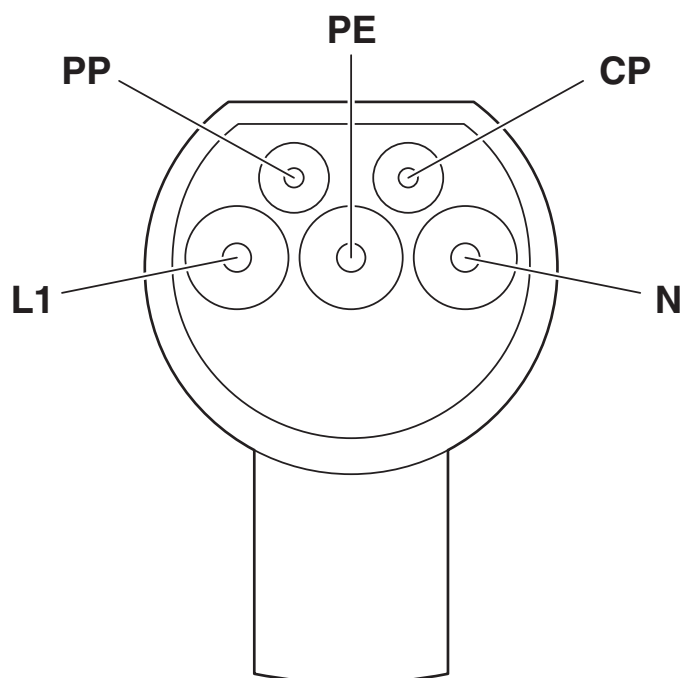

Connection diagram



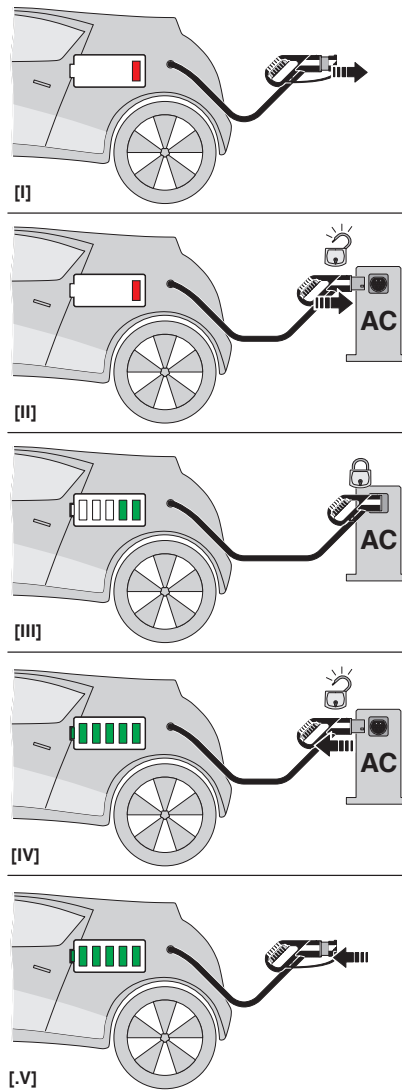
Pin assignment of Infrastructure Plug

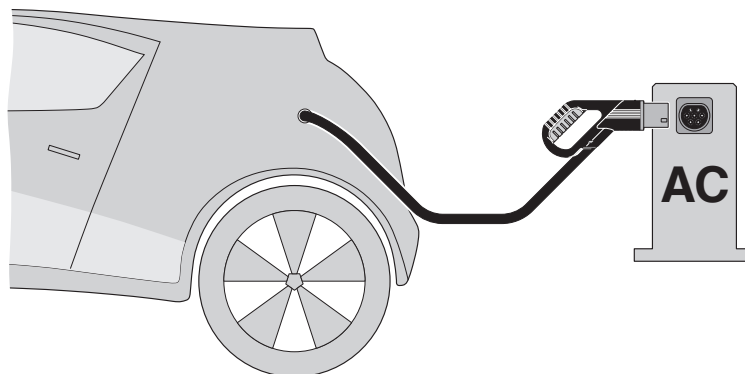
