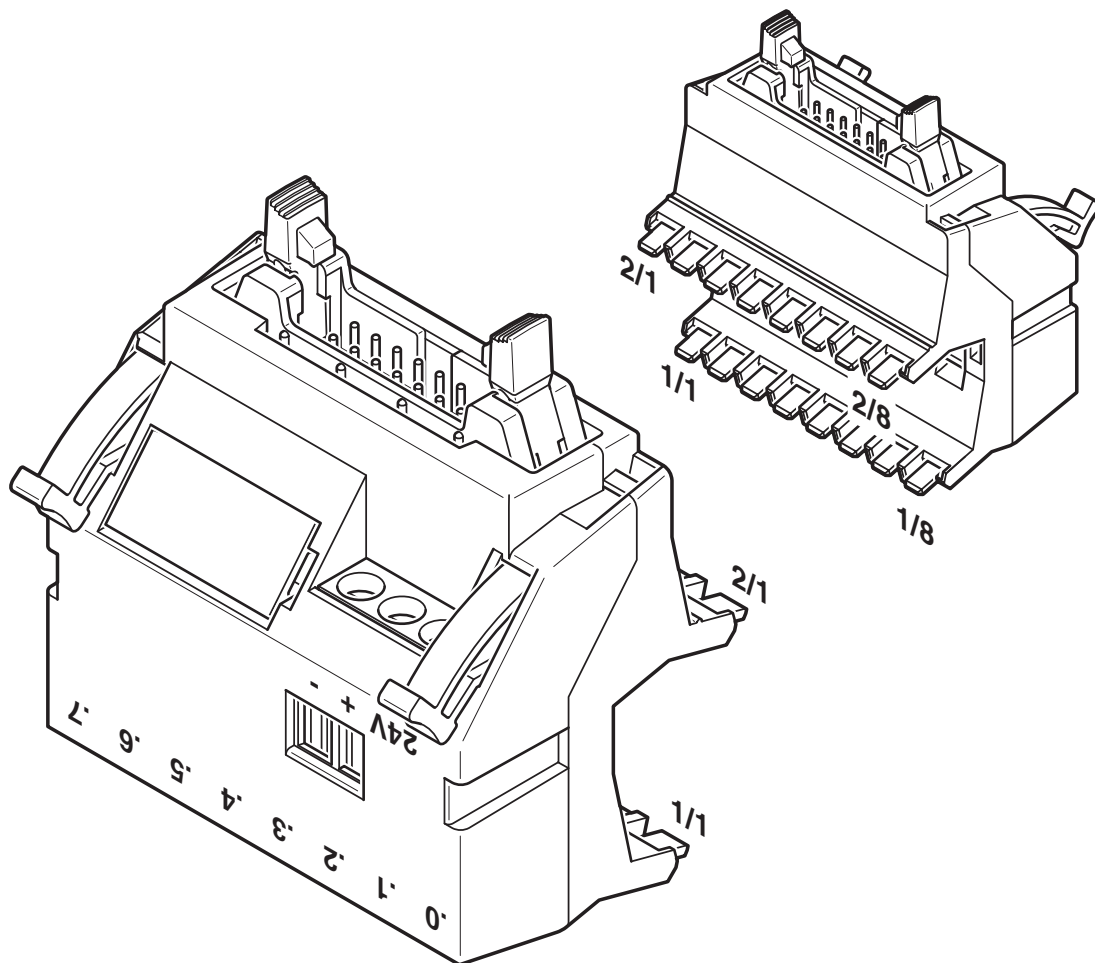

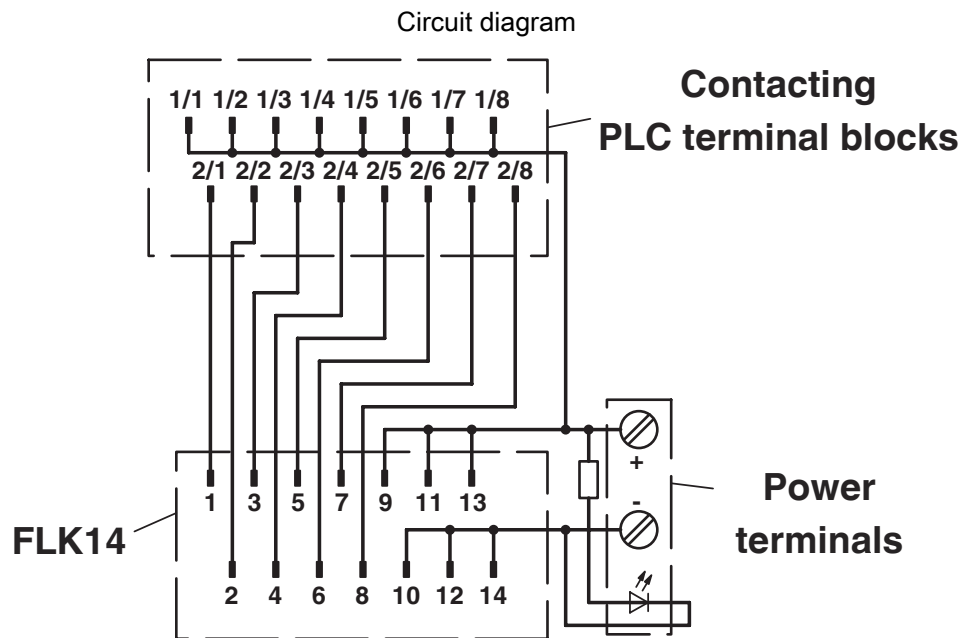
Schematic diagram
