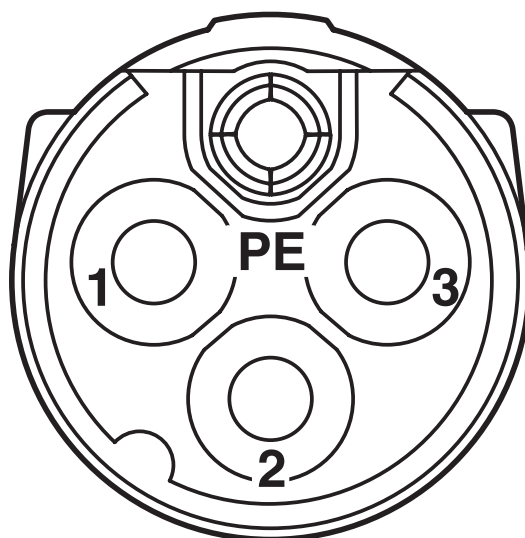

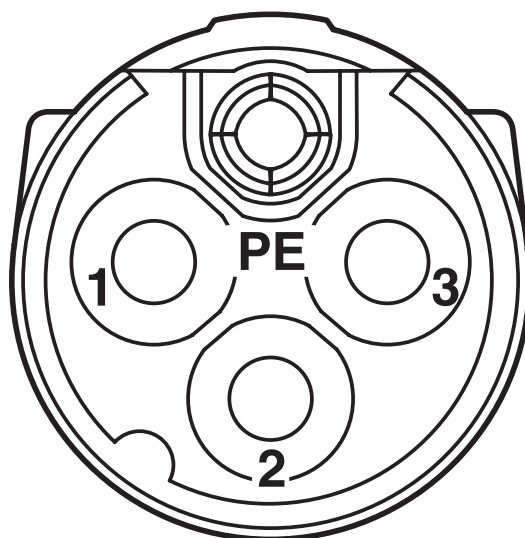

Schematic diagram

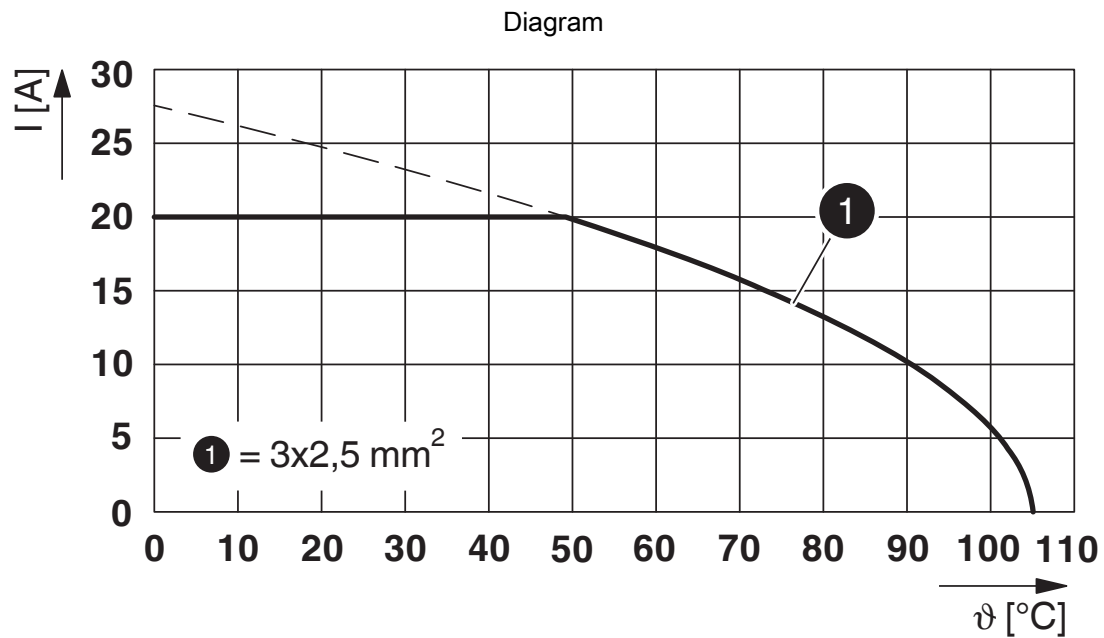
