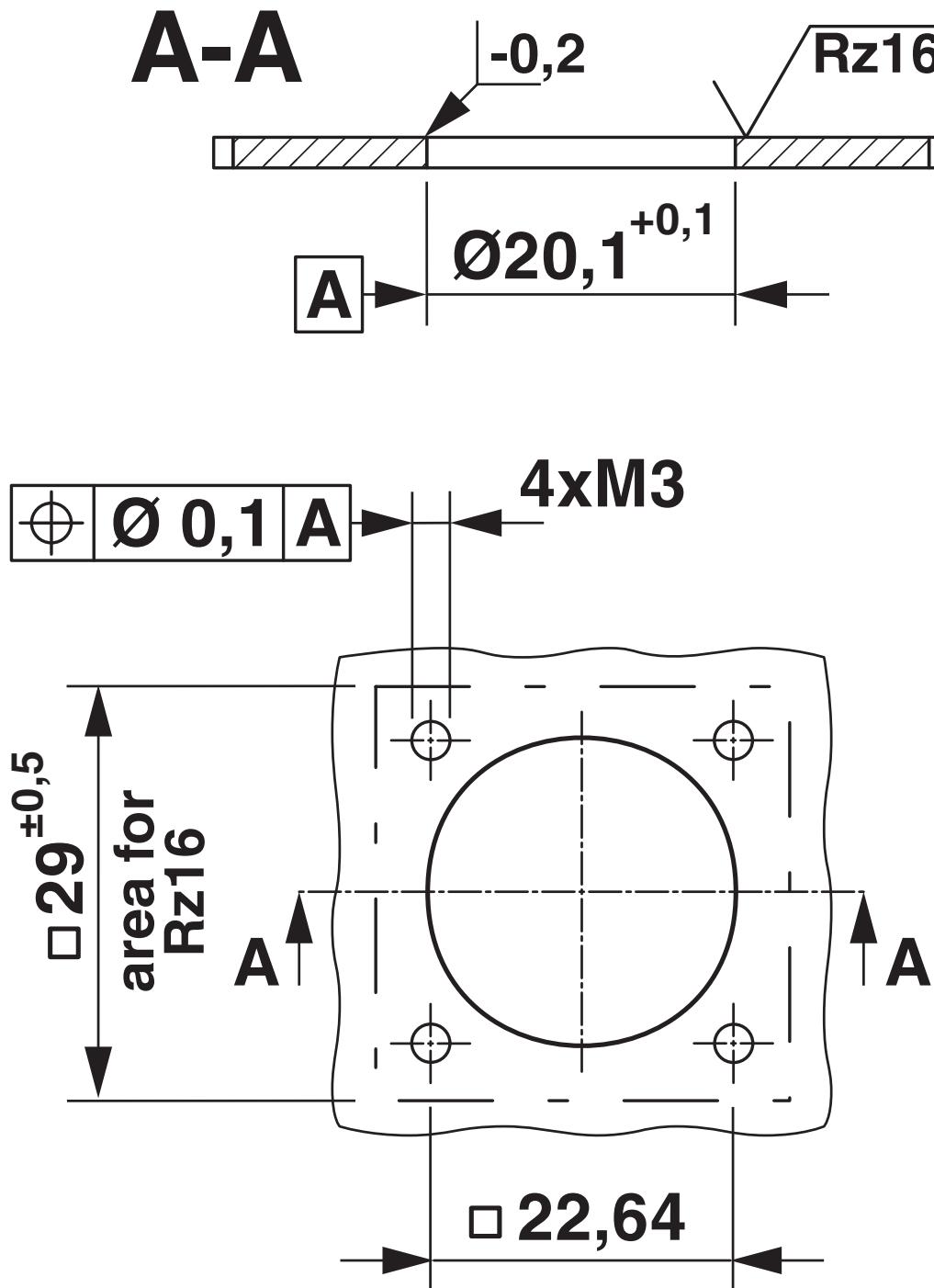



Connector pin assignment






