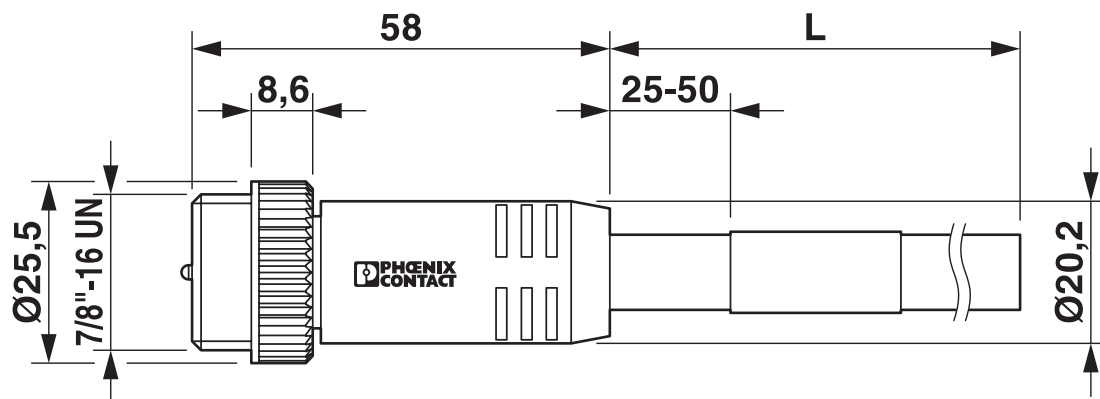

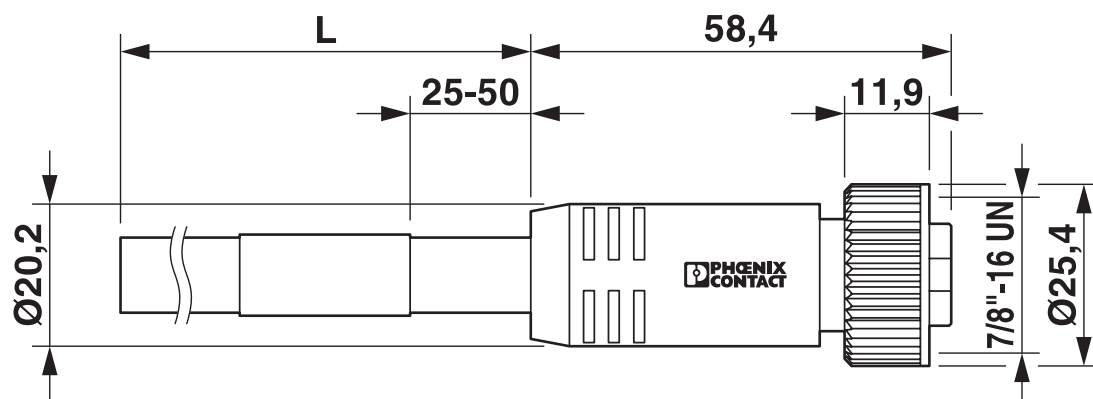

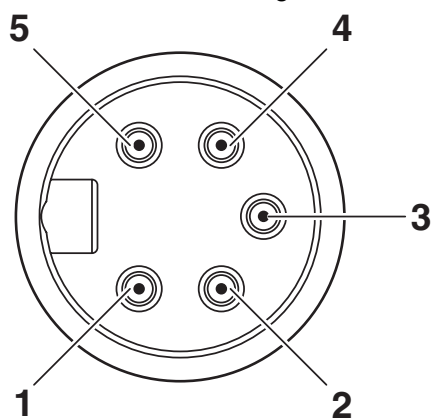
7/8"-16UNF plug, straight

Schematic diagram

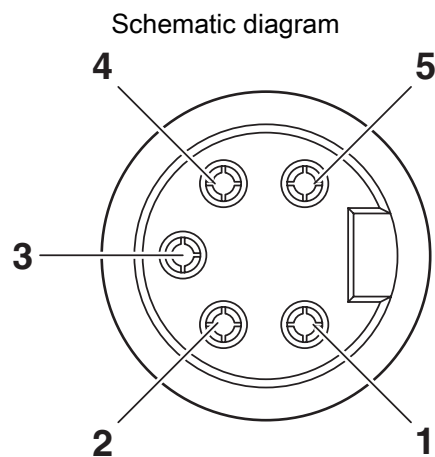


Pin assignment, plug, 7/8"-16UNF, 5-pos., view of male side
