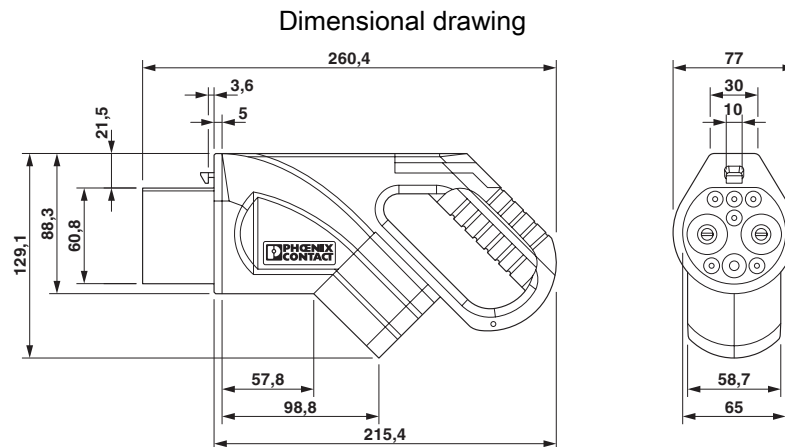

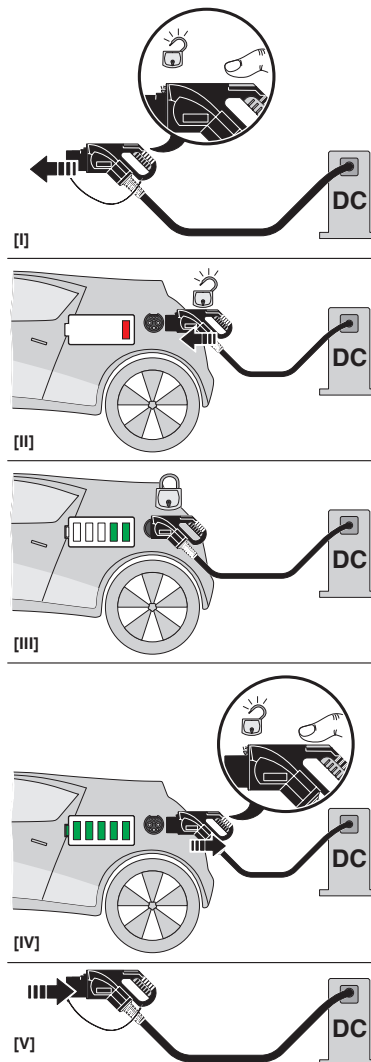

Schematic diagram

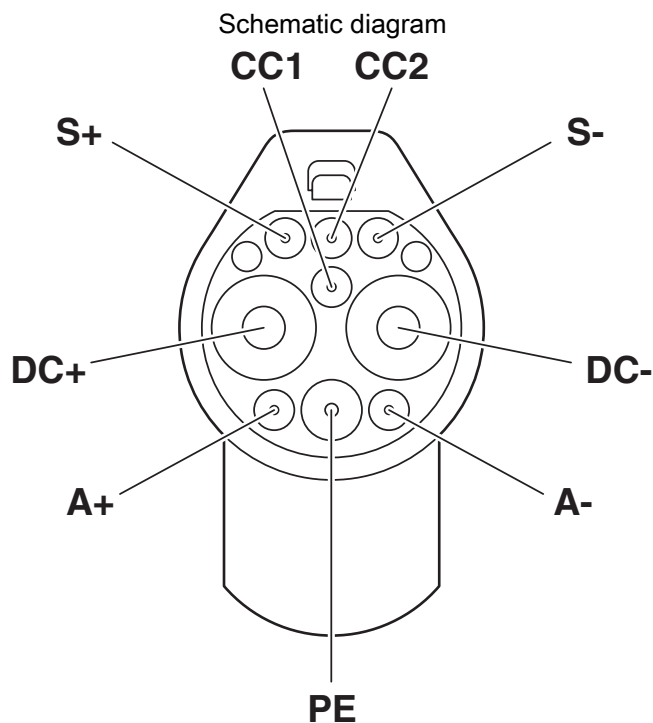

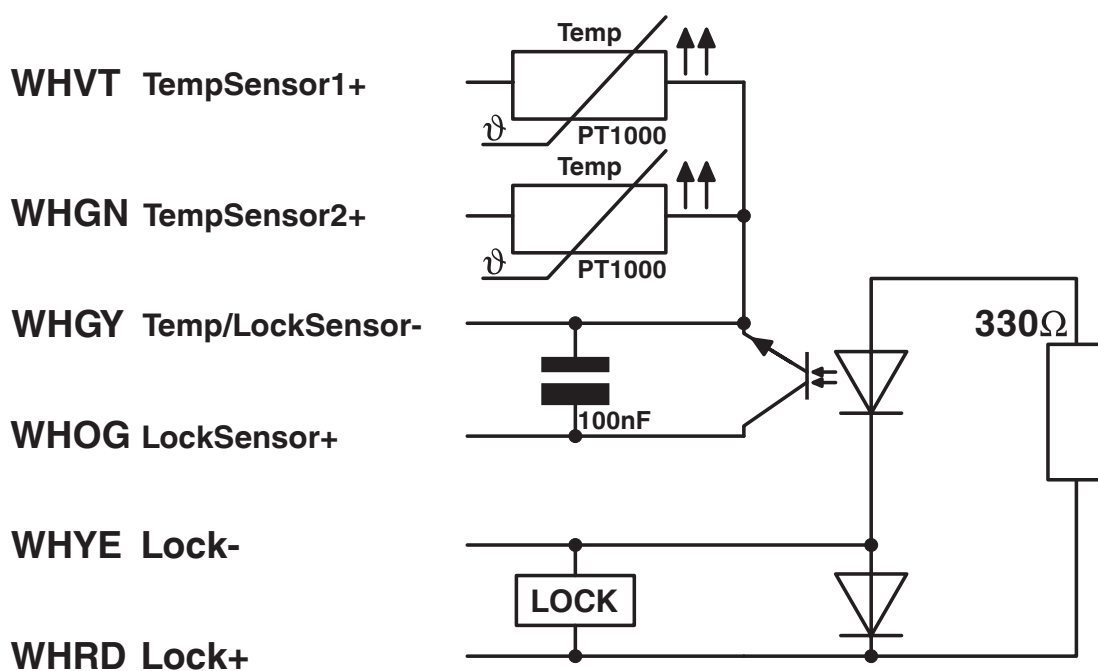
