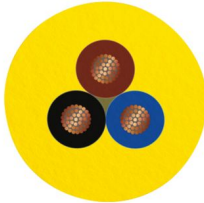

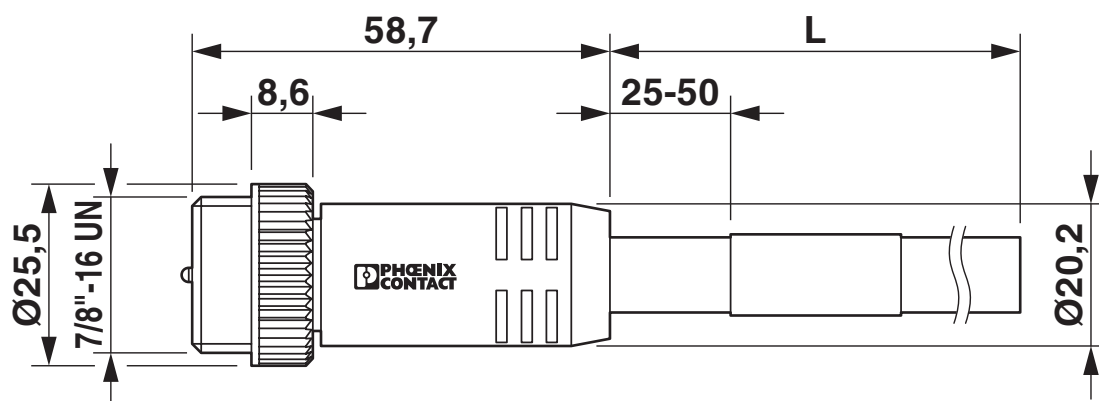

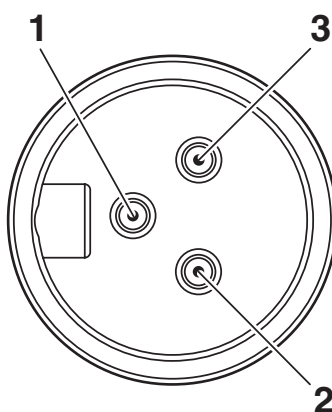

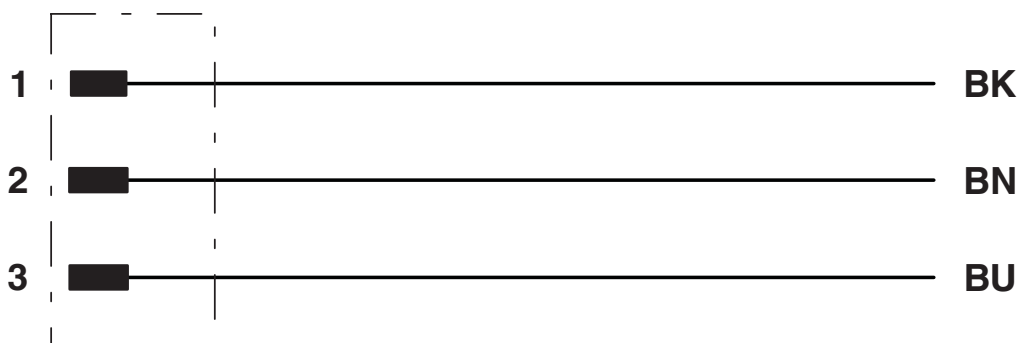
7/8"-16UNF plug, straight
