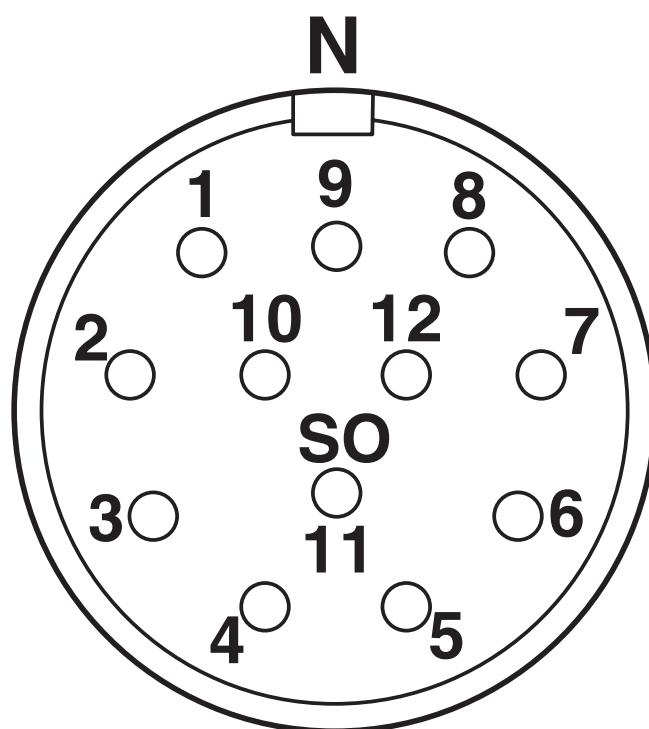

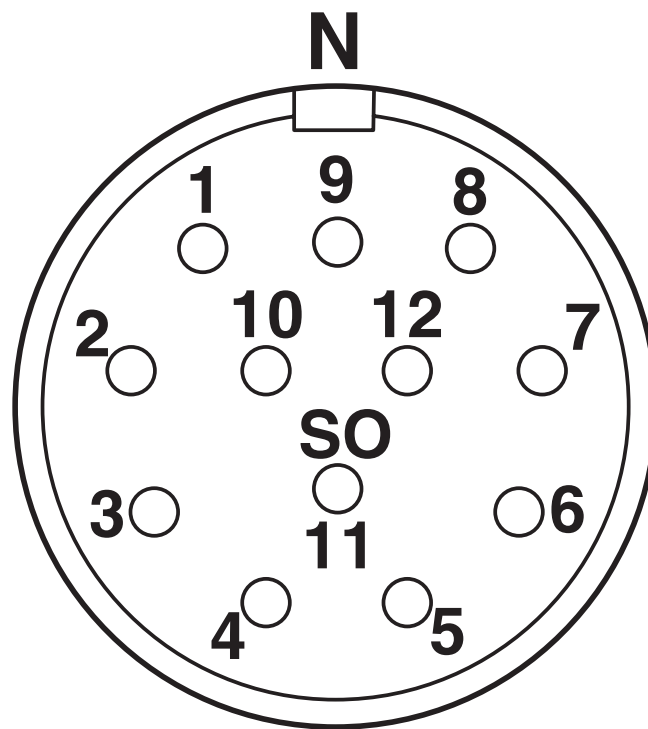


Connector pin assignment
