

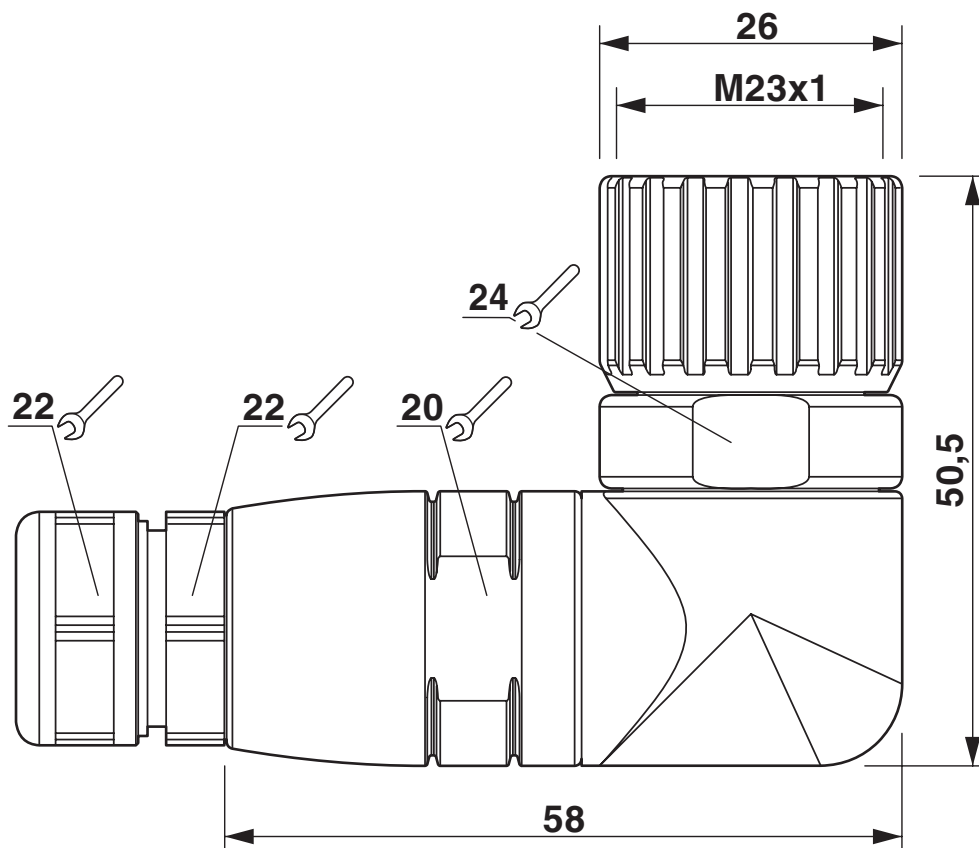

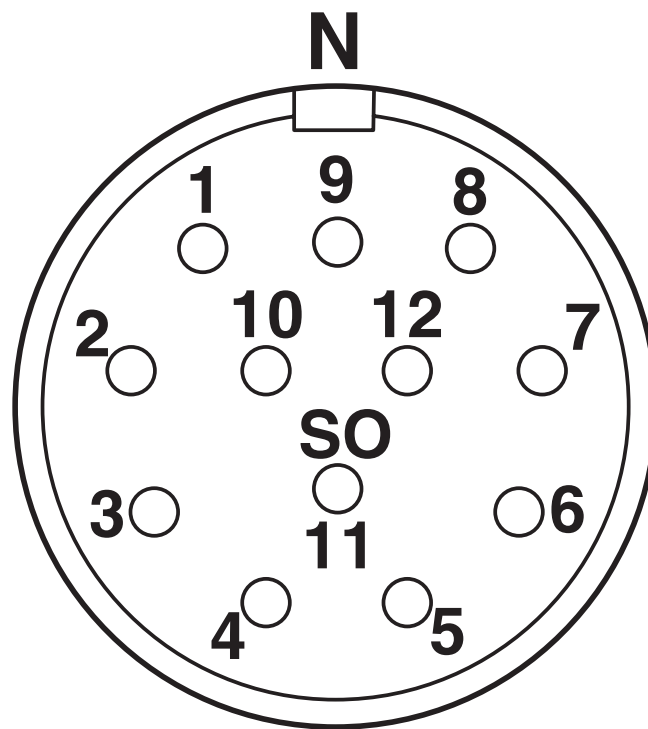

Schematic diagram

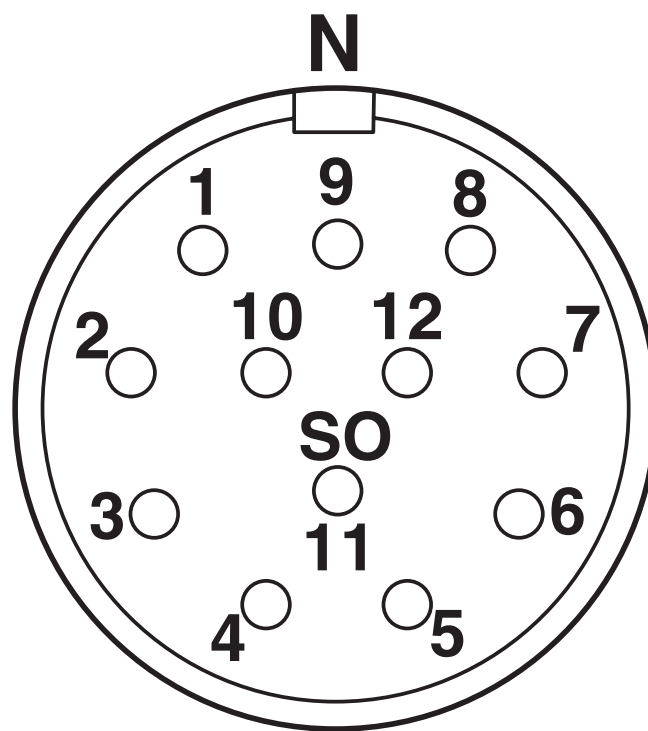


Pin assignment M23 socket, 12-pos., female side view

Schematic diagram

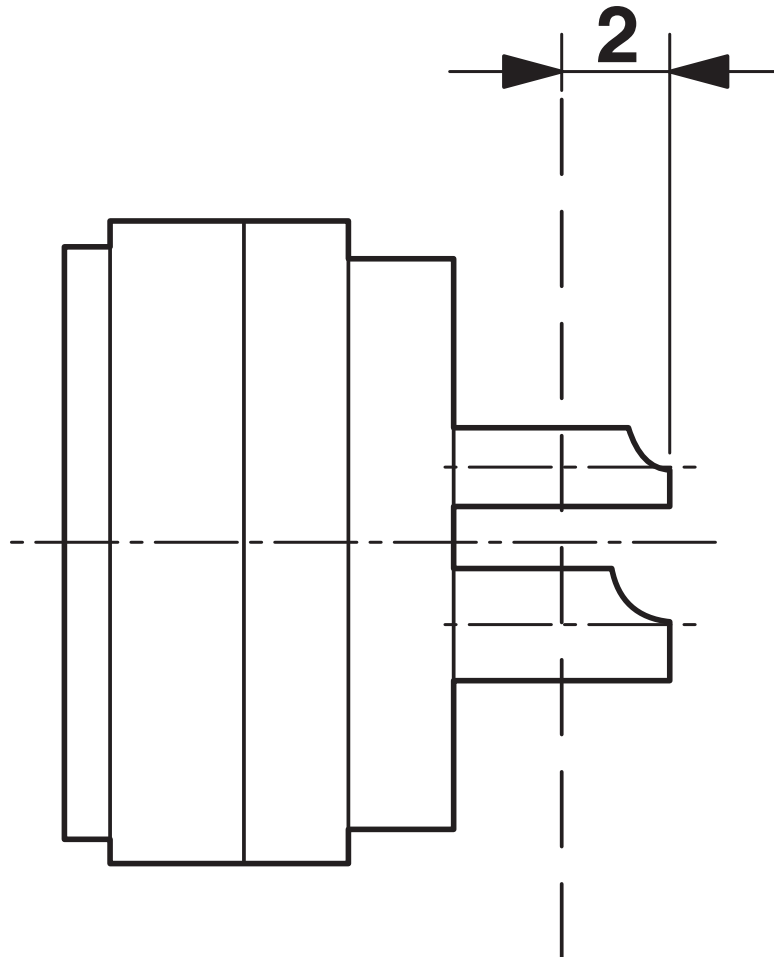


Connector pin assignment
