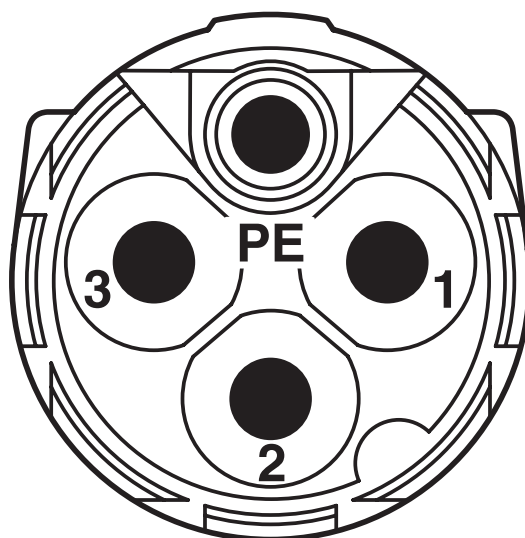

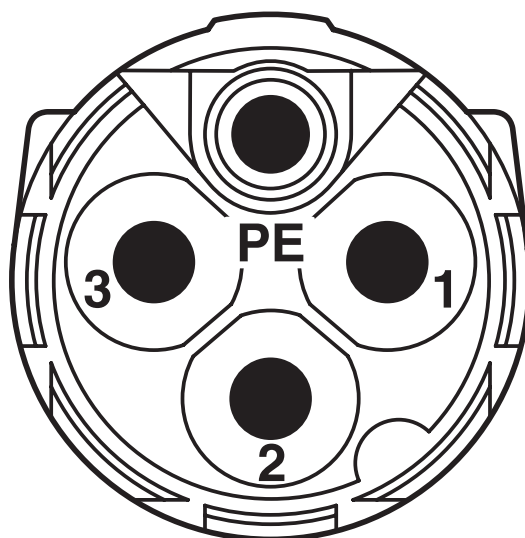

Schematic diagram

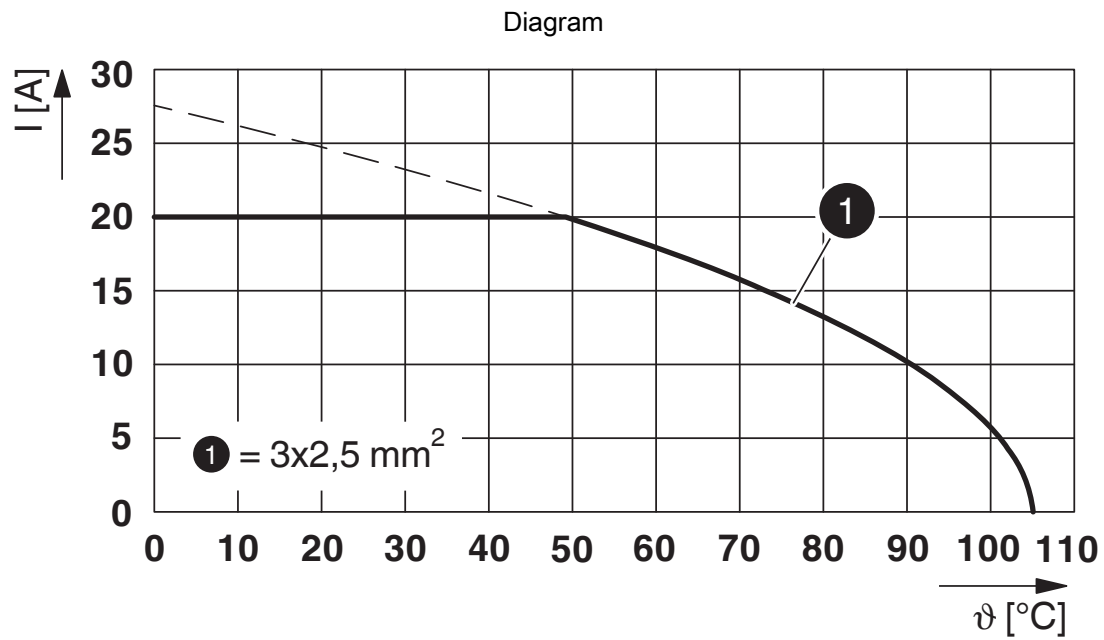
