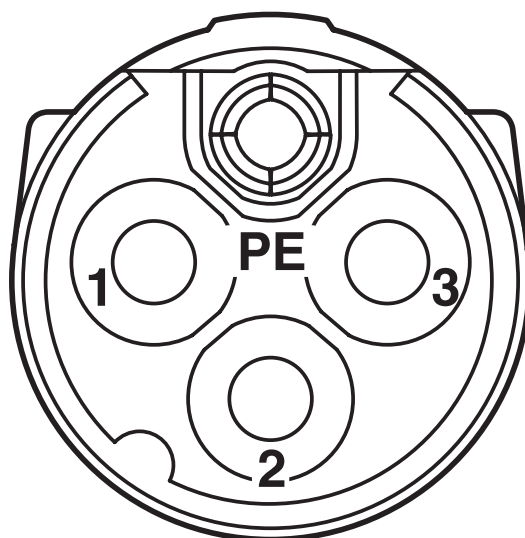

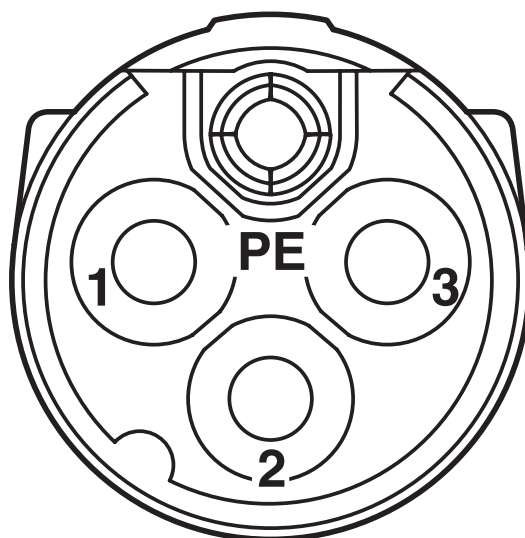

Schematic diagram

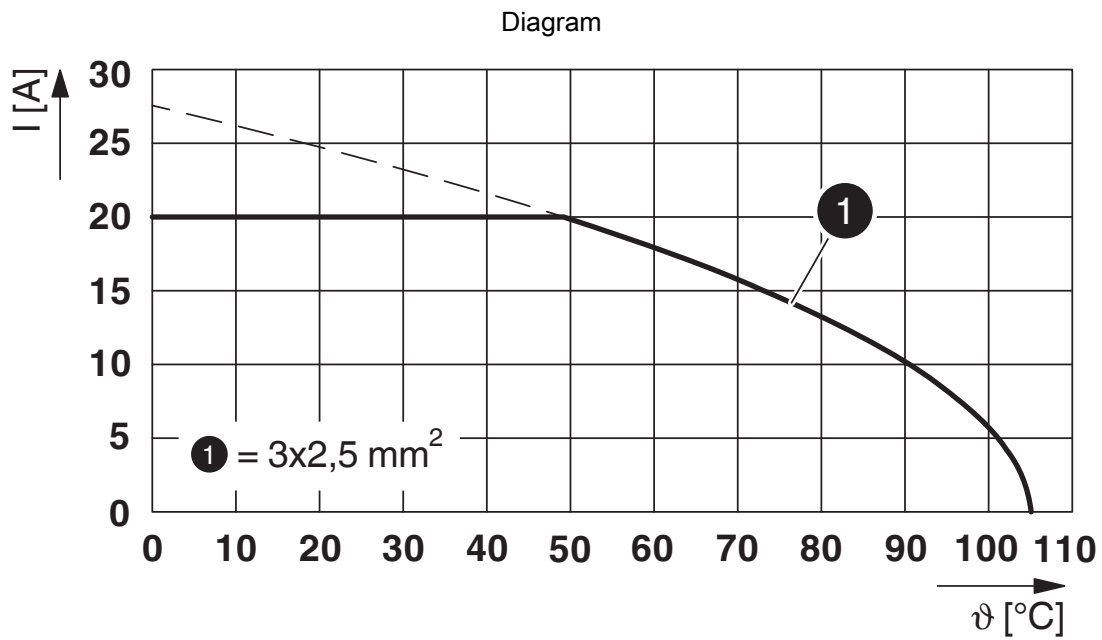
