Connector pin assignment

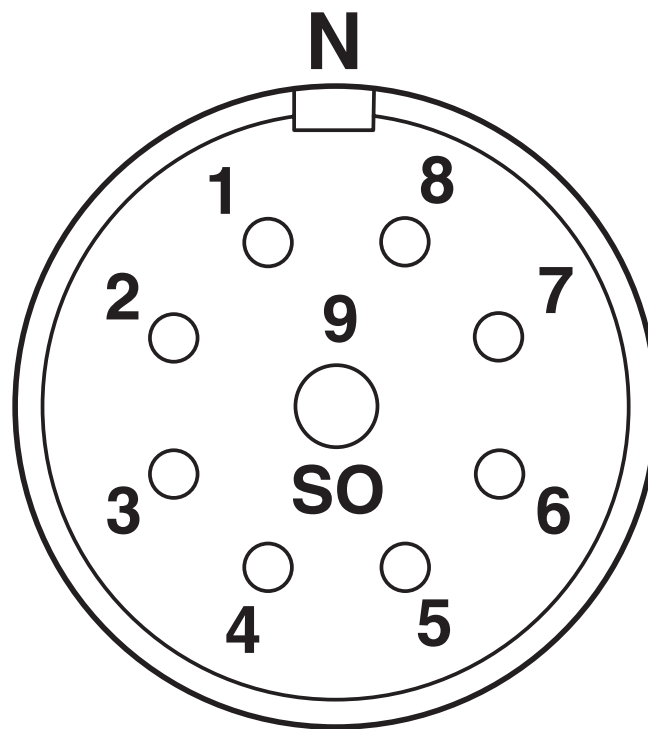
