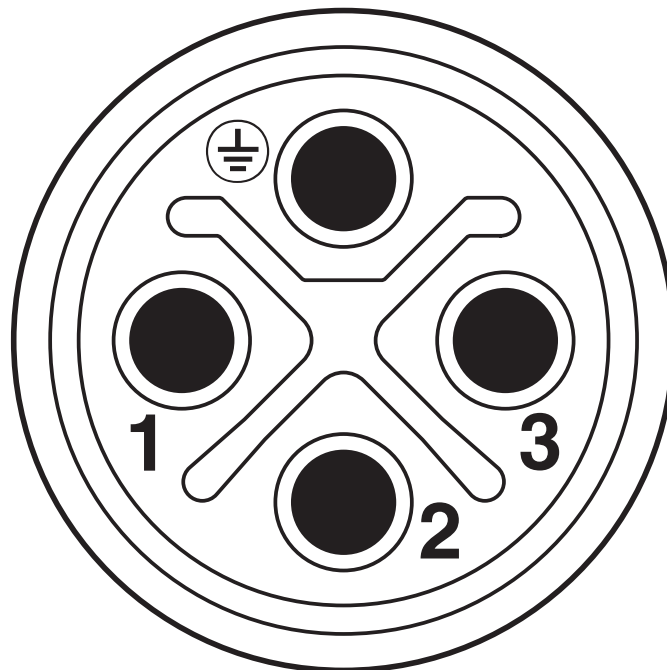

Schematic diagram

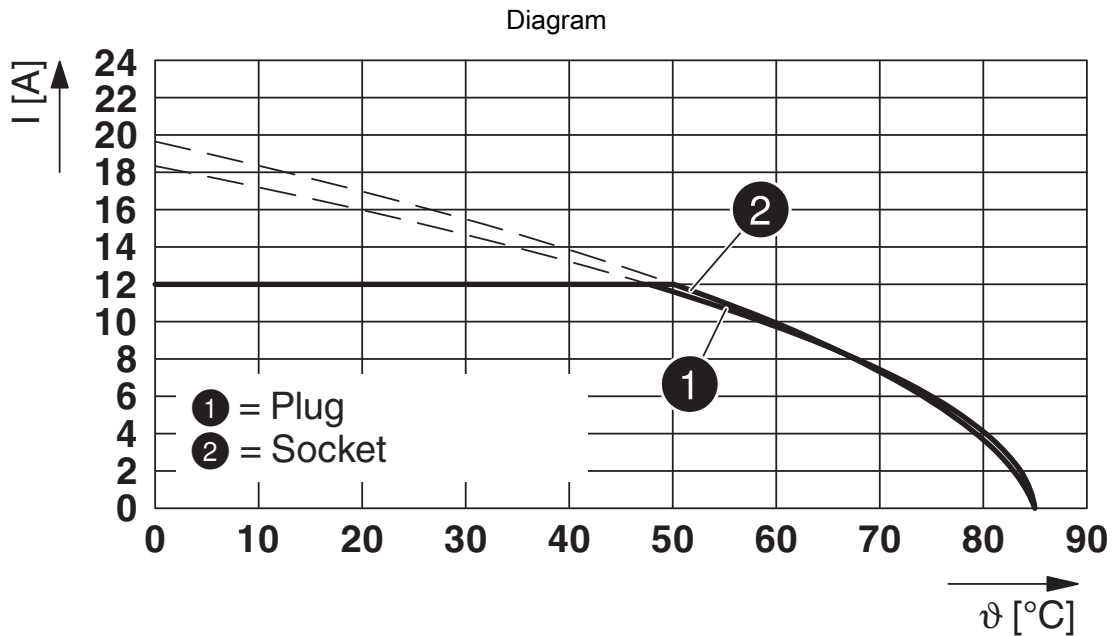


M12 plug pin assignment, 4-pos., S-coded, plug side view

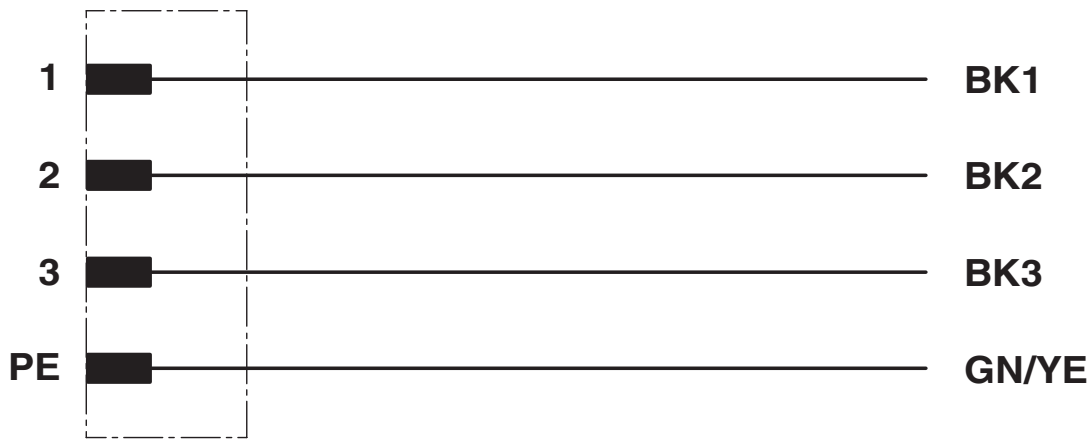
