

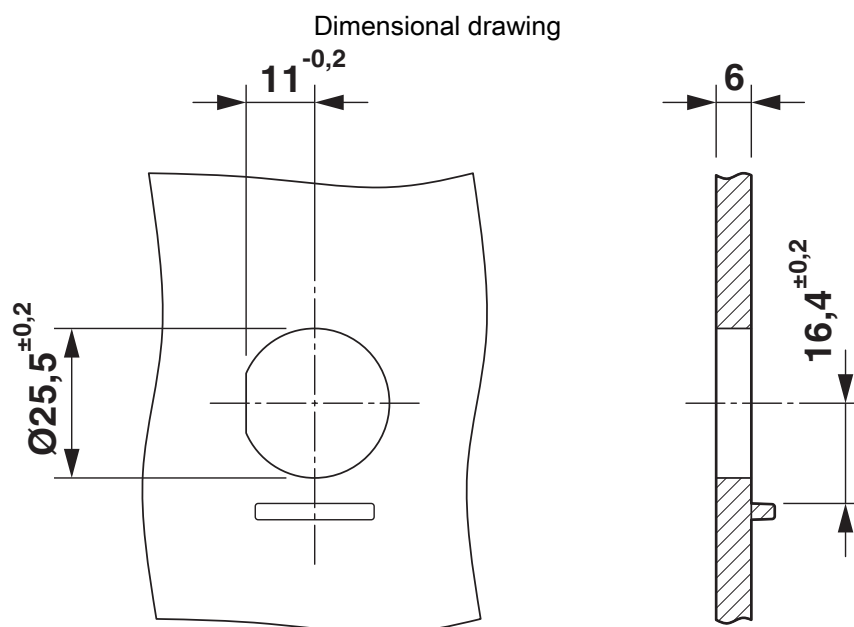

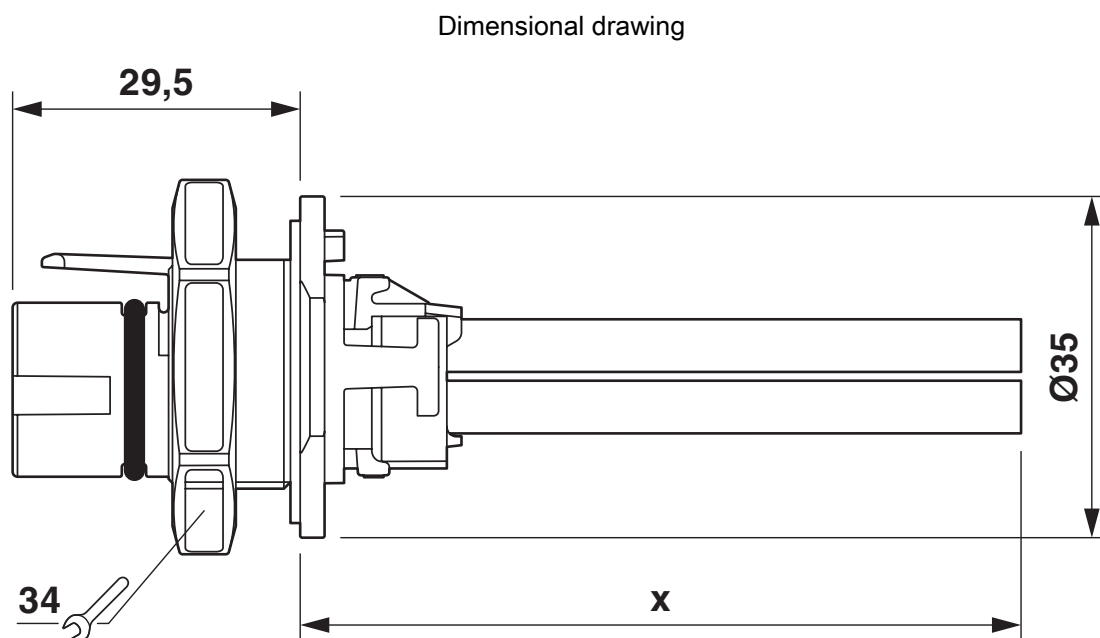

Housing cutout



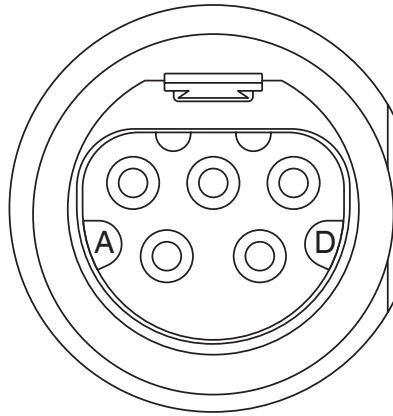
