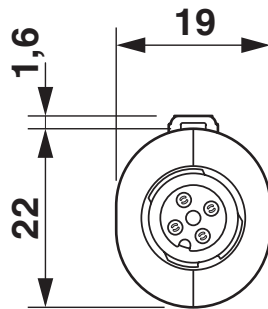

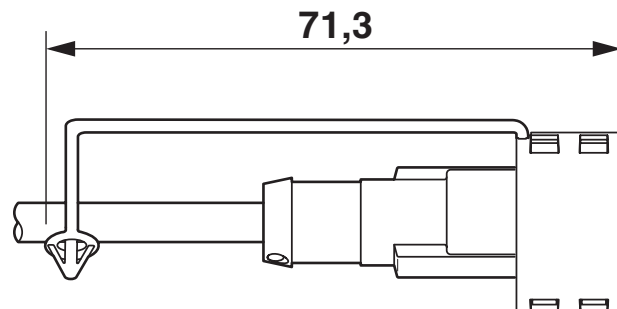

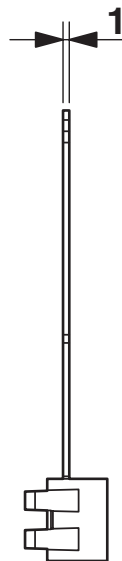
Dimensional drawing



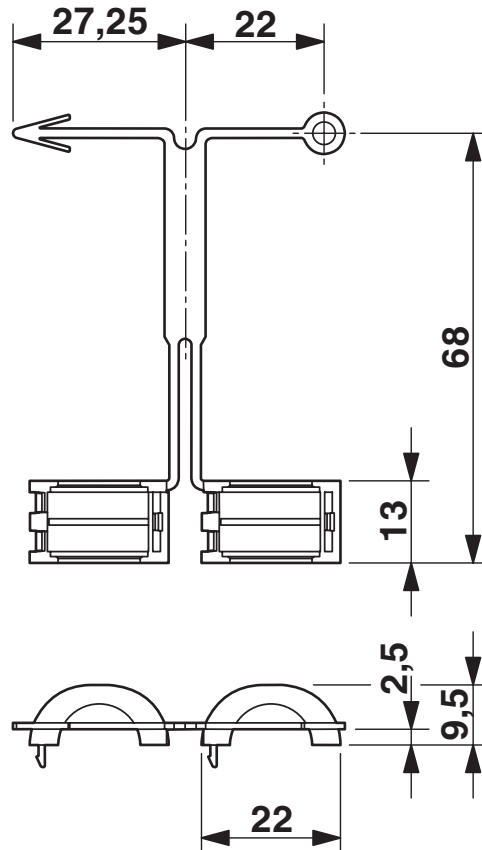
EXCLIP mounted socket

EXCLIP socket

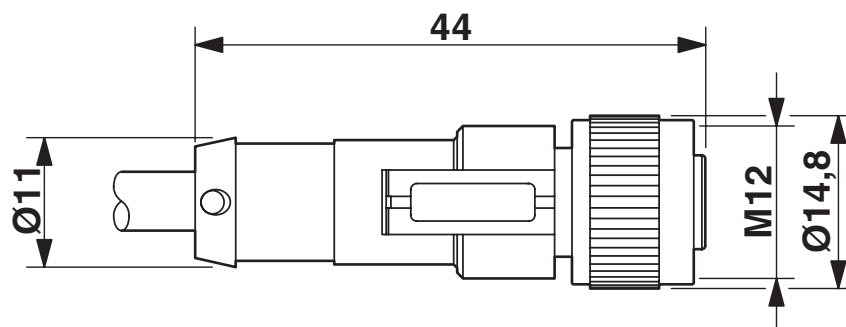

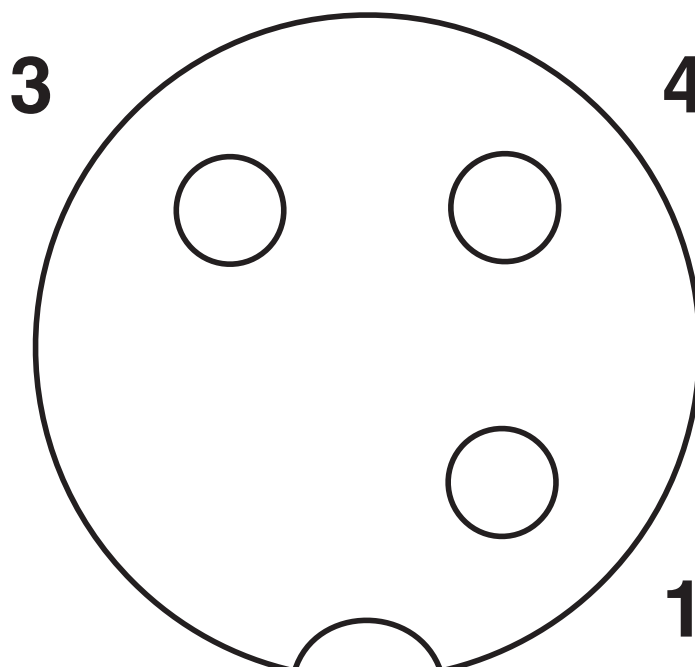

Pin assignment M12 socket, 3-pos., A-coded, view female side

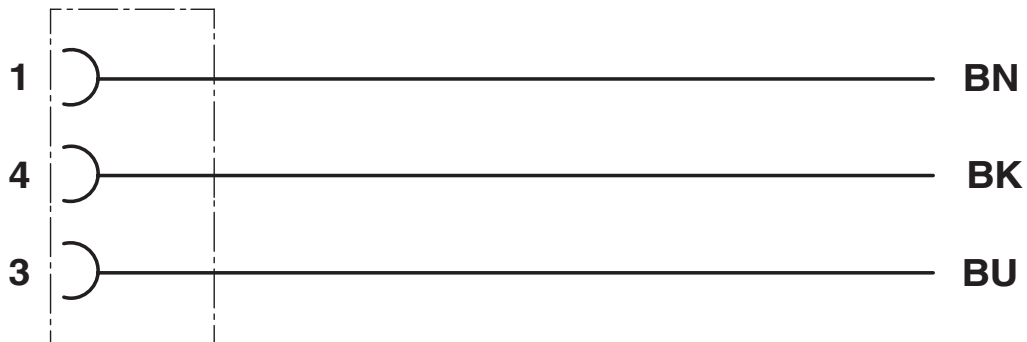
