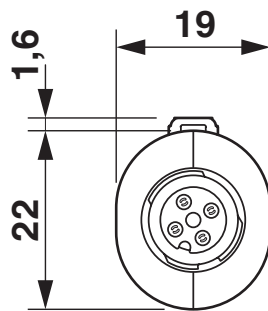

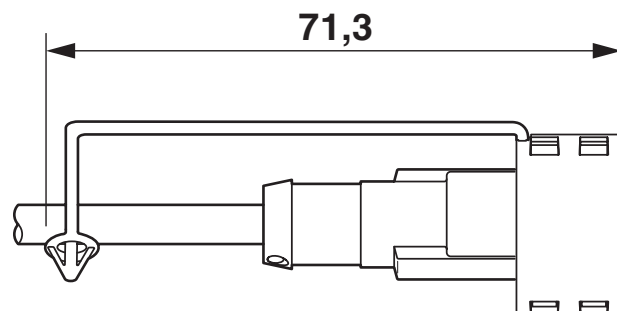

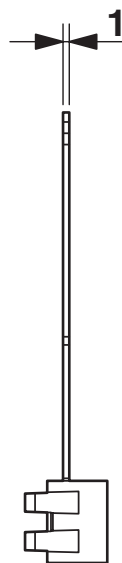
Dimensional drawing



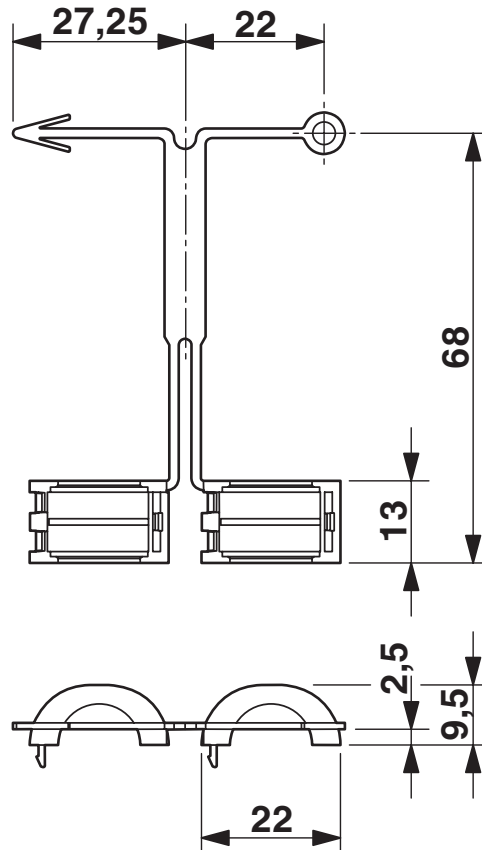
EXCLIP mounted socket

EXCLIP socket

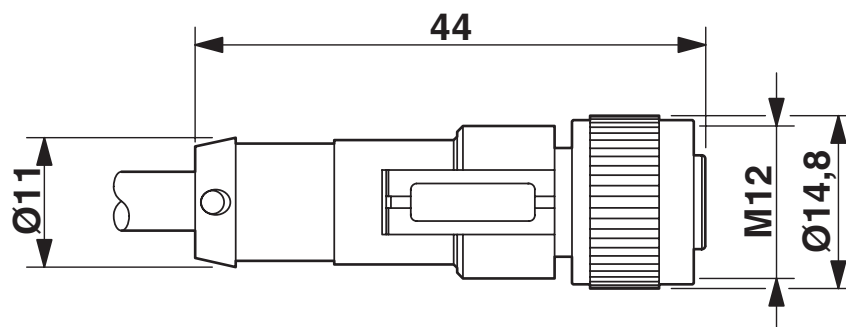

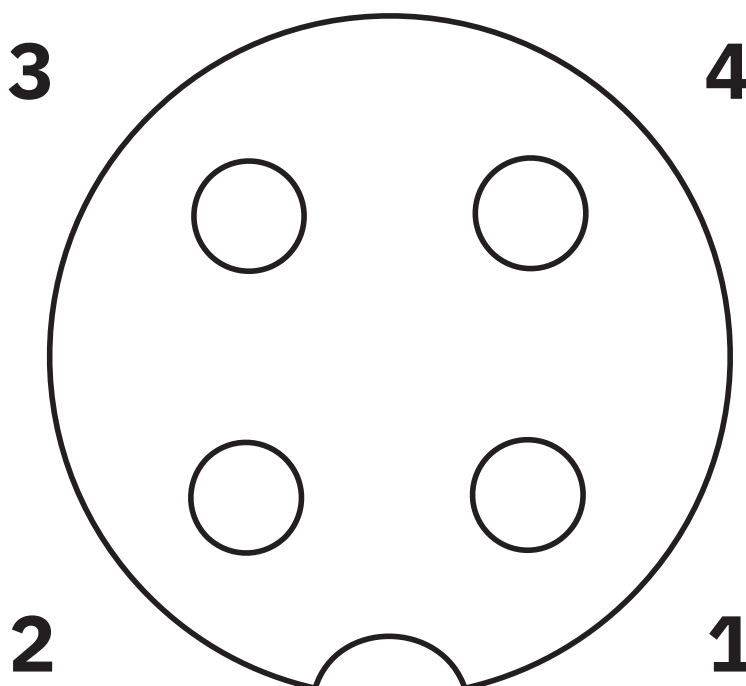
