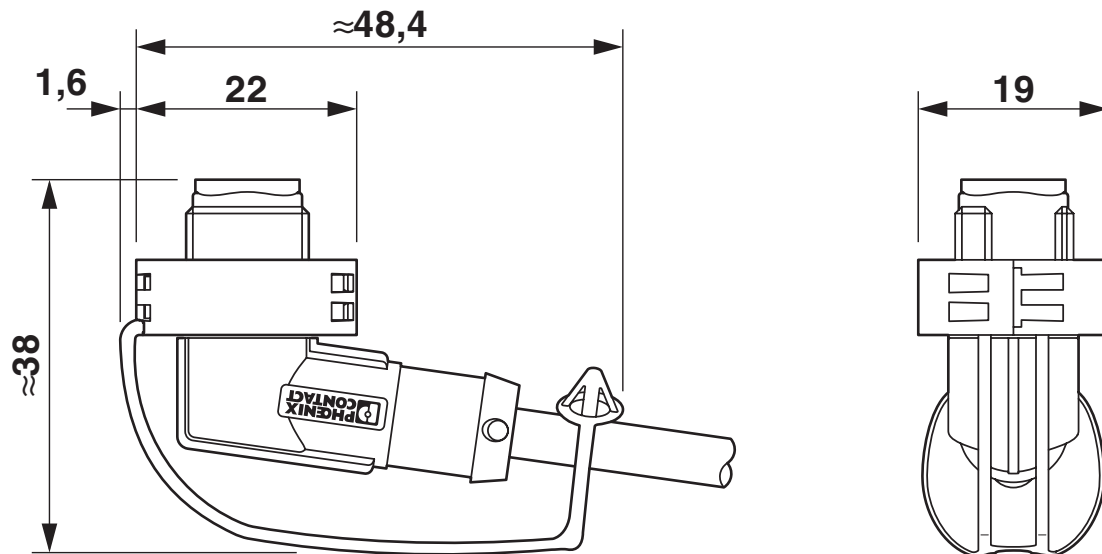

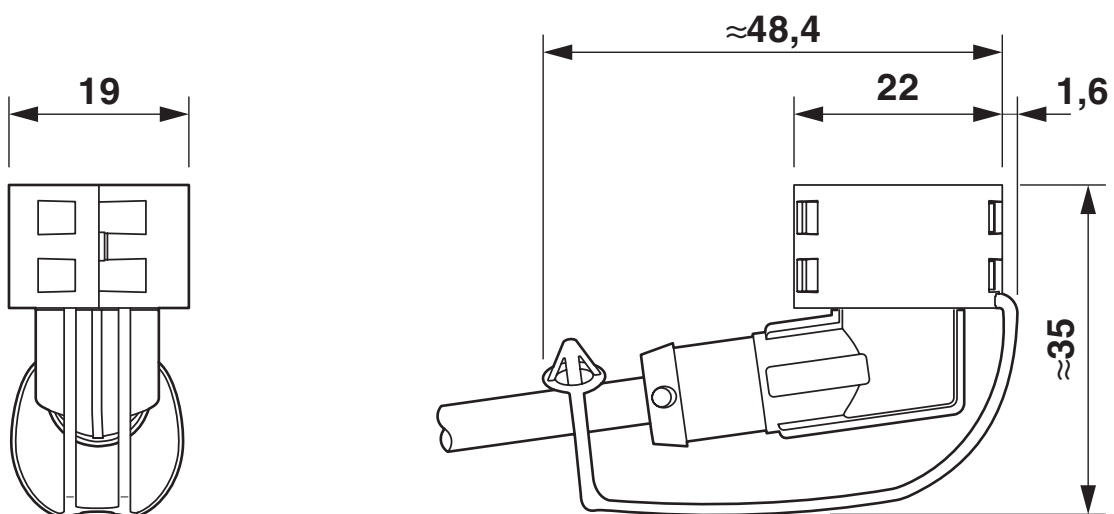

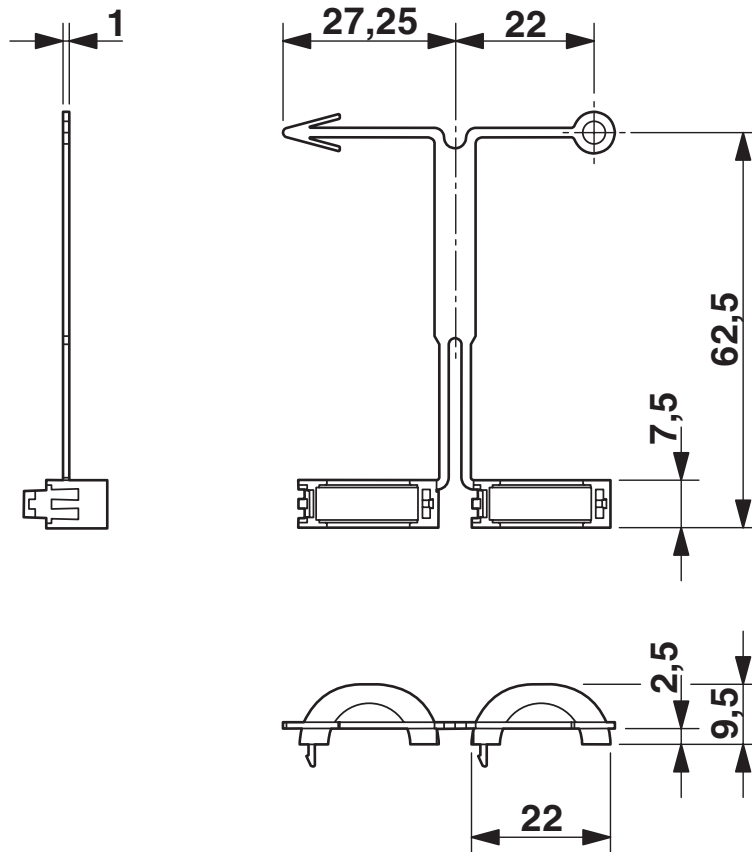
EXCLIP mounted socket

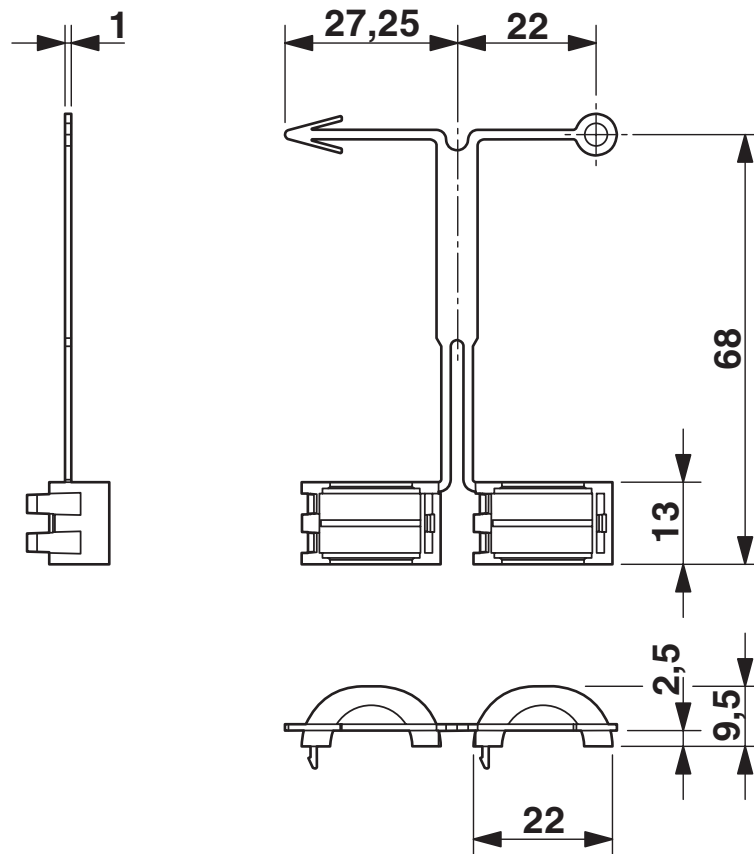
EXCLIP plug

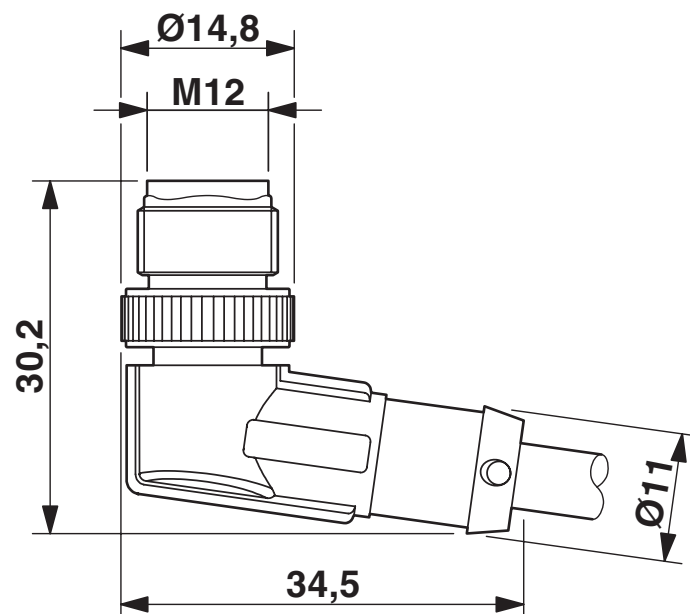

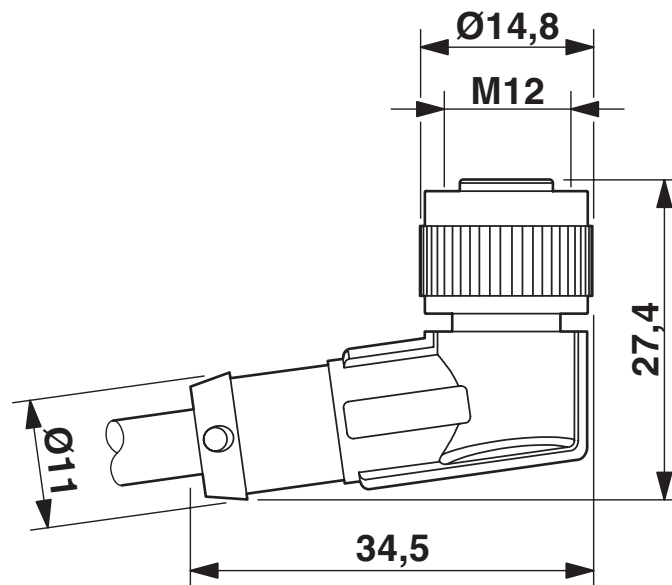
M12 x 1 male plug, angled

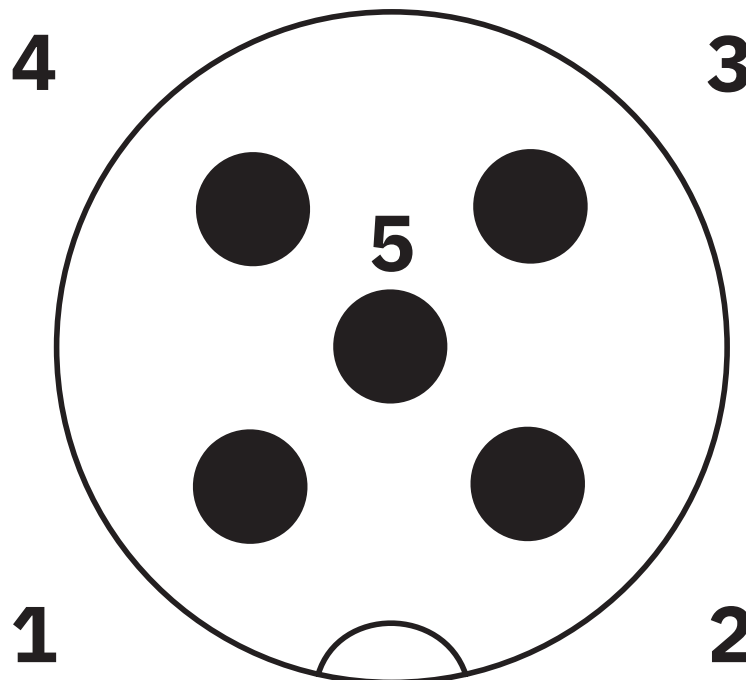

Pin assignment M12 male connector, 5-pos., A-coded, male side

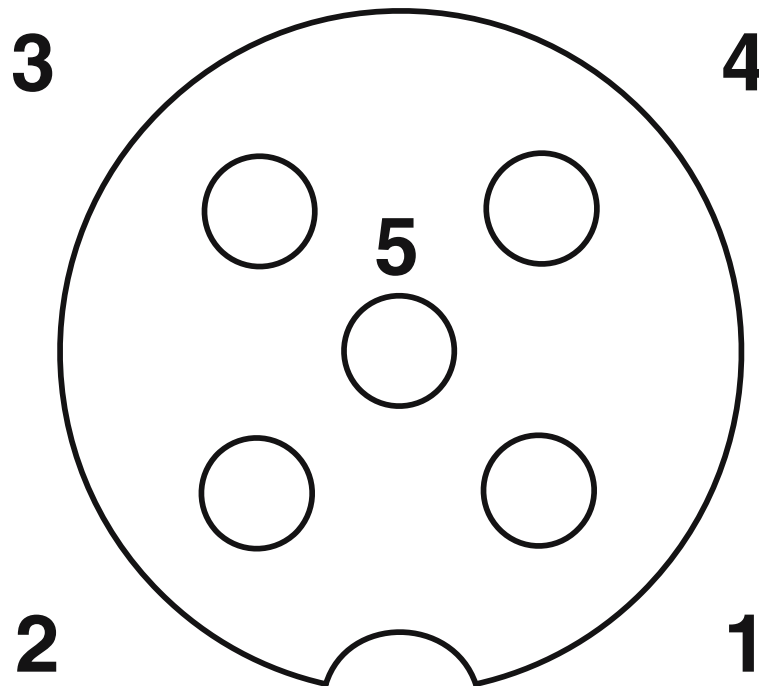
