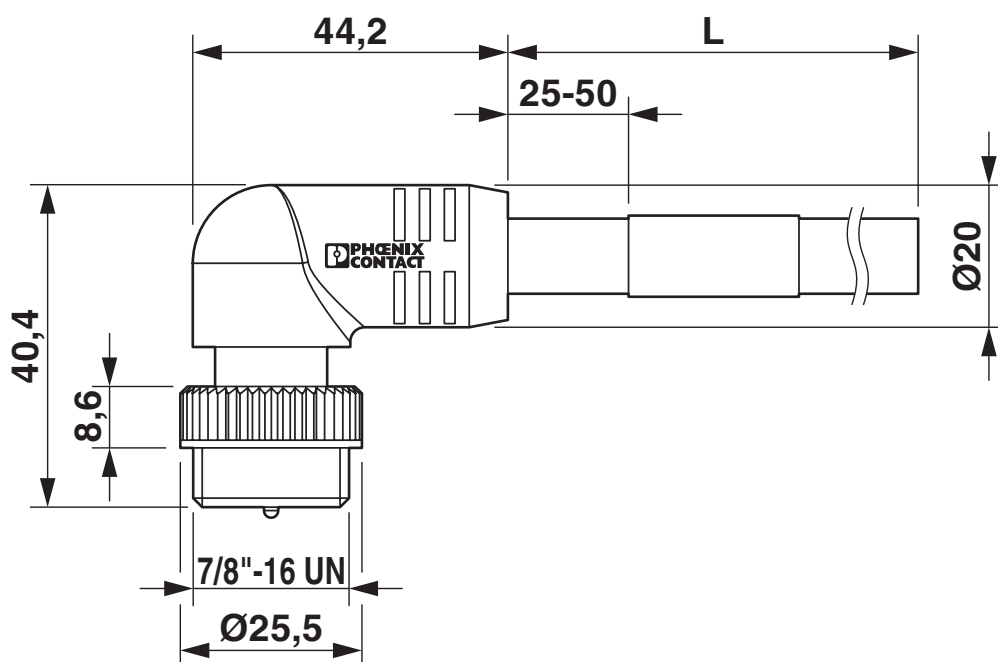

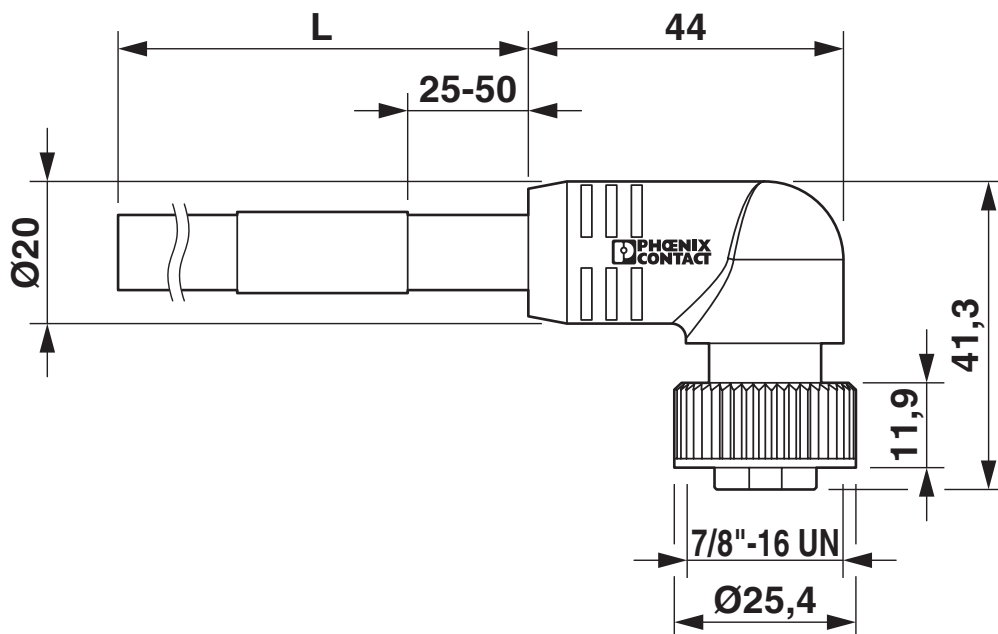

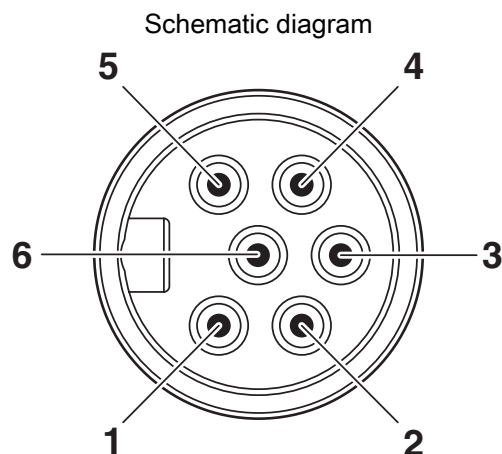


7/8"-16UNF socket, angled

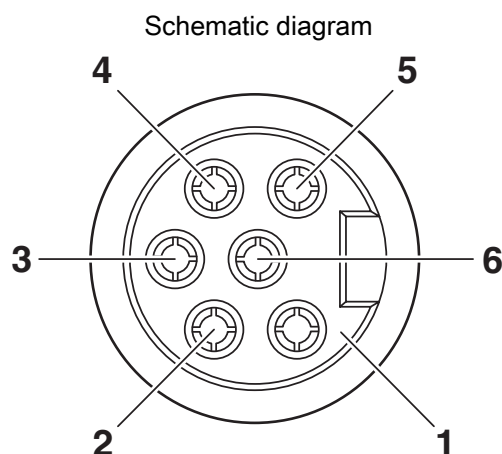

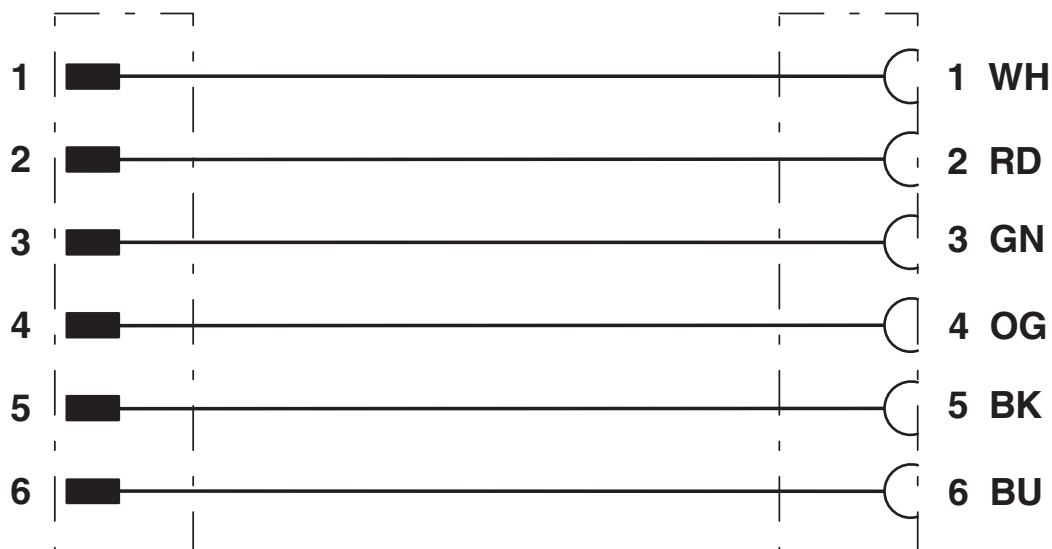


Pin assignment, plug, 7/8"-16UNF, 6-pos., view of male side
