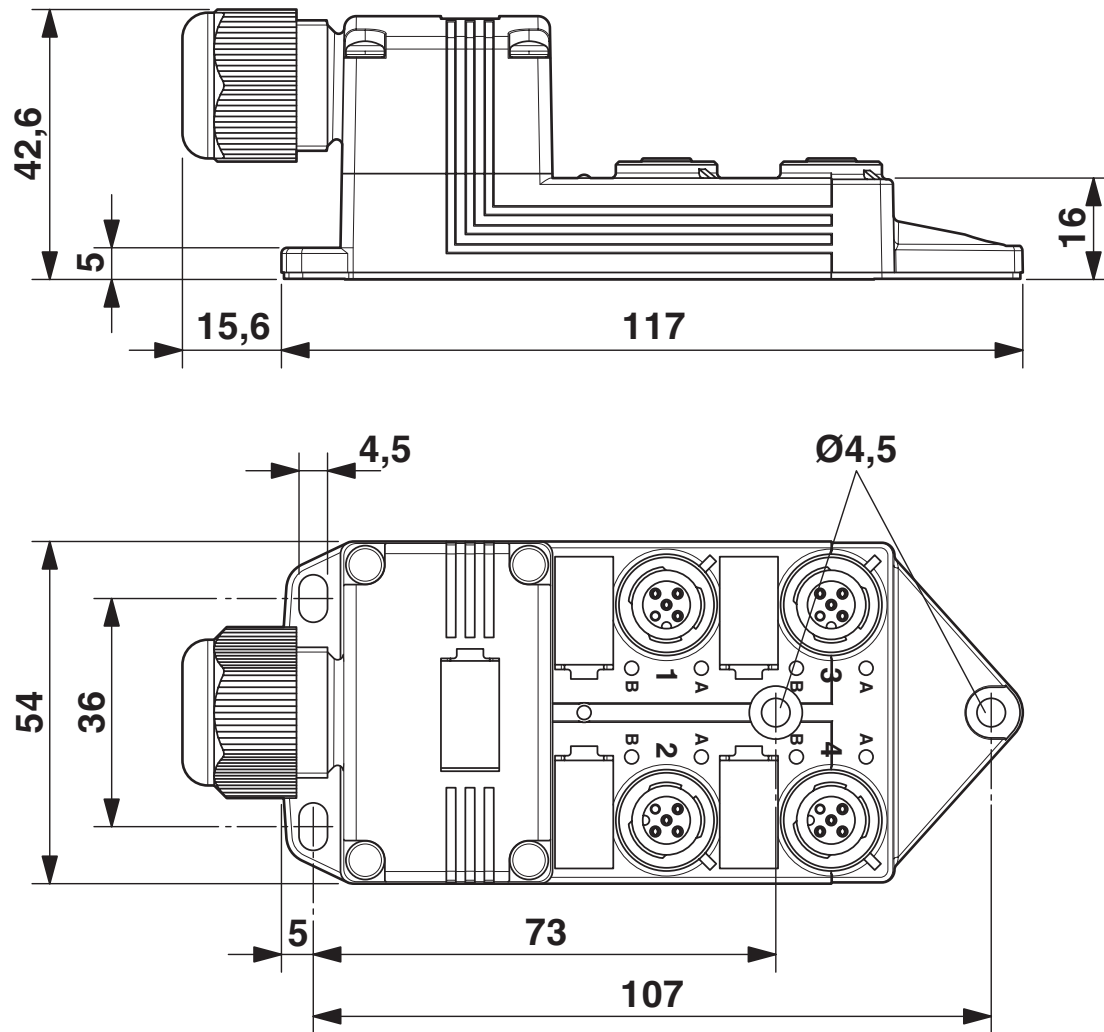

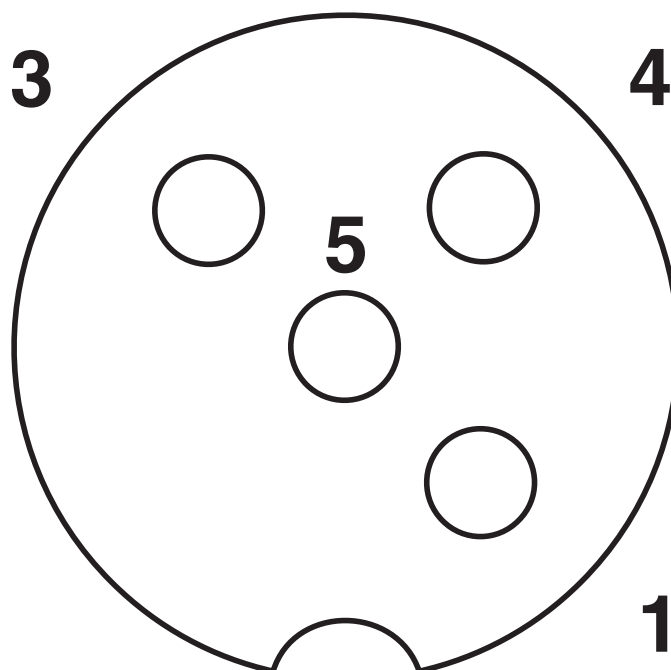

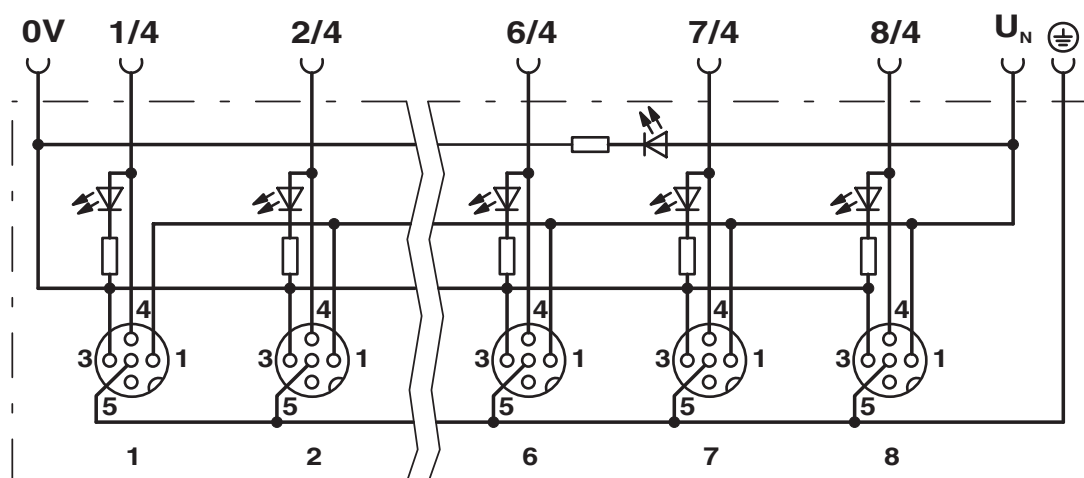


Schematic diagram
