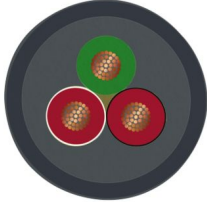

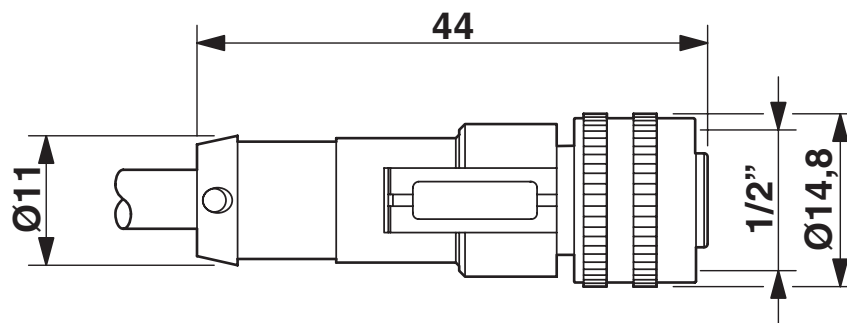

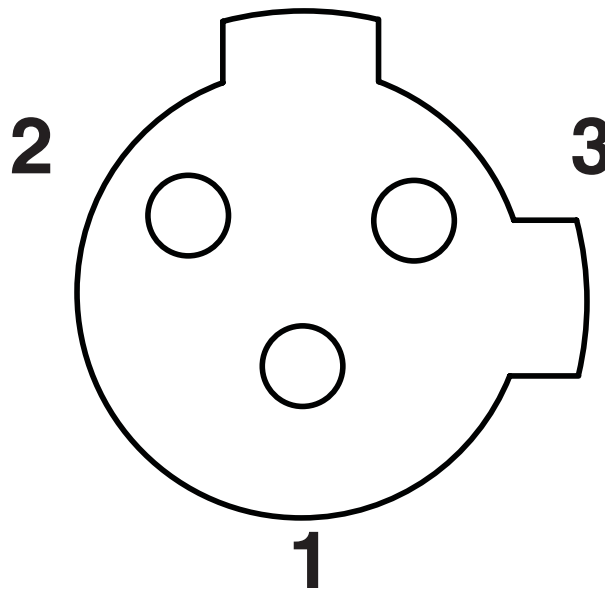

Pin assignment 1/2"-20UNF socket, 2-pos., view female side

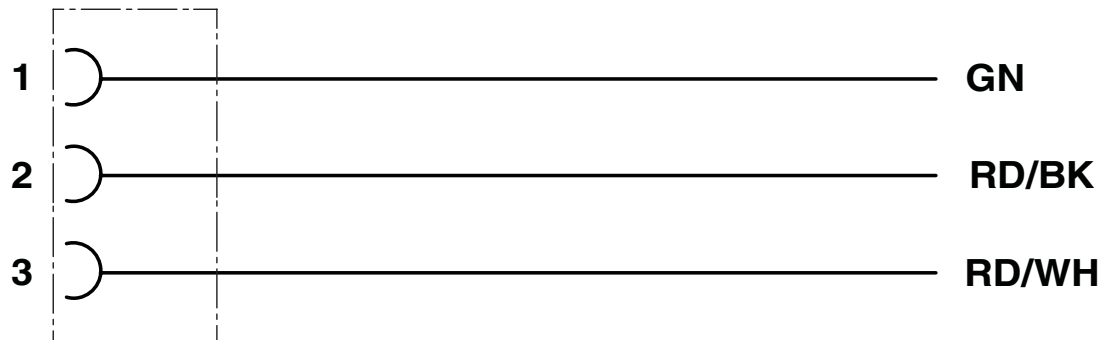
