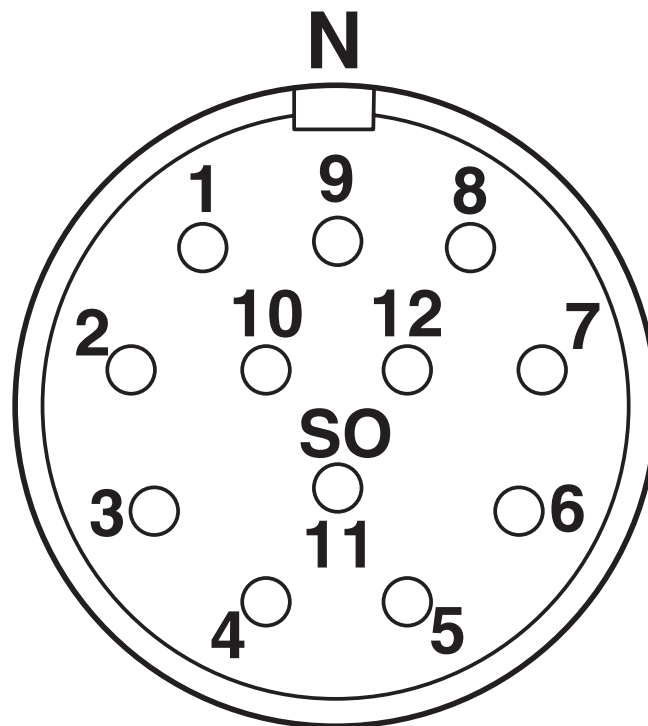

Connector pin assignment

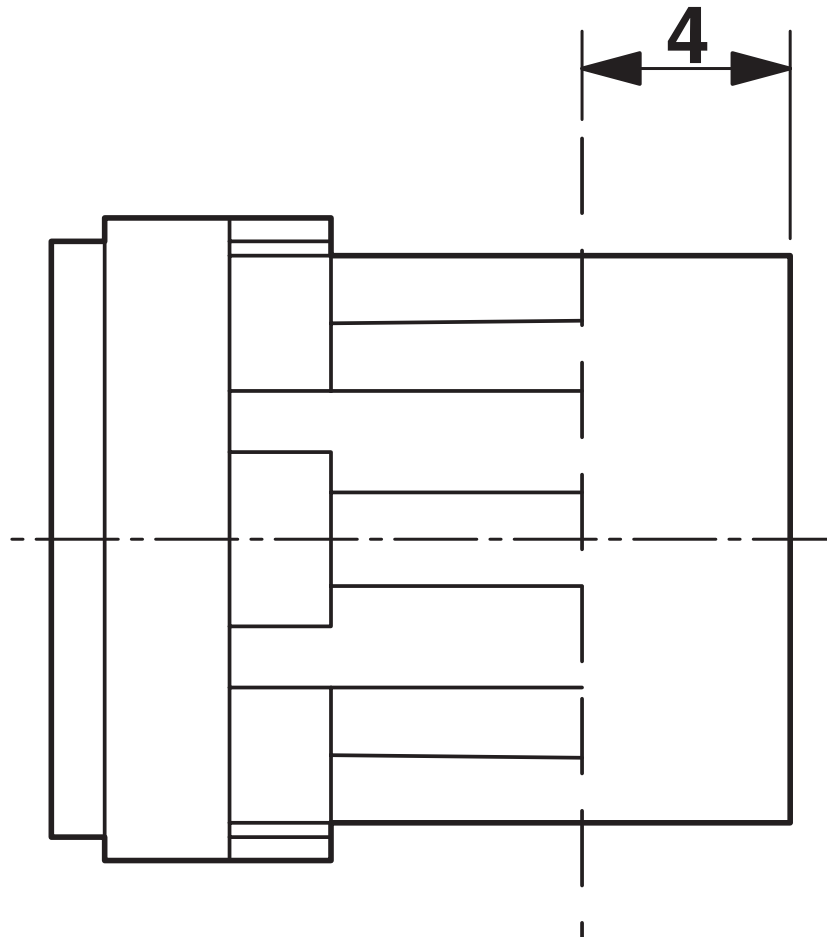
