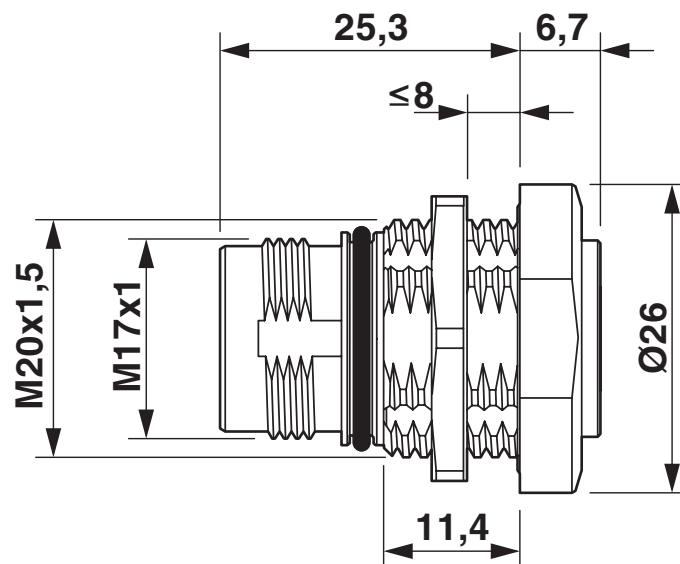

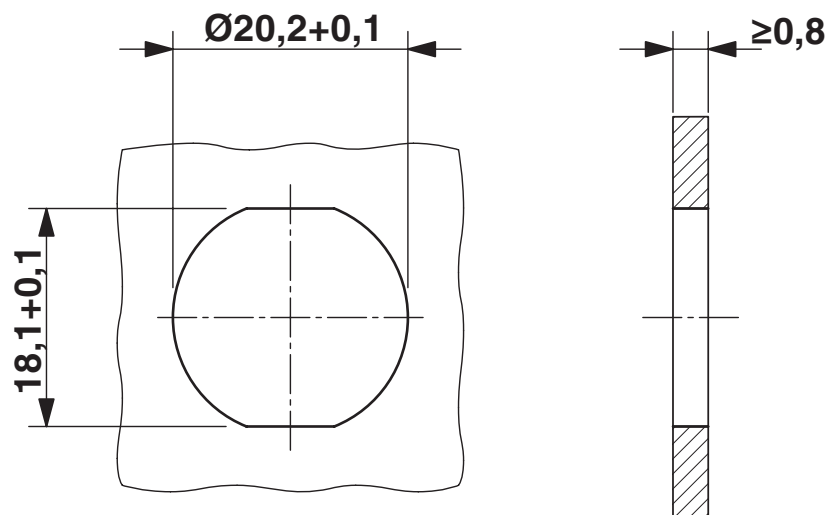

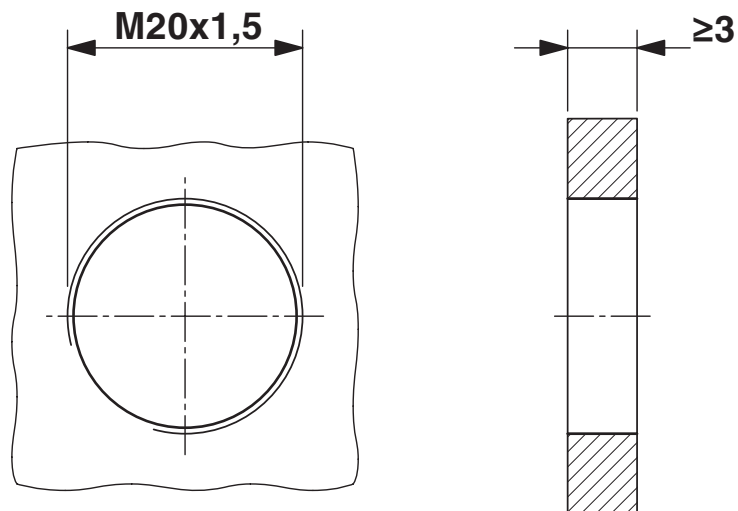
Installation dimensions: mounting with anti-rotation protection and locking nut

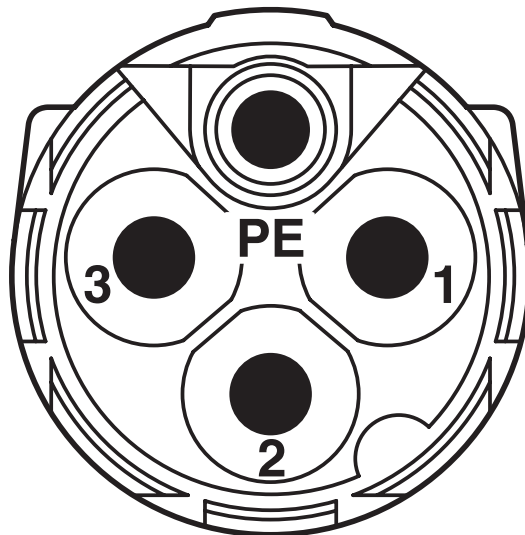

Installation dimensions: mounting with thread

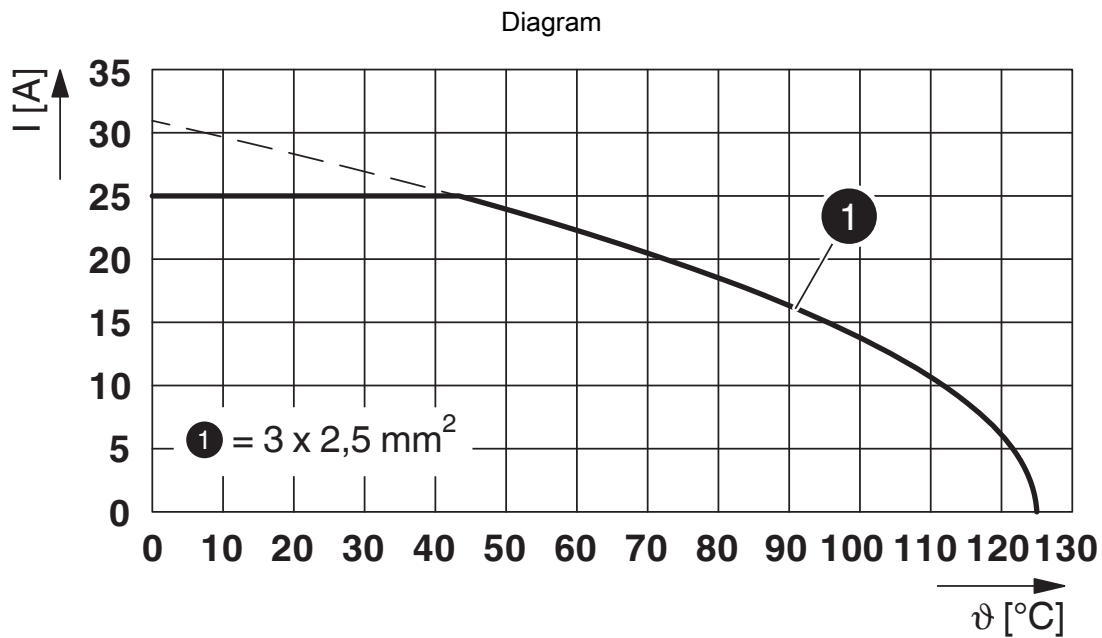
Schematic diagram
