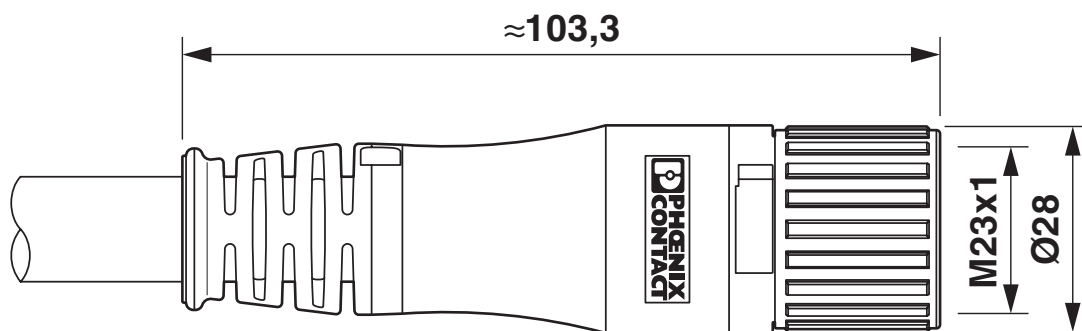

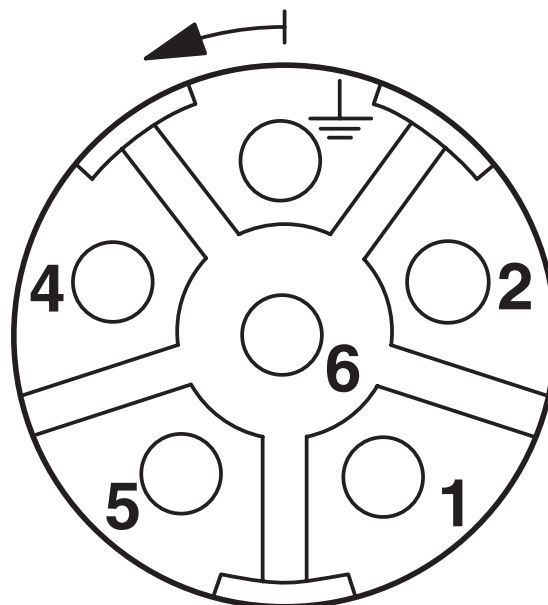

Schematic diagram



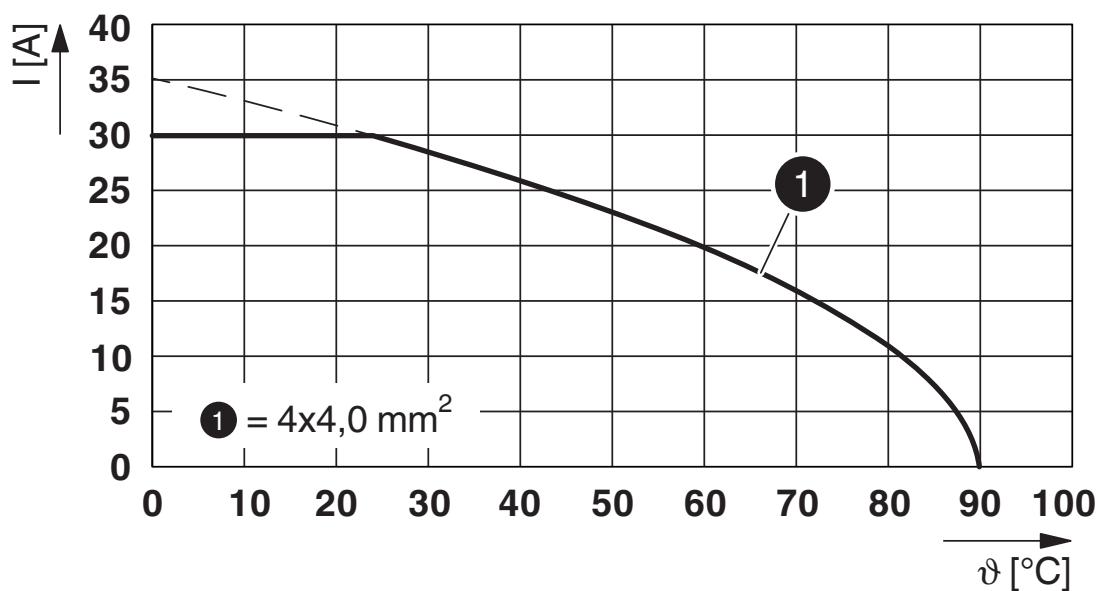

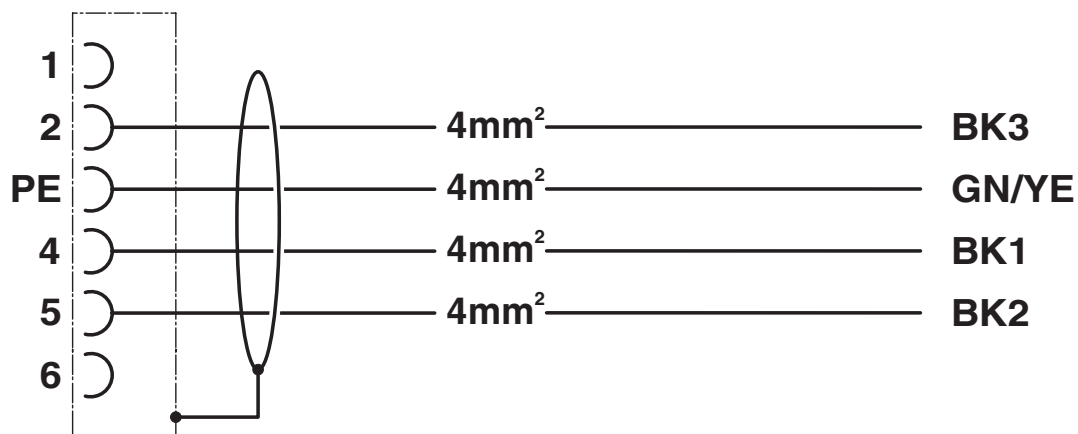
