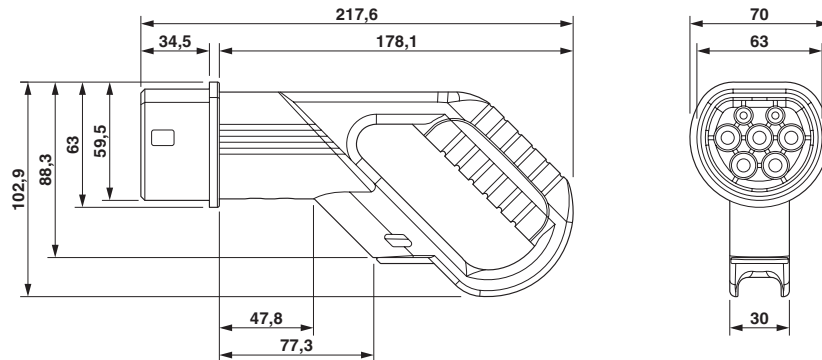

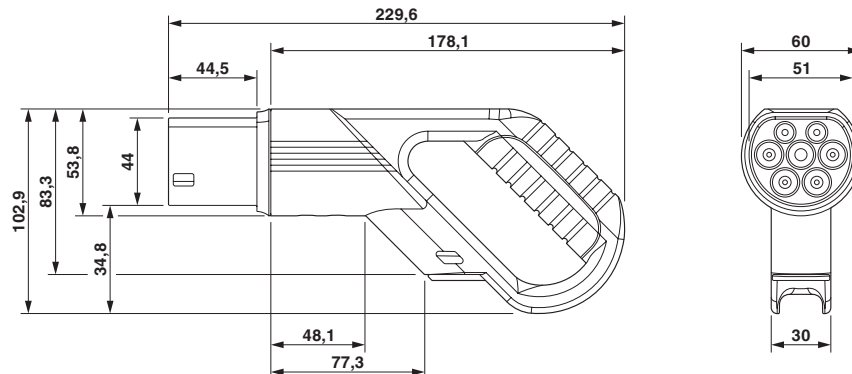

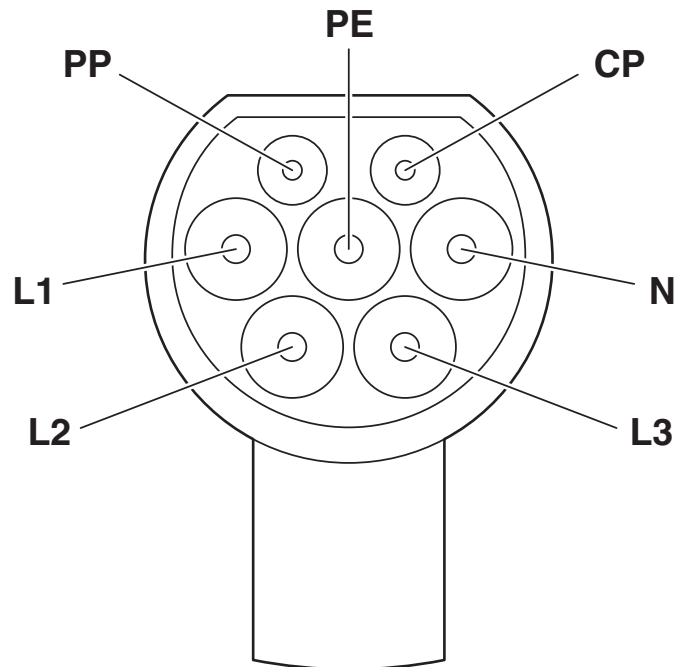
Infrastructure plug

Connection diagram



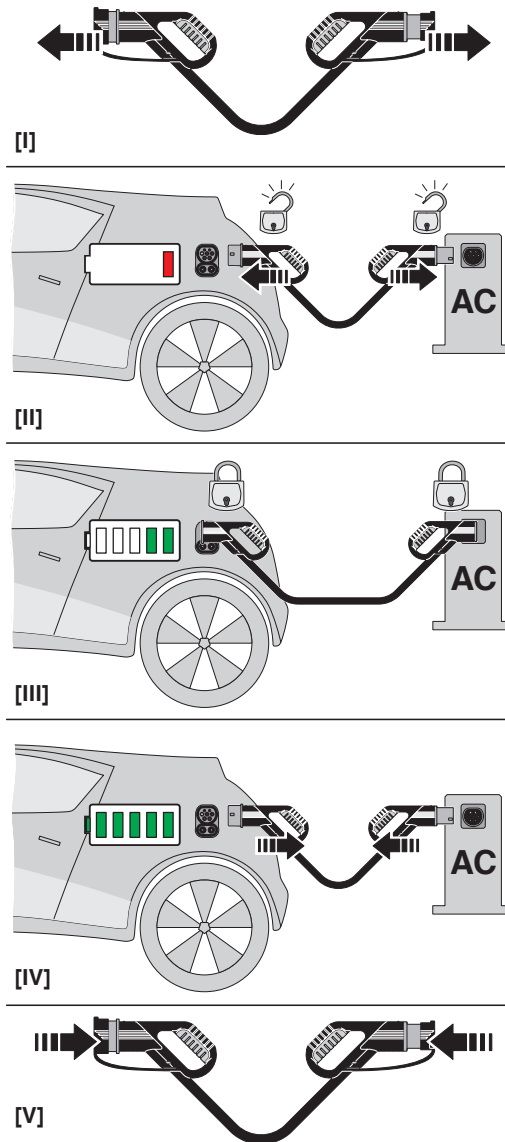
Pin assignment of Infrastructure Plug

Schematic diagram



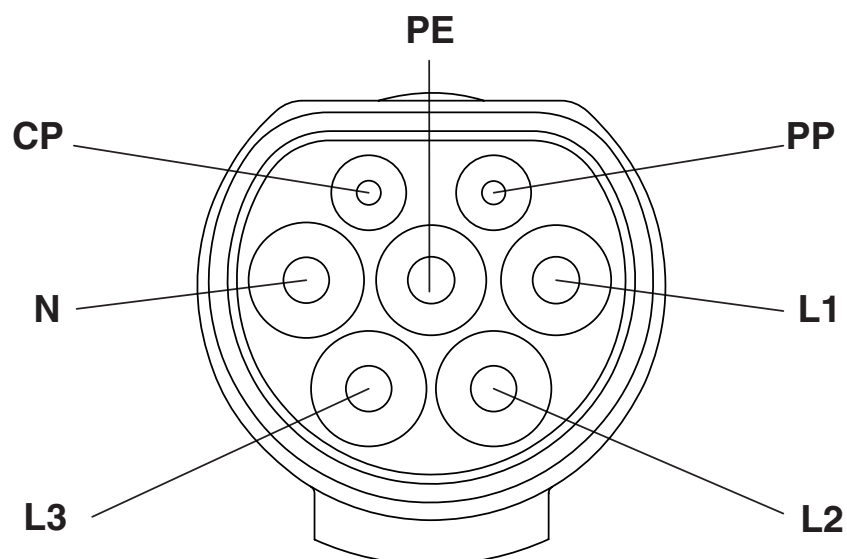
