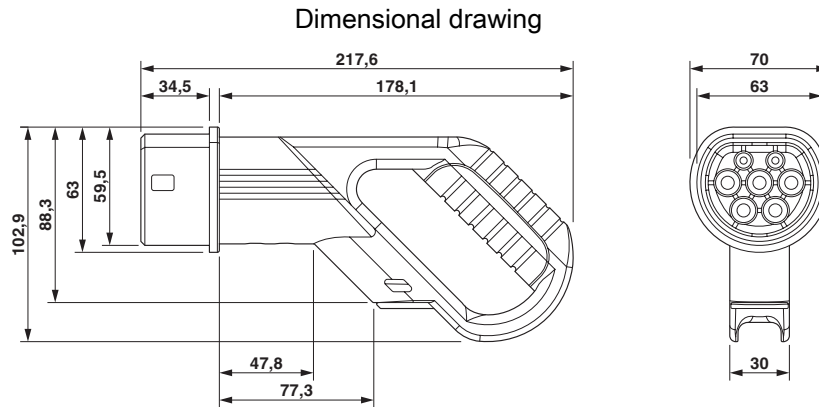

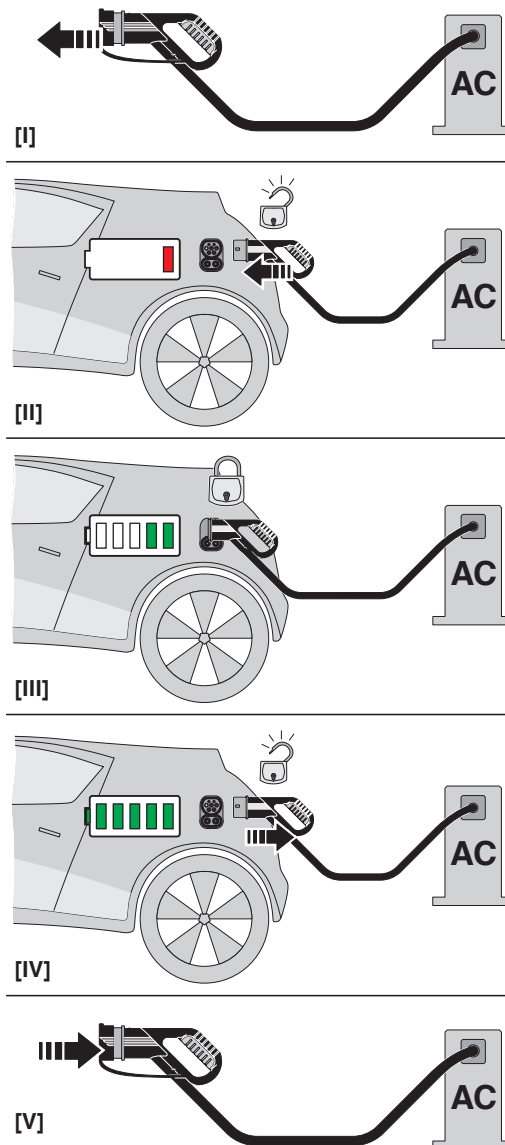

Schematic diagram



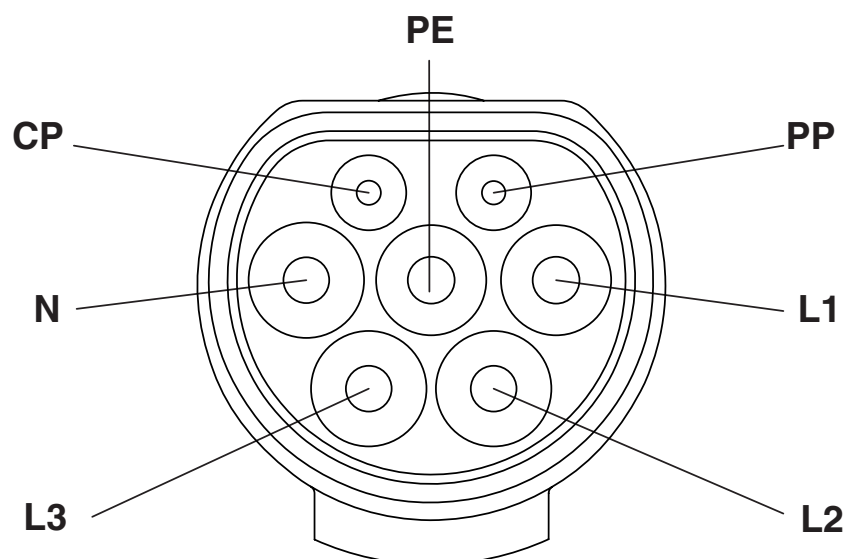
