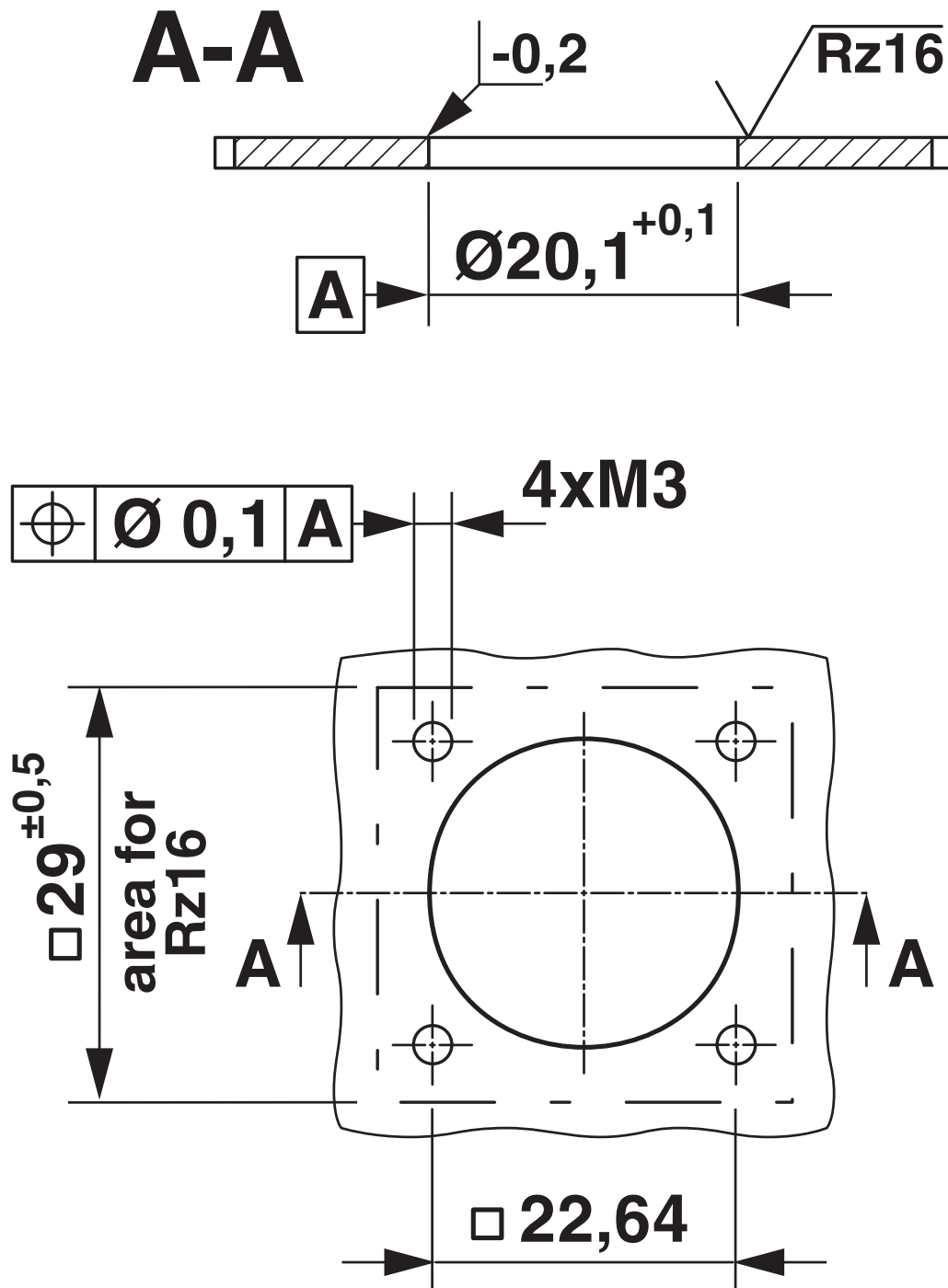

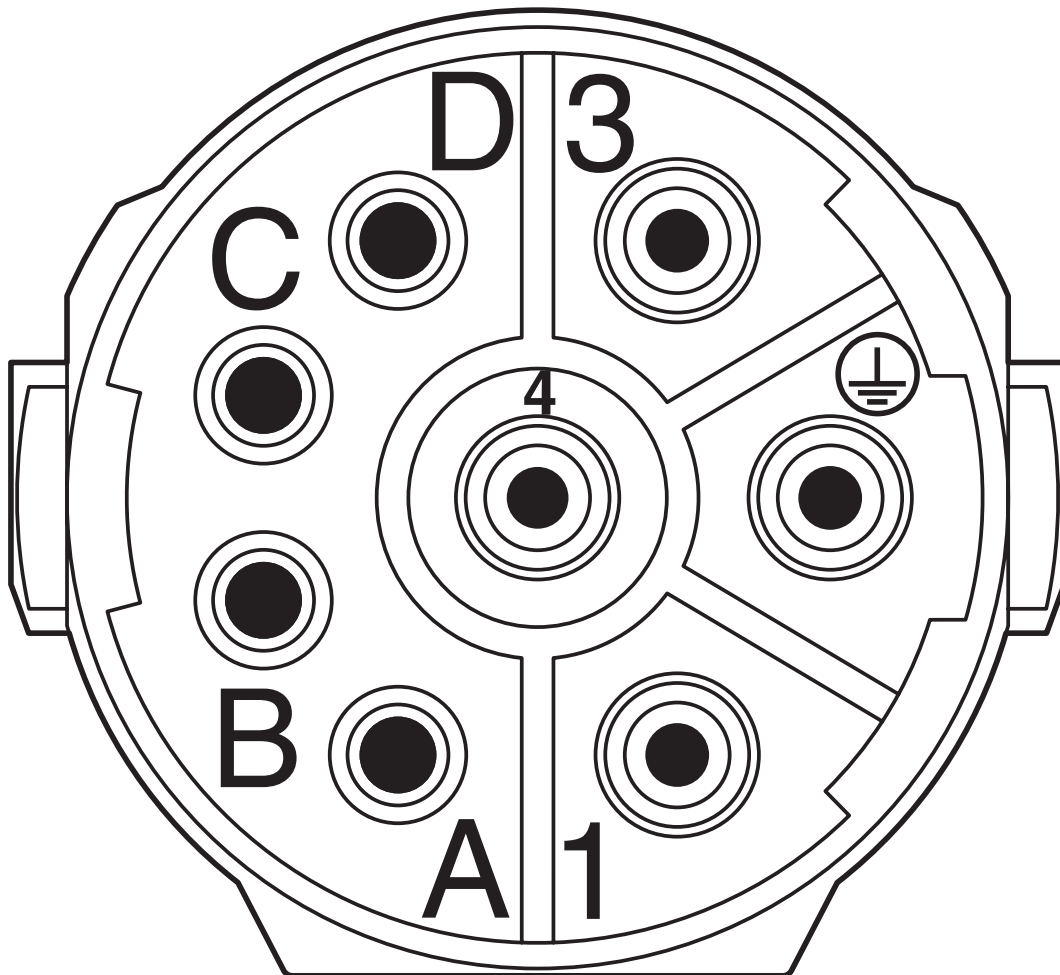
Installation dimensions

Schematic diagram



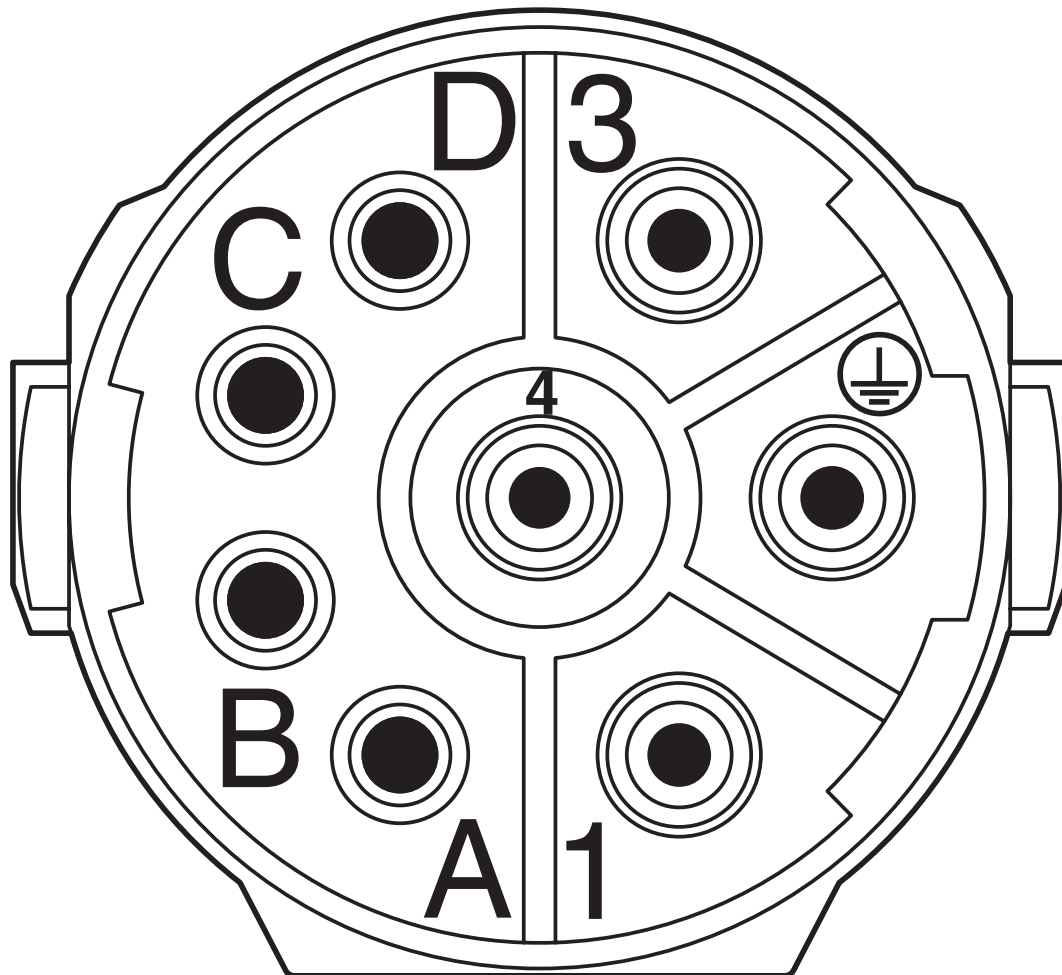
Connector pin assignment

Schematic diagram



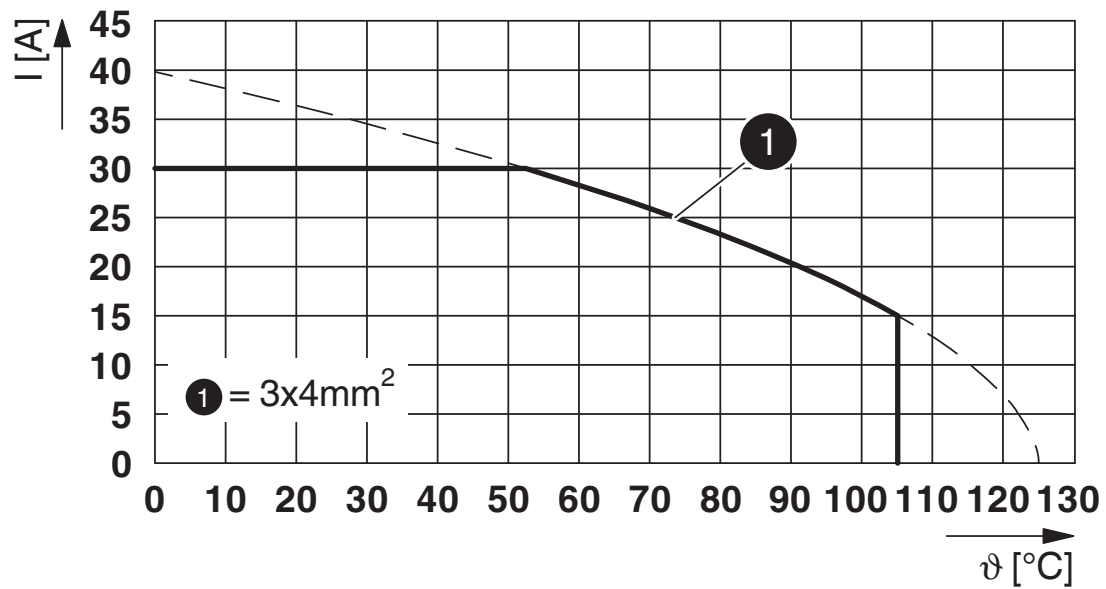
Connector pin assignment
