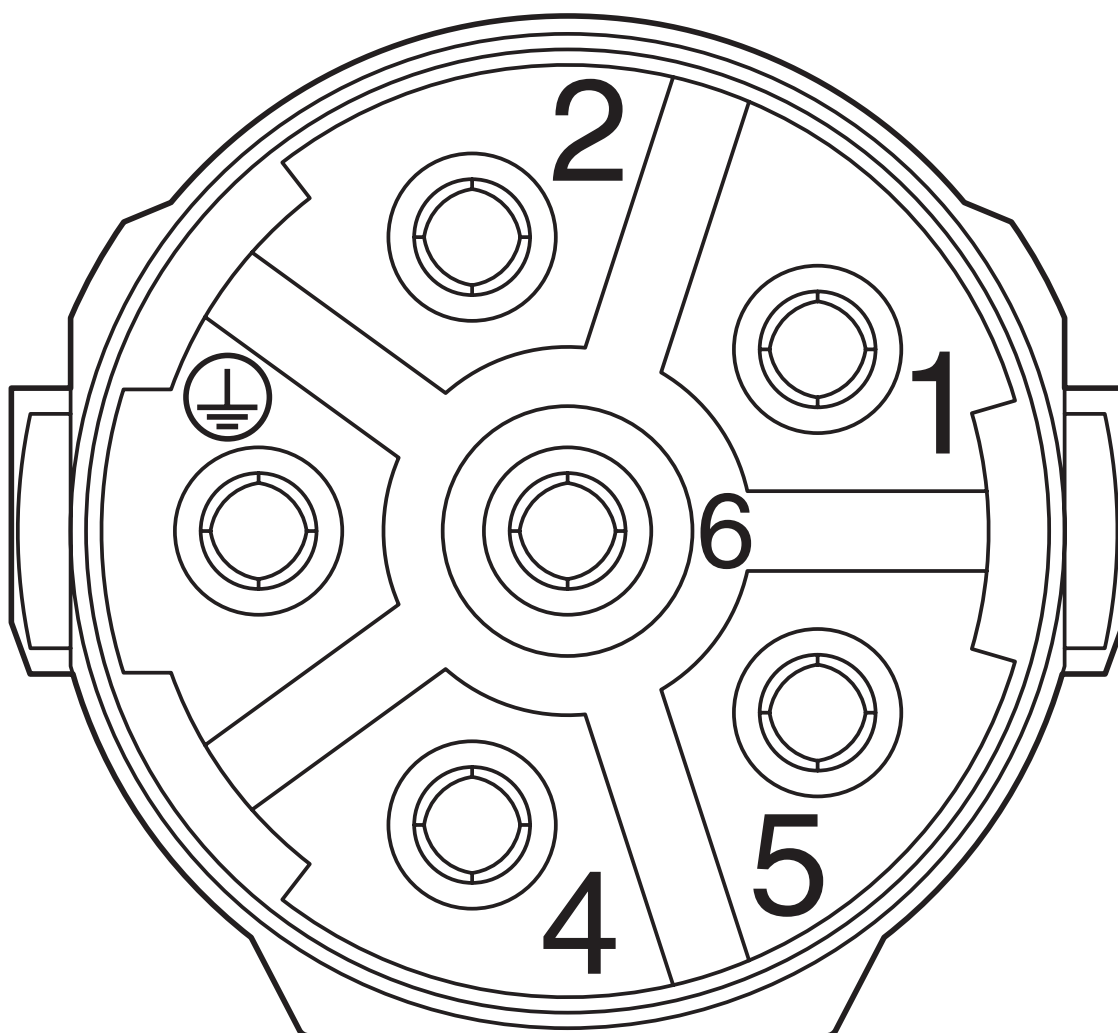

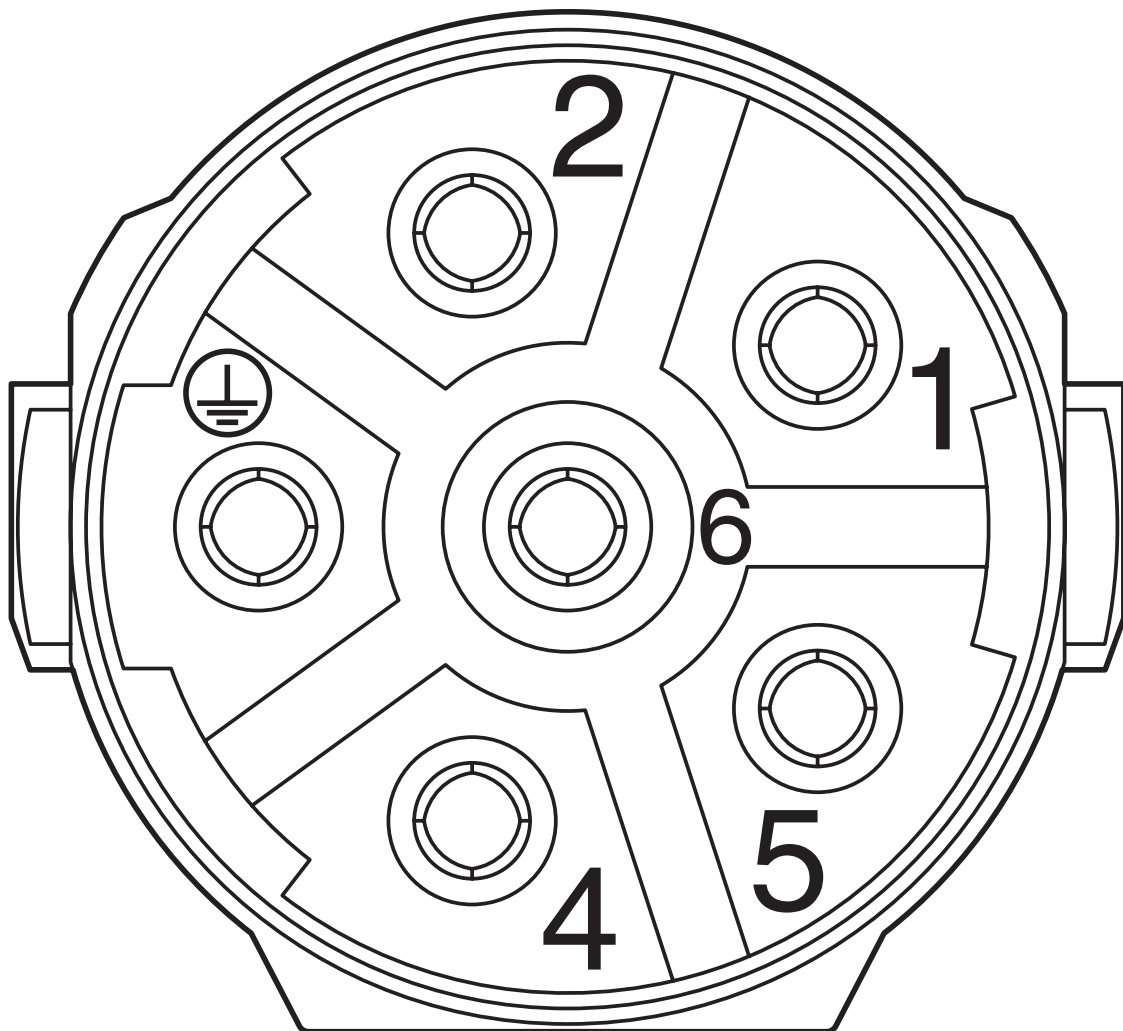


Connector pin assignment

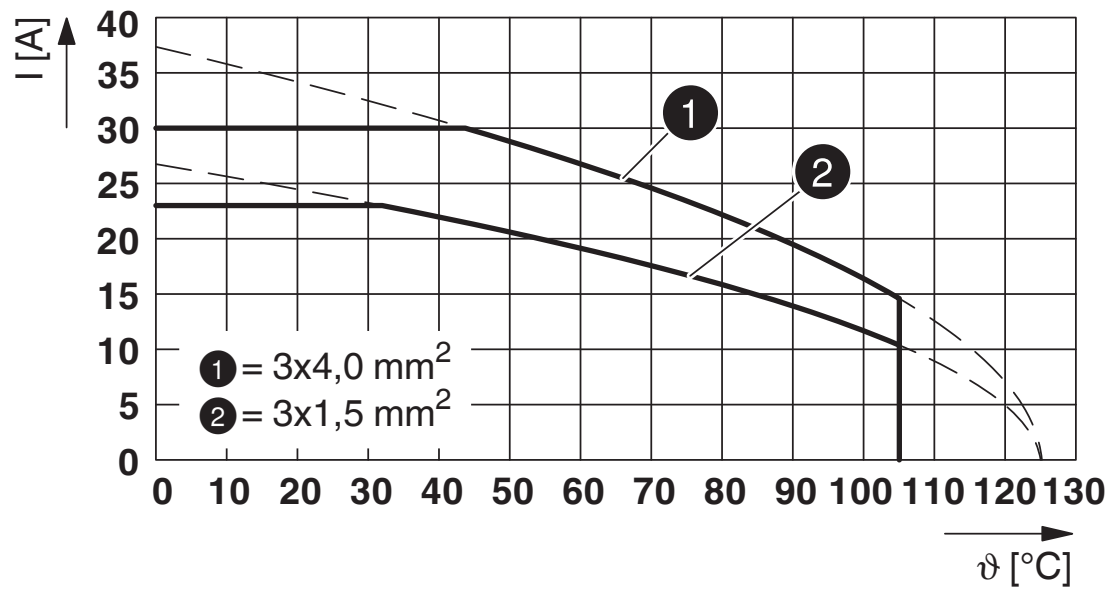
