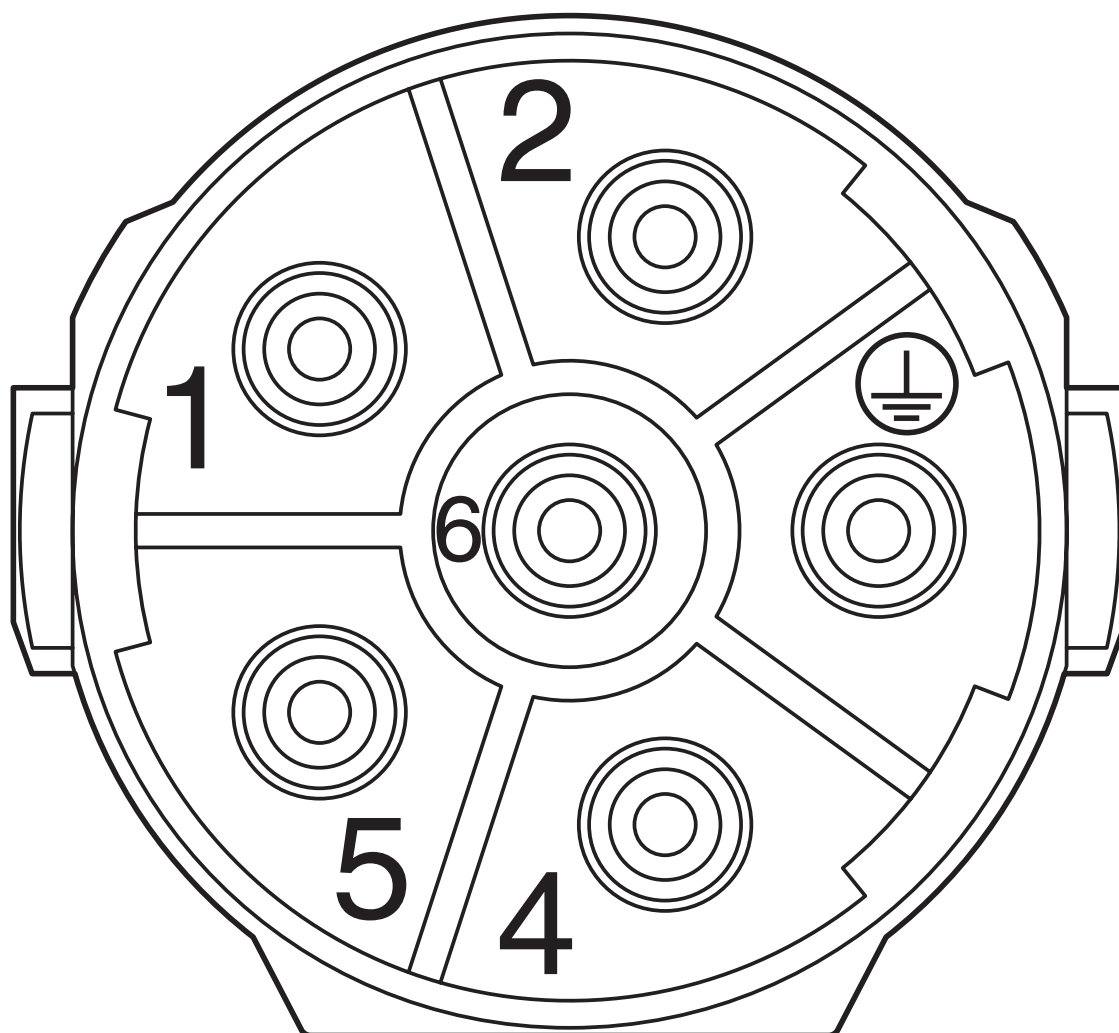

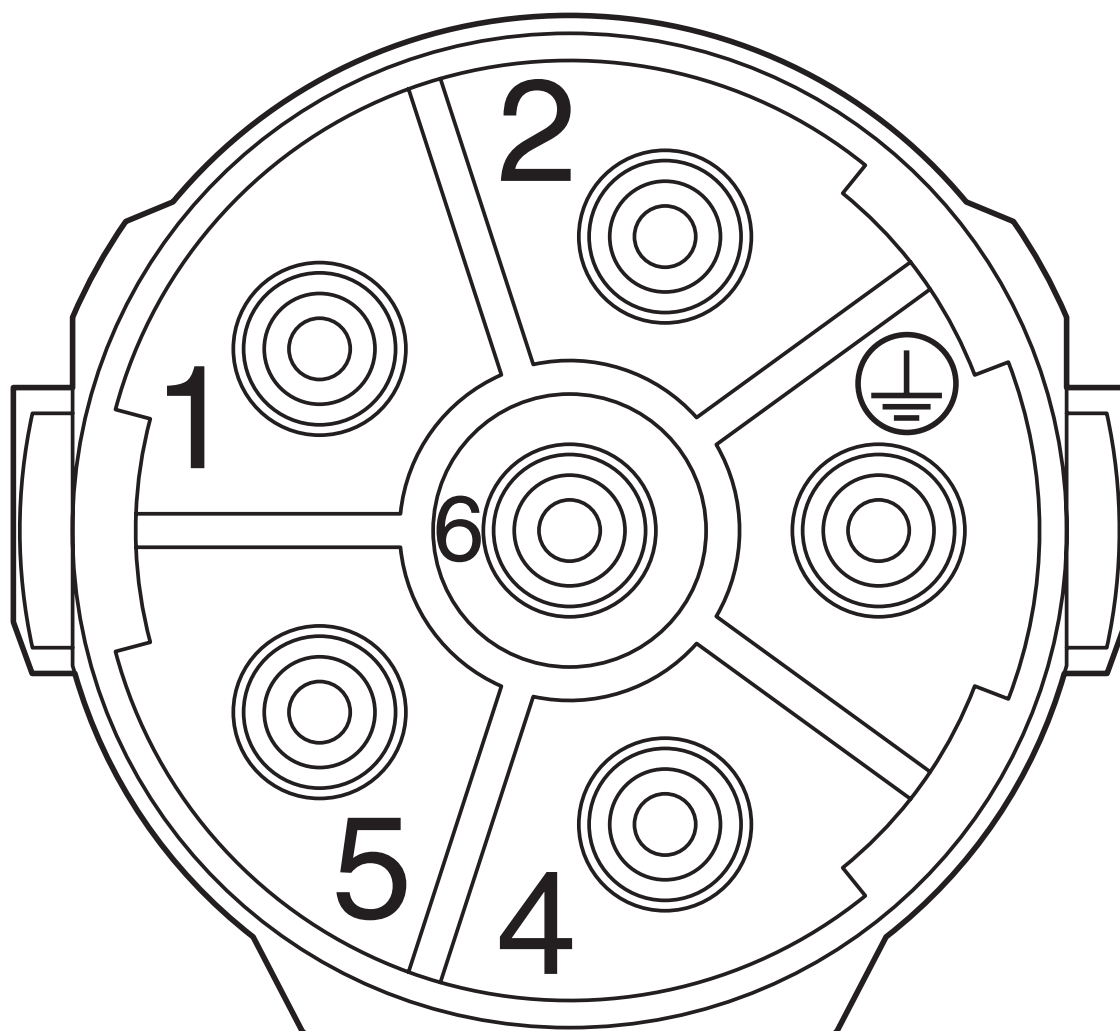

Schematic diagram



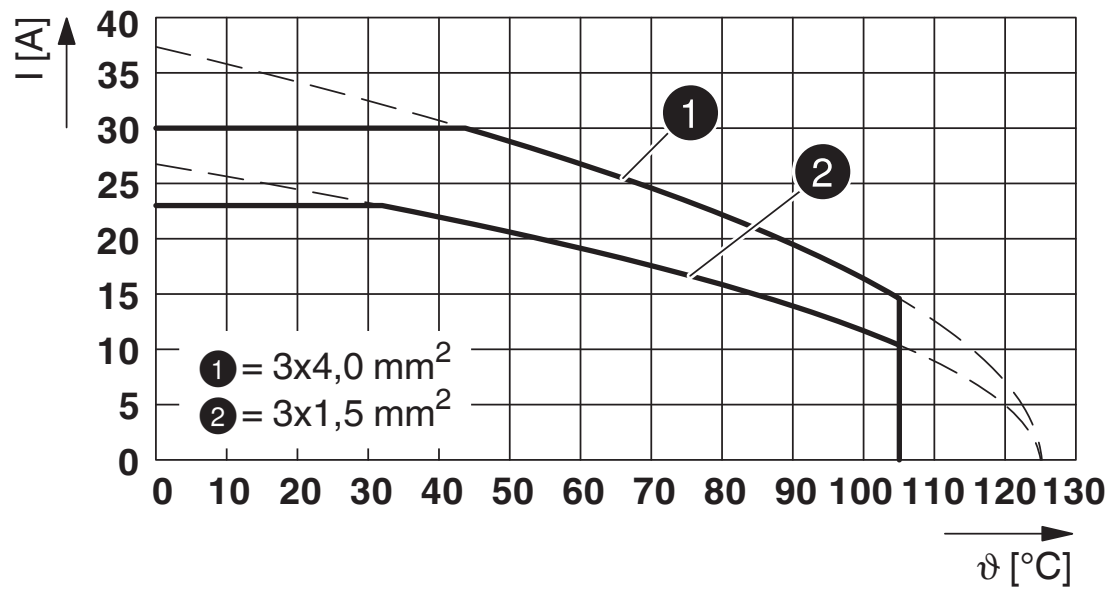
