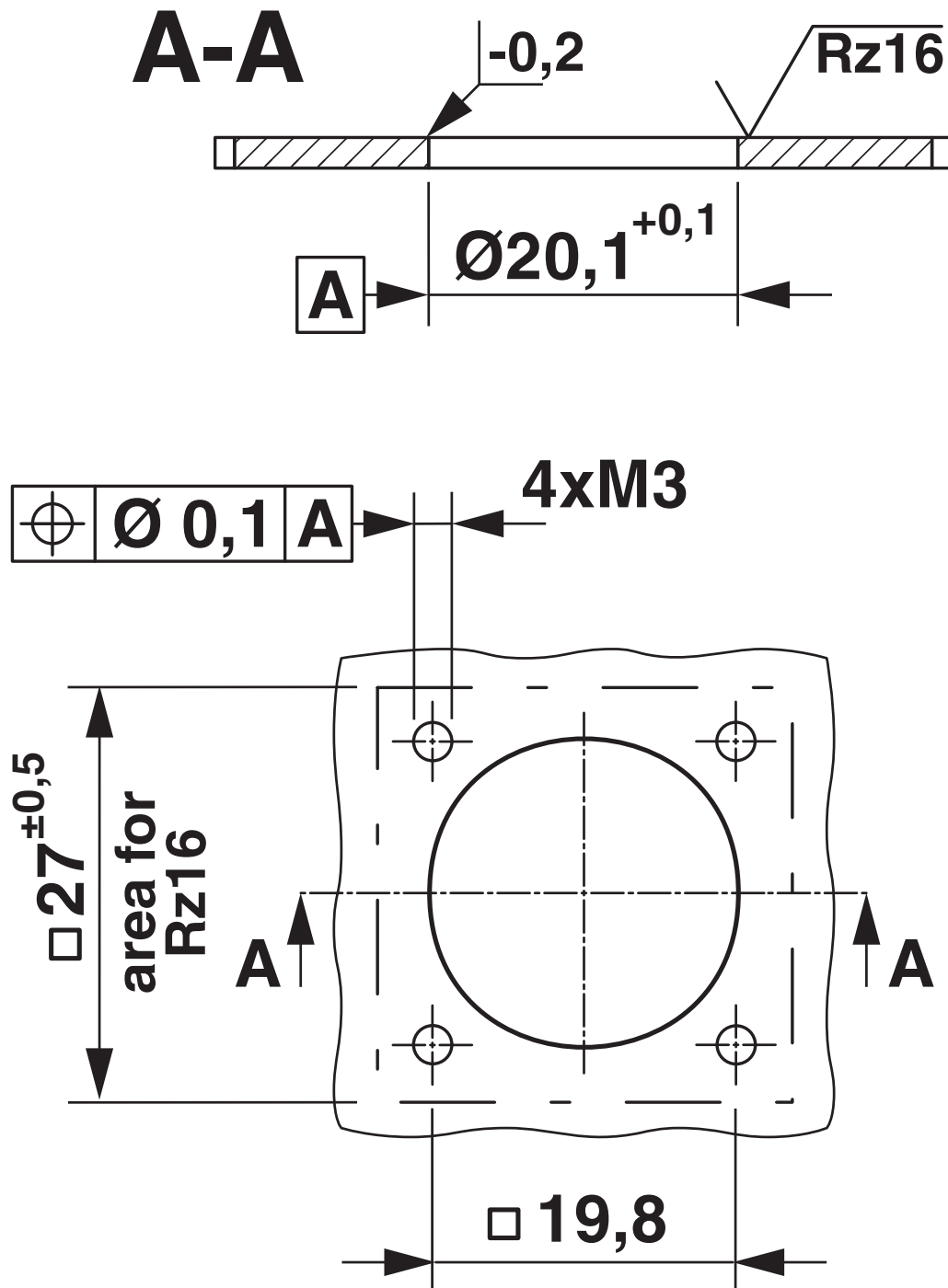

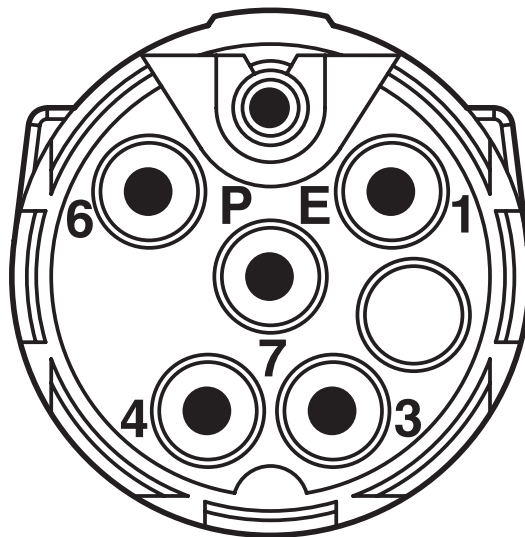

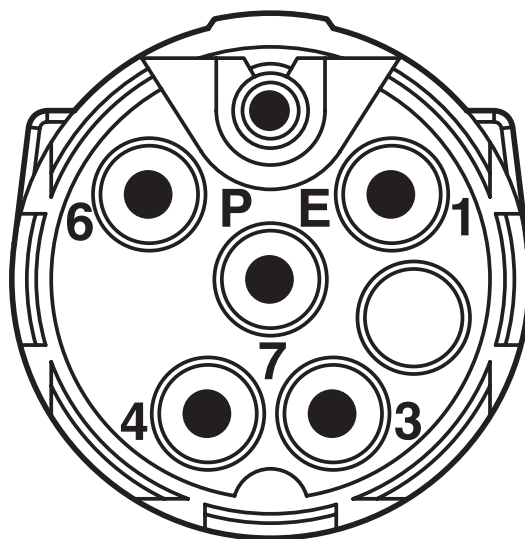

Schematic diagram

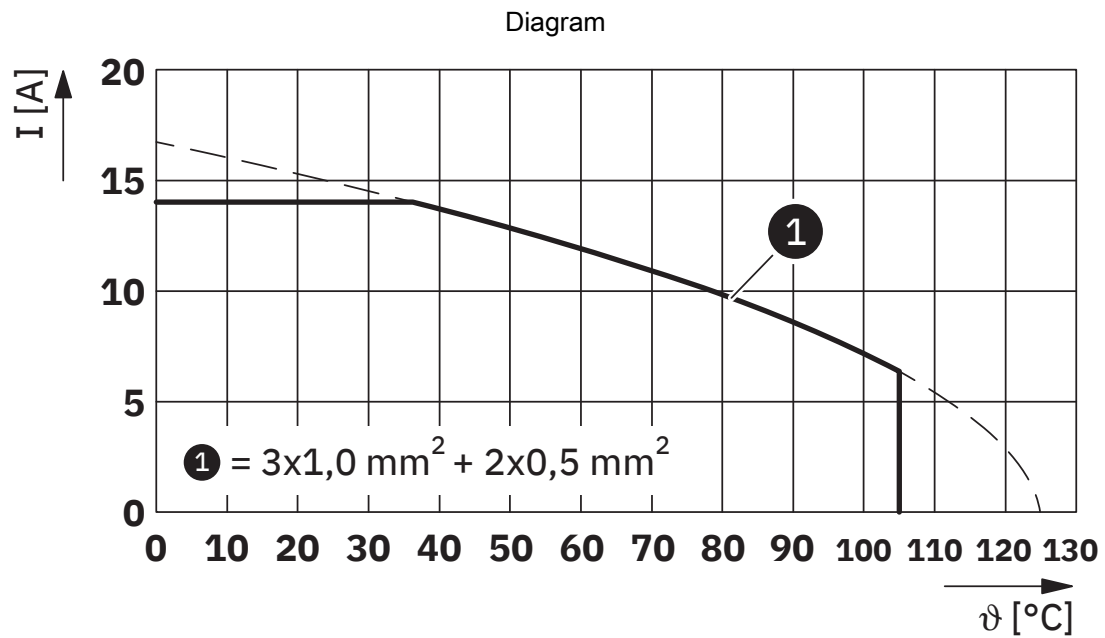
