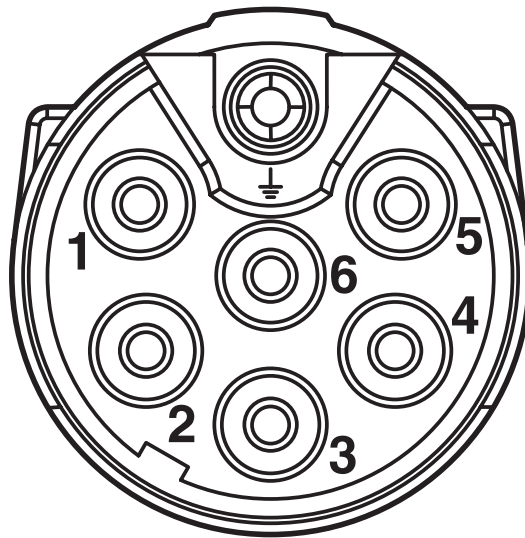

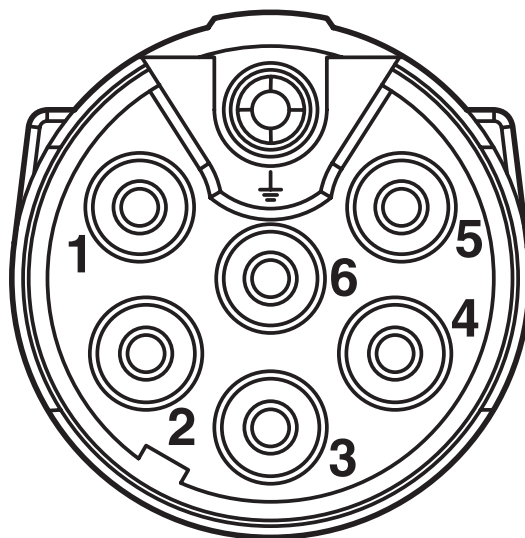

Schematic diagram

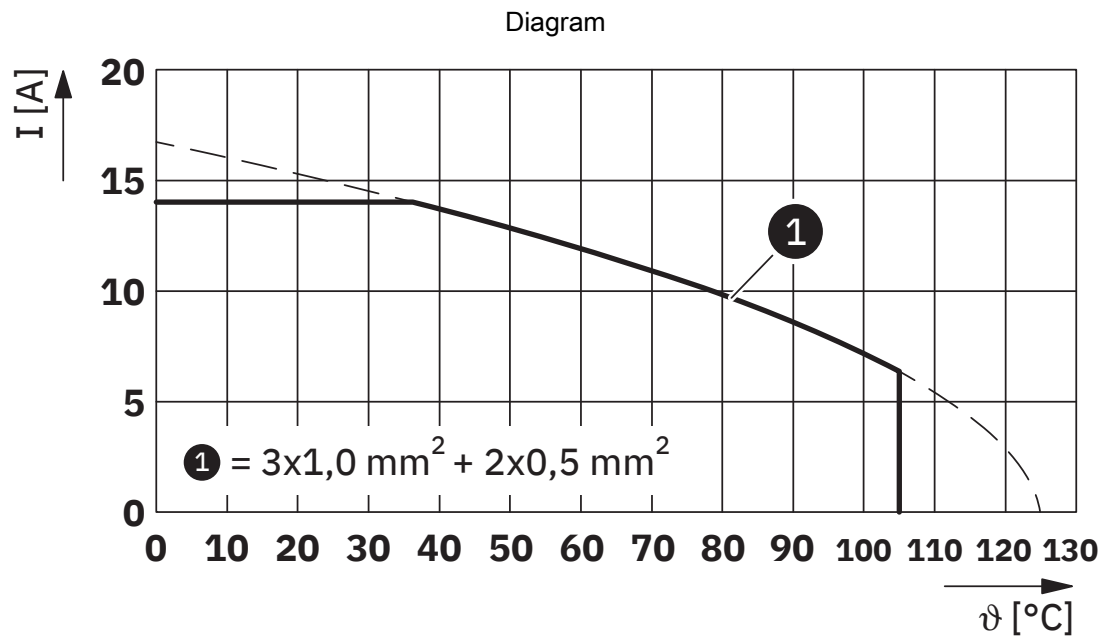
