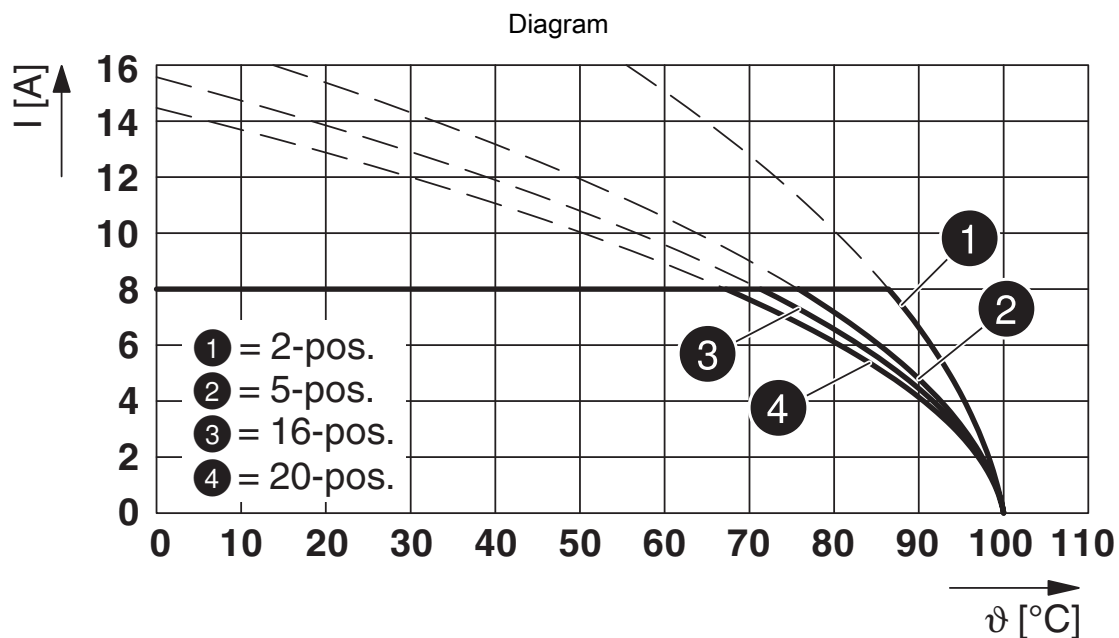

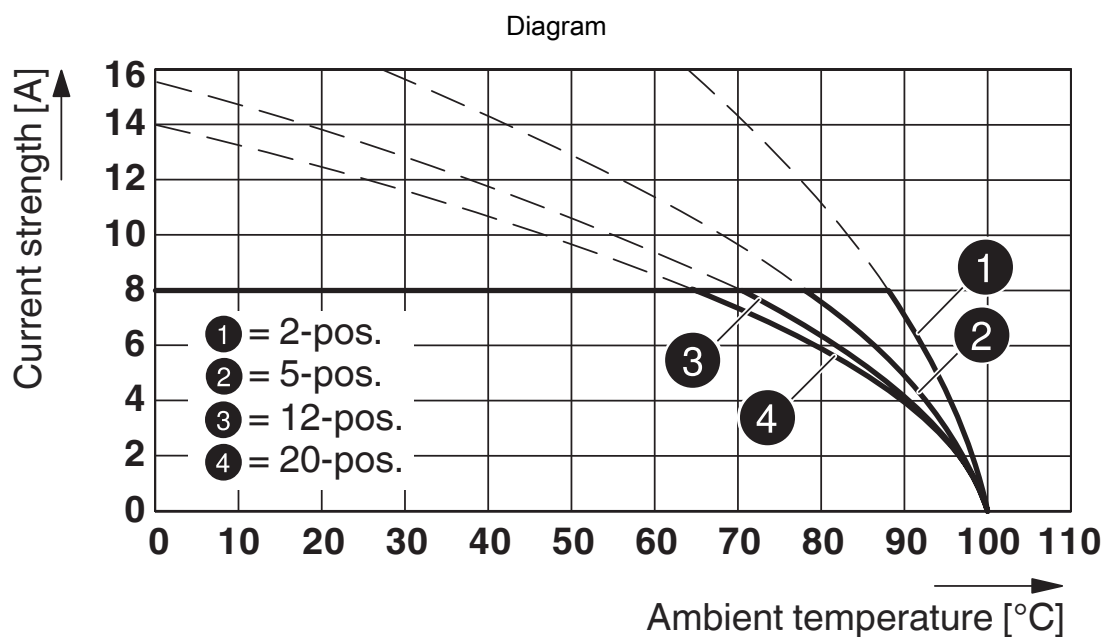

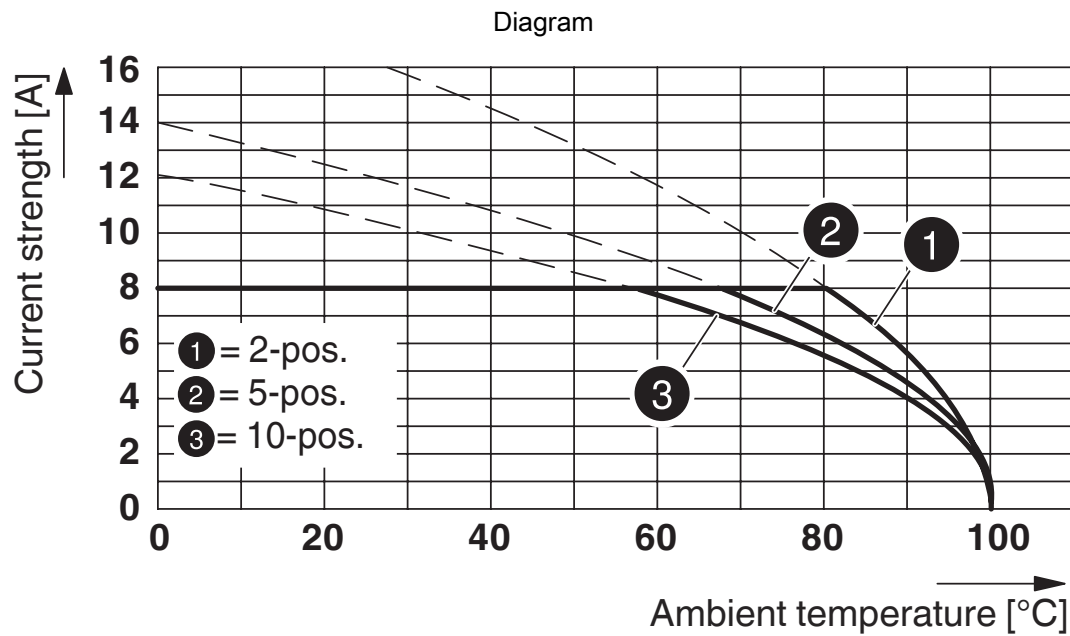

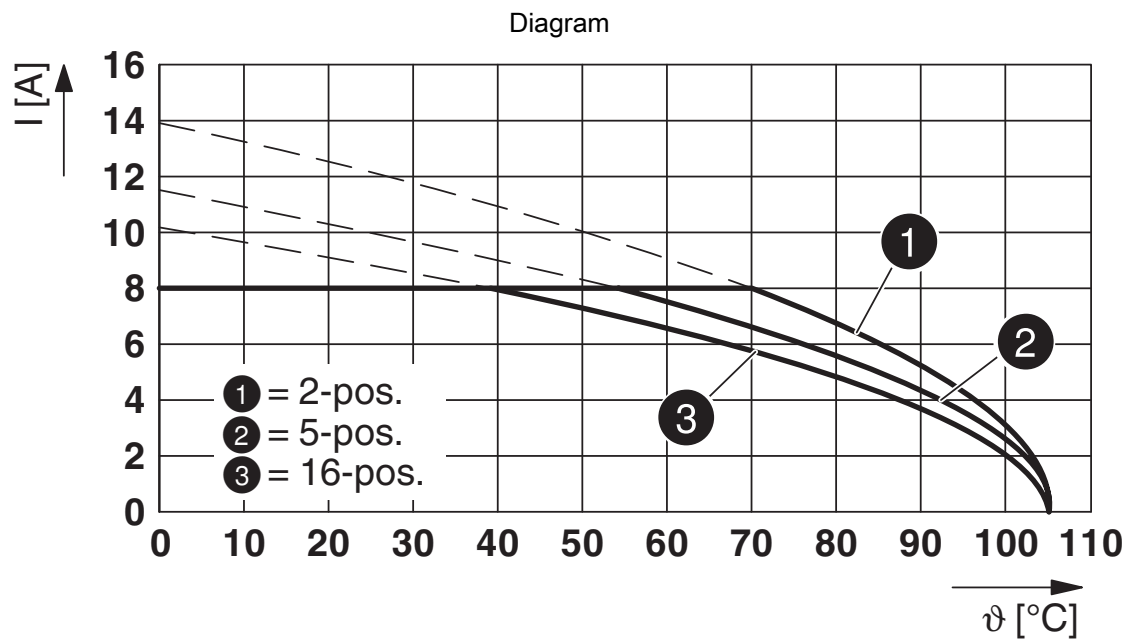
Type: FMC 1,5/...-STF-3,5 with MC 1,5/...-GF-3,5



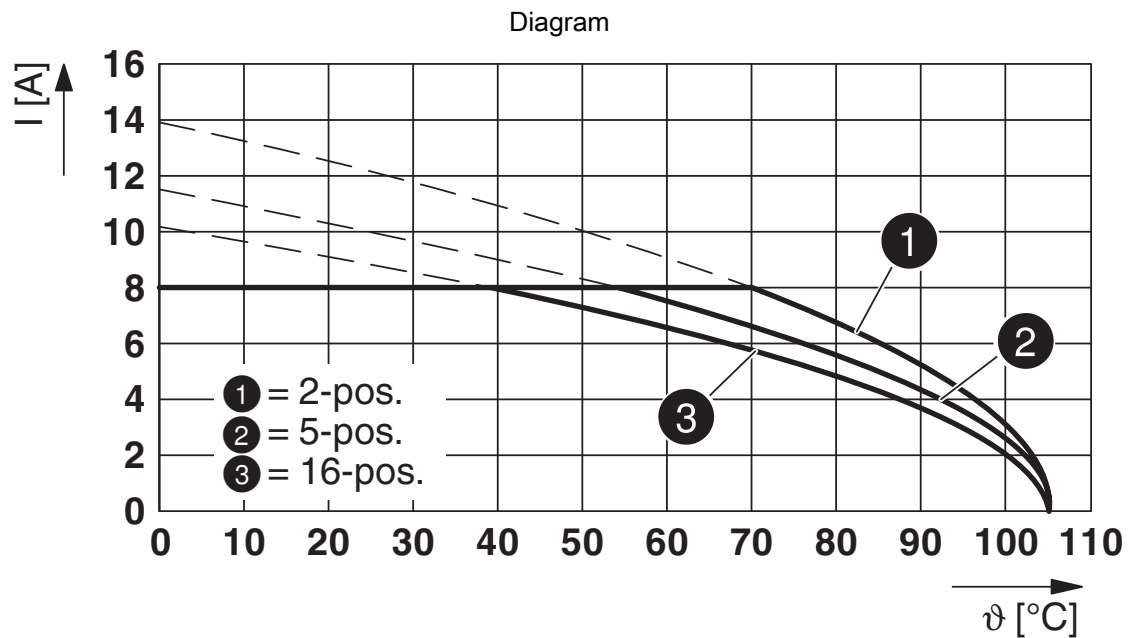
Type: FK-MCP 1,5/...-STF-3,5 with MC 1,5/...-GF-3,5

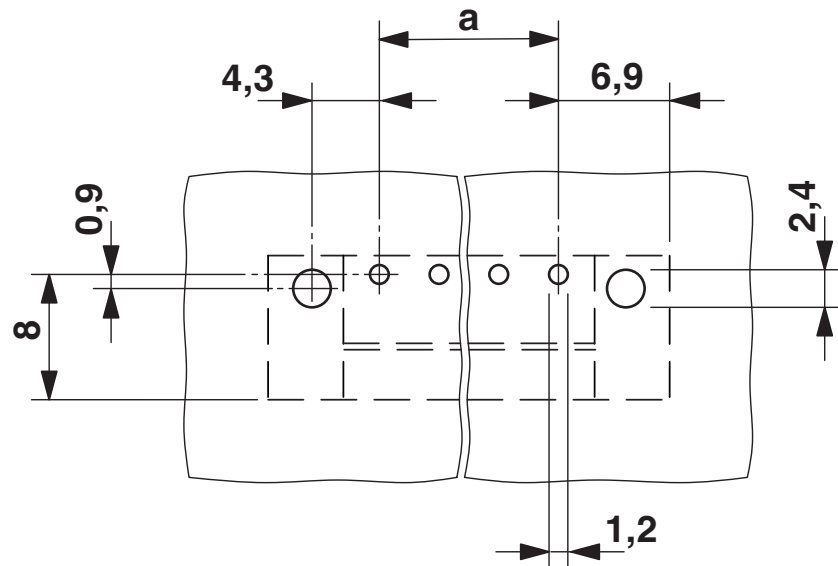


Type: MCVR 1,5/...-STF-3,5 with MC 1,5/...-GF-3,5
